HUD Releases New HMIS Data Standards!

In early May, HUD released its newest data standards. All HMIS vendors/systems must make all changes by September for testing and the new data standards will go into effect on October 1, 2023. HMIS vendors should be communicating with their users about the changes and training ahead of the go live date. The NYC HMIS team will be posting a summary of changes on our website soon and will provide details on how this impacts the new data warehouse rollout.

New Federal Initiative on Unsheltered Homelessness

The Biden-Harris administration has announced the launch of ALL INside, a first-of-its-kind initiative to address unsheltered homelessness across the country. ALL INside is a key part of "All In: The Federal Strategic Plan to Prevent and End Homelessness," a bold goal to reduce homelessness by 25% by 2025 and ultimately build a country where every person has a safe and affordable home.

This initiative brings the U.S. Interagency Council on Homelessness (USICH) and its 19 federal member agencies together to partner with state and local governments to strengthen and accelerate local efforts to get unsheltered people into homes in six places: Chicago, Dallas, Los Angeles, Phoenix Metro, Seattle, and the State of California.

Social Security Administration Expands Outreach and Access for Supplemental Security Income

Acting Commissioner of Social Security Kilolo Kijakazi announced a campaign to expand its outreach to people in critical need of financial help who may be eligible for Supplemental Security Income (SSI), which supports President Biden's Executive Order 13985, Advancing Racial Equity and Support for Underserved Communities Through the Federal Government.

Using data, Social Security was able to identify and reach underserved communities in rural and urban areas across the country where there was the sharpest decline in SSI applications since the pandemic and where the majority of people living in those zip codes are people of color and/or people living at or below the 150 percent Federal poverty threshold.

Homecoming: Life After Incarceration

Developed from HUD TA to provide support to community-based organizations working with individuals released from incarceration, including Housing Opportunities for Persons With AIDS (HOPWA) grantees and project sponsors.

The Homecoming highlights the challenges and struggles people experience as they try to re-enter society, showcasing examples of organizations and people who are leading the way in supporting the reentry population as well as listens to the often-marginalized voices of the population themselves. A secondary focus is on the connection between HIV and incarceration and highlights the challenges and opportunities that exist in addressing the housing and health needs of people with HIV exiting jails and prisons.

Each documentary style video episode is 20 - 40 minutes in length and uses the unique capabilities of film to humanize this topic. Explore the toolkit which includes a book with chapters that dive deeply into key topics, as well as related resources.
