NYC CoC Spotlight

HUD Awards NYC \$60 Million

On April 17th, the U.S. Department of Housing and Urban Development (HUD) announced an additional \$172.2 million in awards to address unsheltered and rural homelessness, bringing the total value of awards to \$486 million.

New York City has been awarded \$60 million to support the creation of 12 new projects across nine organizations/agencies, all of which will serve persons experiencing unsheltered homelessness. Additionally, New York City Housing Authority and New York City Department of Housing Preservation and Development were awarded a total of 612 Stability Vouchers to provide rental assistance to people experiencing or at-risk of homelessness, including survivors of domestic violence, dating violence, stalking, or human trafficking.

Direct Cash Transfer (DCT) Pilot

Starting in 2023, YouthNPower: Transforming Care will begin giving monthly cash assistance to 100 young people across New York City who have recently aged out of foster care. **100 participants will receive \$1000/month, no-strings-attached, for 12 months.** The online application is open!

To be eligible for the Direct Cash Transfer pilot, applicants must fit within a few criteria.

- Applicants must be between the ages of 18-22 Applicants must have been in foster care in New York City at age 18 or older
- Applicants must be out of foster care in New York City *or* Continuation of Care and Support (CCS21+) for at least 6 months at the time of their application
- Applicants must have "aged out" of foster care, meaning the last time they left foster care was not due to reunification, adoption, or guardianship
- Applicants must be currently living in New York City

This funding opportunity will help strengthen coordination among public housing authorities (PHAs), public child welfare agencies (PCWAs), and Continuums of Care (CoCs) and increase access to supportive services for those who need them.
