

SURVEY SUMMARY REPORT GUIDE

What is the Coordinated Assessment Survey?

The Coordinated Assessment Survey tells households what city, state, and/or federal housing programs/subsidies they are potentially eligible for.

The survey summary report shows:

- The number of households submitting surveys in the timeframe
- Characteristics of the households submitting surveys in the timeframe
- Which city, state, and/or federal housing/subsidy programs that households submitting surveys are potentially eligible for
- Prior supportive housing application activity tied to households who submitted surveys in the timeframe
- Supportive housing application activity in the timeframe

Report Columns:

Columns C through F show counts by **household type**. Households submitting surveys can be:

- Single Adults
- Adult Families
- Families with Children

For overall counts (i.e., all households), see column F.

Columns G through J show counts by household type **for households where the head of the household is 25 or under**. For overall youth counts, see column J.

Report Rows:

SITES AND SURVEYS shows the number of sites that started a survey in the timeframe, and the total number of surveys started.

COMPLETED SURVEYS shows the number of submitted surveys in the timeframe, and, of those, how many were completed within a day or within 30 minutes of starting the survey.

COMPLETED SURVEYS BY REFERRING AGENCY breaks out submitted survey counts by the type of agency that submitted the survey.

Housing Choice Voucher (Section 8)	Provides assistance to eligible low- and moderate-income families to rent housing in the private market*
NYCHA Public Housing	Public affordable housing*
Support Services for Veteran Families (SSVF) Rental Assistance	VA-funded program that assists low-income veteran families who are homeless or at risk of homelessness
VASH (Veteran Affairs Supportive Housing)	VA-funded rental assistance and supportive services to help veterans sustain permanent housing
VASH Continuum	VA-funded rental assistance and supportive services to help veterans sustain permanent housing; broader eligibility than VASH
HUD CoC Stability Vouchers (SV)	Available through the 2021 Consolidated Appropriations Act; through SVs, HUD is providing rental assistance administered by local Public Housing Agencies (PHA) including the Department of Housing Preservation and Development (HPD) and The New York City Housing Authority (NYCHA) for low to moderate income households who are homeless, at risk of homelessness, experiencing or fleeing domestic violence, and veterans to rent housing on the private market
HUD CoC Rapid Re-housing (RRH) – Category-I	Short-term rental assistance and supportive services for individuals/families who are homeless
HUD CoC Rapid Re-housing (RRH) – Category-II	Short-term rental assistance and supportive services for individuals/families who are at risk of homelessness
HUD CoC Rapid Re-housing (RRH) – Category-IV	Short-term rental assistance and supportive services for individuals/families who are fleeing/attempting to flee DV/GBV

SURVEYS POTENTIALLY ELIGIBLE FOR CITY AND STATE HOUSING/SUBSIDY PROGRAMS shows the number/share of submitted surveys potentially eligible for city and state housing/subsidy programs, and which city/state housing/subsidy programs they are potentially eligible for.

City/State Program:	Program Description:
CityFHEPS	Rental assistance program to help individuals and families currently in DHS or HRA shelter or those experiencing street homelessness to find and keep housing. It is administered by the Department of Social Services (DSS), which includes the Department of Homeless Services (DHS) and the Human Resources Administration (HRA)
Enhanced One Shot Deal (EOSD)	DHS clients who are in shelter, are employed, have an active or single issue Public Assistance case and meet certain income qualifications. Rent must not exceed 50% of gross income of the household. Clients may be eligible for up to 4 months' rent, broker's fee, furniture allowance, security voucher, storage fees and moving expenses. This assistance can be used for room rentals and in conjunction with Project Reconnect
FHEPS A	NY State rental subsidy program for families with children who receive Cash Assistance (CA) and who have been evicted or are facing eviction, or who lost their housing due to domestic violence. FHEPS provides a rental subsidy for up to 5 years until the youngest child turns 18 years old or 19 years old and is a full-time student regularly attending a secondary school or the equivalent level of vocational or technical training
FHEPS B	NY State rental subsidy program for families with children who receive Cash Assistance (CA) and who have been evicted or are facing eviction, or who lost their housing or at risk of losing their housing due to domestic violence (DV) or another form of gender-based violence (GBV). FHEPS provides a rental subsidy for up to 5 years until the youngest child turns 18 years old or 19 years old and is a full-time student regularly attending a secondary school or the equivalent level of vocational or technical training
HPD Housing Connect	NYC Department of Housing Preservation and Development (HPD) has different options for affordable housing based on income qualification. There is an application process and qualified candidates are selected by periodic lotteries and notified of next steps
Independent Living	For all household types that have sufficient income to afford rent in NYC. Support to the client/household is focused on finding a safe and affordable unit and identifying all the resources/services available to assist in long term placement in the community
NYC Family Justice Centers (FJCs), NYC Hope, NYC 24-Hour Domestic Violence Hotline	Walk-in facilities located in each borough operated by the NYC Mayor's Office to End Domestic and Gender-Based Violence. Professionals from multiple social and legal service agencies

	are located onsite and provide support for domestic/gender-based violence victims and survivors, including immediate safety planning, housing advocacy, counseling, help with Family Court, criminal justice advocacy, and other vital services
Pathway Home	City program that helps families and individuals move out of shelter and live with host families consisting of friends and family ("hosts"). The program can help you move back to the community as quickly as possible by offering monthly rental assistance payments to stabilize you in housing while you search for your own home, living with a host family for up to 12 months
Project Reconnect	Helps connect individuals/families who are applying for shelter or are in the shelter system to housing options outside of New York City
Reunification	Reunification is program assistance to individuals and families in shelter to identify family or friends ("hosts") that are willing to share their apartment or home for an extended period of time or permanently
Special One-Time Assistance (SOTA)	Provides one year's full rent up front for eligible DHS clients to move within New York City, to other New York state counties, or to another state, Puerto Rico, or Washington, D.C.

General Population (Formerly DHS SRO)	City-funded supportive housing
SMI/High Service Needs	City- & state-funded supportive housing for mental health
NY/NY I and II	City- & state-funded supportive housing for mental health
NY/NY III	City- & state-funded supportive housing
NYC 15/15	City-funded supportive housing
ESSHI	State-funded supportive housing for mental health and substance use disorder (SUD)
ESSHI Senior	State-funded supportive housing for seniors
HASA	City-funded supportive housing for individuals living with HIV/AIDS

PRIOR SUPPORTIVE HOUSING APPLICATION WITHIN 5 YEARS OF SURVEY START DATE shows, of households with submitted surveys in the timeframe, how many have supportive housing applications submitted within the last 5 years of the survey date. Of those, what number/share of prior supportive housing applications were approved?

NEW SUPPORTIVE HOUSING APPLICATIONS shows the number/share of supportive housing applications submitted in the timeframe. Of those, what number/share of those supportive housing applications were approved?

SVA (STANDARDIZED VULNERABILITY) shows, of households that submitted supportive housing applications in the timeframe, the number/share that are high, medium, and low SVA. See the [CoC website](#) for a detailed description of SVA.

HUD CHRONIC shows, of households that submitted supportive housing applications in the timeframe, the number/share that are HUD chronic. HUD chronicity is a homelessness requirement for certain supportive housing programs. See [HUD Exchange](#) for the definition of HUD chronicity.

SVA DISTRIBUTION BY SITE TYPE shows, of households that submitted supportive housing applications in the timeframe, the number/share that are high, medium, and low SVA **by site type**.
