## **Public Hearing Overview**

In accordance with Section 5A of the United States Housing Act of 1937, as amended, housing authorities are required to develop, with review and input from residents and the general public, Annual Plans for the coming year and then gather input on the Plans from residents and the general public.

Federal law allows a public housing authority to modify or amend its Annual Plan. Significant amendments to the Plan must also be brought to a public forum to provides residents and the general public the opportunity to comment.

## **Annual Plan and Significant Amendment**

On June 14, 2024, NYCHA released the **Draft Fiscal Year 2025 Annual Plan** and the **Draft Significant Amendment to the Fiscal Year 2024 Annual PHA Plan** for public review on NYCHA's website.

This Amendment is for the Fiscal Year 2024 Capital Plan and 5-Year Action Plan as well as the following activities:

- •Housing Opportunity Through Modernization Act (HOTMA) sections 102 and 104
- •New York City Public Housing Preservation Trust
- •MTA Easement at Wagner Houses
- •Permanent Affordability Commitment Together (PACT)

## **Annual Plan and Significant Amendment**

As part of the Annual Plan and Significant Amendment process, NYCHA held 12 meetings to date with members of the Resident Advisory Board (RAB) and Citywide Council of Presidents (CCOP):

- 5. June 4 & 6 5-Year Goals for 2025 2029
- 6. June 11 & 13 Housing Preservation Trust

## **Progress on HUD Agreement Pillar Areas**

The 2019 HUD Agreement focuses on a set of pillars, each with a specific set of metrics and requirements.

#### Monitorship Updates

 The Monitorship's first term, led by Bart Schwartz and Guidepost Solutions, ran until February 2024

 The new Federal Monitors are Neil Barofsky and Matt Cipolla of Jenner & Block

 The second phase will run for five years, until 2029

#### **Key Examples of Progress to Date**

#### **E** Trests & Waste

- Reduced verified pest complaints by 10% from 2022 to 2023.
- Responding to rat complaints within 2 days 85% of the time—up from 48% this time last year.

#### Heat

- 15% reduction in # of unplanned heat outages in 2023/2024 relative to 2022/2023; duration of unplanned outage time reduced by 8% to 7.2 hours.
- Completed 120+ boiler replacements—200+ remain planned by end of 2026.

#### Elevators

- 11% reduction in unplanned outages in 2023 relative to 2022; duration time reduced by 32% to 7.5 hours.
- Completed 100+ elevator replacements—200 remain planned by end of 2025.

#### Lead

- Tested 72,000+ apartments with children under age 6 to determine presence of lead-based paint.
- Removed lead from over 7,600 apartments at 0.5 mg/cm<sup>2</sup> standard since 2022.
- Abating all PACT sites to the 0.5 mg/cm<sup>2</sup> standard.


#### 💥 Mold

- Improved compliance with the printing of the inspection plan from 58.6% to 70% from 2022 to 2023.
- Completed the ventilation program, replacing 8,400 roof fans; cleaned ~74,000 vents.



- Trust board appointed in July 2023
- First Trust employees started in August 2023

- First design-build Request for Qualifications released in May 2024

- Design-build start: Q2 2024

- 15 buildings, 4, 6, 9, 13, 14 stories
- 1,139 units

- NYCHA has hosted 71 sessions and trained 1,334 staff and 589 residents over 17 months


#### NYCHA Resident Training Academy

#### **Resident Safety**

- Teen Expansion Program offers youth programs at 130 sites citywide, open seven days a week
- Mayor's Action Plan for Neighborhood Safety enlists residents, agencies, and Community Based Organizations to help move beyond enforcement to address the factors underlying safety at 30 NYCHA developments






