**Notice of Availability of the Programmatic Environmental Assessment for New York City
Housing Authority Public Housing Resiliency
New York City, New York County, New York**

Notification is hereby given to the public of the intent of the Department of Homeland Security-Federal Emergency Management Agency (DHS-FEMA) to provide federal funding to the New York City Housing Authority (NYCHA), as sub-grantee, for the Public Housing Resiliency. The proposed project would be funded through the Public Assistance Program and Hazard Mitigation Program.

NYCHA proposed to mitigate utilities at developments and community centers against future flood and storm damage. Work proposed includes construction of new elevated boiler plant buildings to house boiler systems and associated fuel oil tanks at housing developments, equip residential buildings and community centers with new emergency power generators, and construction of new electrical annex structures and utility corridors.

Many project sites are within FEMA-designated flood zone, as shown on the FEMA Flood Insurance Rate Map. Pursuant to the National Environmental Policy Act (NEPA) and 44 CFR Part 9, DHS-FEMA evaluated practicable alternatives, including a No Action alternative, the proposed alternatives, and two alternatives that were dismissed (Relocation of residents and the demolition and reconstruction of new buildings).

In accordance with NEPA, a Programmatic Environmental Assessment (PEA) has been prepared to assess the potential impacts of the proposed project on the human environment. The PEA summarizes the project's purpose and need, project alternatives, the affected environment, and potential environmental consequences for considered alternatives. DHS-FEMA's requirement of addressing floodplain management in accordance with 44 CFR Part 9 is incorporated with the PEA.
