


Rate proposal and customer programs update



DEP is recommending a 4.42% rate increase for Fiscal Year 2024

- Proposing a 4.42% rate increase for customers in New York City
- Re-authorizing the Board's core customer programs at current funding levels
- No rental payment requests have been made for Fiscal Year 2024
- Extend the target date for administrative compliance with all requirements of the Multi-family Conservation Program until June 30, 2024



The moderate size of the proposed rate increase is underwritten in part by the effectiveness of DEP's alternative collection strategy, including receipts from the customer amnesty program

The proposed rate increase:

- Is less than the 4.6% general inflation rate seen in the greater New York City area in the 12-months to March 2023
- Is below the recent 4.9% electricity rate increase, and the 7.7% natural gas rate increase, seen in the energy utility sector
- Enable the system to achieve key financial metrics necessary to support strong bond ratings
- Help address the impacts of rising interest rates and inflation on the cost of providing utility service to customers
- Support hiring and retention initiatives to return headcount to budgeted levels

An expanded capital investment program and system O&M investments are among the costs of service that a rate increase for FY 2024 would fund

- The proposed rate increase would increase projected FY 2024 revenues to above \$4.2 billion, a revenue level that would be sufficient to fund the projected increase in FY 2024 system costs of service
- Additional debt service costs in FY 2024 include an estimated increase of more than \$200 million due to an expanded capital spending program and higher market interest rates
- Increased O&M costs of more than \$100 million include \$74 million for collective bargaining agreements covering the 2021 to 2027 contract years, \$9 million for additional water and wastewater chemical treatment costs, and \$5 million for billing software system development and support
- The Delaware Aqueduct shutdown, along with the related funding, was moved from FY23 to FY24, with the one-time costs attributable to the shutdown assumed to occur during FY 2024

Residential customers with average levels of water use will see a small increase to their monthly bills

DEP recommends that the Board continue its \$30 million customer program budget, which would extend the Board's 50% program budget increase

Residential use charges will remain lower than in other large cities



DEP recommends that the Board also increase water rates for wholesale customers in Fiscal Year 2024

- In addition to supplying water to the City's residents, DEP supplies water to the water utilities that serve another one million residents who live north of the City, mainly in Westchester County
- These local water utilities are allowed to purchase water from City sources pursuant to State law, from water supply assets
 located outside of the City and that pass through the area en route to the City, under a DEC-regulated rate framework
- Requesting the Board consider an allowance quantity rate increase of 6.76% for wholesale customers north of New York
 City
- A typical end consumer's water bill would increase by \$0.82 per month, or \$9.85 per year
- Recommended rate increase for amounts in excess of the allowance quantity of up to 4.42%, in line with the proposed in-City rate increase
