HOW MANY OF THE FADO COMPLAINTS REMAIN OPEN?

Seven (7) cases are still open pending further investigation.

HOW LONG HAVE THESE CASES BEEN OPEN?

The number of days open ranges from 3 days to 86 days. The average number of days open is 39.

HOW MANY OF THE AGENTS WITH OPEN FADO COMPLAINTS HAVE BEEN THE SUBJECT OF PRIOR COMPLAINTS?

There are two (2) agents with open FADO complaints that have been the subjects of prior complaints.
