WITH REGARD TO ABUSE OF AUTHORITY COMPLAINTS, HOW MANY INVOLVED DISPUTED ARRESTS OR THE CONFISCATION OF STUDENT PROPERTY?

There were **NO** abuse of authority cases during this period.

HOW MANY OF THE FADO COMPLAINTS REMAIN OPEN?

Twenty-seven (27) cases are still open pending further investigation.

HOW LONG HAVE THESE CASES BEEN OPEN?

The number of days open ranges from 3 day to 87 days. The average number of days open is 42.

HOW MANY OF THE AGENTS WITH OPEN FADO COMPLAINTS HAVE BEEN THE SUBJECT OF PRIOR COMPLAINTS?

There are seven (7) agents with open FADO complaints that have been the subjects of prior complaints.
