- 7. OATH is conducting this hearing in accordance with the
- 8. requirements of the City Administrative Procedure Act. The purpose
- 9. of this hearing is to receive comments from the public on OATH's
- 10. Proposed Rule Regarding Adjudication of Trade Waste Violations.
- 11. OATH proposes to amend its Rules of Practice for the Hearing
- 12. Division, found in Chapter 6 of Title 48 of the Rules of the City of New
- 13. York, to indicate that findings made by Hearing Officers in trade
- 14. waste proceedings filed by the Business Integrity Commission also
- 15. known as (BIC) are recommendations to BIC rather than final
- 16. decisions and orders. This rule change will ensure that proceedings
- 17. filed in the Hearings Division by BIC for violations of trade waste
- 18. laws and rules under Chapter 1 of Title 16-A of the New York City
- 19. Administrative Code, and rules promulgated pursuant to that
- 20. chapter, are adjudicated as required by Section 16-518(a) of the
- 21. Administrative Code.
- 22. OATH's proposed rule was published in The City Record on
- 23. January 17, 2023. OATH e-mailed the rule to the Speaker of

- 24. the City Council; every Member of the City Council; all community
- 25. board managers and the news media. OATH also posted the
- 26. proposed rule on OATH's website; the New York City Rules website
- 27. and the City Records online website.
- 28. OATH has been accepting written comments on the proposed rule
- 29. since the date it was published in The City Record and OATH will
- 30. continue to accept written comments through the close of business
- 31. today.
- 32. At this hearing, you may present an oral statement concerning
- 33. the proposed rule. We just ask that before you begin speaking:
- 34. Please state your name and affiliation whether you are with an
- 35. agency, the media, etc.
- 36. Please speak slowly and clearly, so that your statement can be
- 37. accurately recorded. Please limit your statement to no more than
- 38. three minutes.
- 39. Shortly after today's hearing, copies of all written comments
- 40. received by OATH, concerning the proposed rule, and a
- 41. summary of the statements given today, will be made
- 42. available to the public on OATH's website at:
