- 1. Joy Thompson: It is 11am. Okay, we are going to start this
- 2. public hearing regarding the authority of the Chief Administrative
- 3. Law Judge to transfer cases between divisions.
- 4. Good morning again. My name is Joy Thompson. I am the Assistant
- 5. General Counsel at the New York City Office of Administrative Trials
- 6. and Hearings, also known as OATH. Thank you for attending today's
- 7. hearing.
- 8. OATH is conducting this hearing in accordance with the
- 9. requirements of the City Administrative Procedure Act also
- 10. known as CAPA. The purpose of this hearing is to receive
- 11. comments from the public on OATH's proposed rule to inform
- 12. parties of the authority of the Chief Administrative Law Judge to
- 13. direct cases between OATH's Trials and Hearings Divisions.
- 14. OATH is proposing to amend the Rules of Practice for OATH's Trials
- 15. and Hearings Divisions, currently located in Chapters 1 and 6
- 16. of Title 48 of the Rules of the City of New York.
- 17. This proposed rule would amend Subdivision (e) of Section 1-26 of
- 18. Title 48 of the Rules of the City, of the City of New York to clarify that
- 19. provision and to correct grammatical errors. Pursuant to the
- 20. authority set forth in the Charter Sections 1049 and 1049-a, this rule
- 21. would also add a new paragraph (3) to Subdivision (a) of
- 22. Section 6-08 of the same title to clarify the Chief Administrative
- 23. Law Judge that he may, he or she may, in his or her discretion,

- 24. remove cases from the Hearings Division to the Trials Division.
- 25. These amendments would increase the transparency in the
- 26. management of proceedings.
- 27. The proposed rule was published in The City Record on
- 28. April 26, 2021. OATH also e-mailed the rule to the Speaker of the
- 29. City Council; every member of the City Council; all community board
- 30. managers; the news media; as well as civic organizations. In
- 31. addition, OATH posted the proposed rule on OATH's website, the
- 32. New York City Rules website, and the City Records online website.
- 33. OATH has been accepting written comments on the proposed rule
- 34. since the date it was published in The City Record and will continue
- 35. to accept written comments through the close of business today.
- 36. At this hearing, you may present an oral statement concerning the
- 37. proposed rule. Before you begin speaking: 1) Please state your
- 38. name and affiliation whether you are with an agency, the media, etc.
- 39. Please speak slowly and clearly, so that your statement may be
- 40. accurately recorded. Please limit your statement to no more than
- 41. three minutes.
- 42. Shortly after today's hearing, copies of all written comments
- 43. received by OATH, concerning this proposed rule, and a
- 44. summary of the statements given today, will be made
- 45. available to the public on OATH's website. I am actually going to
- 46. read this website out but I will also put it in the chat. It is:

- 48. That is a long website. We are virtually meeting so I will add that to
- 49. the chat.
- 50. Before issuing its Final Rule, OATH will carefully consider
- 51. the statements presented at today's hearing, as well as all written
- 52. comments received by the close of business today. Again, thank
- 53. you for attending this hearing. Now the floor is open for comments.
- 54. Again, before you begin speaking: 1) Please state your name and
- 55. affiliation. Speak slowly and clearly so that your statement can be
- 56. accurately recorded and please limit your statement to no more than
- 57. three minutes.
- 58. Okay, the floor is open. I see we have one guest. Will someone like
- 59. to make a comment. If so, please speak now.
- 60. So, give a few more minutes. At least one more minute. What I am
- 61. doing now is adding to the chat where any comments can be made.
- 62. Okay, I see we are being joined by our General Counsel. Again, any
- 63. discussion about this proposed rule about the Chief Administrative
- 64. Law Judge's authority to transfer cases among between the
- 65. divisions.
- 66. As there are no comments on OATH's proposed rule to inform
- 67. parties of the authority of the Chief Administrative Law Judge to
- 68. direct cases between OATH's Trials and Hearings Divisions, this
- 69. meeting is now adjourned. Thank you for attending and please
