March is Women's History Month

Each year during Women's History Month we celebrate the enormous contributions of women to the development of important technological advancements, political movements and social programs. Women have been at the helm of various social movements and causes as well, such as the creation of policy, programming, and the amplification of efforts to raise awareness of domestic violence.

We have women leaders to thank for the first domestic violence shelters and safe houses for survivors, the first national conferences that highlighted domestic violence as a pressing issue, the first organizations dedicated solely to supporting survivors, and the first lawsuits that led to sweeping policy changes that continue to have an impact on how domestic violence survivors receive services, and how these programs are funded.

According to the National Coalition Against Domestic Violence, 1 in 3 women and 1 in 4 men have been victims of [some form of] physical violence by an intimate partner within their lifetime. This prevalent societal issue remains a key area to drive leadership to, and support leadership of women.


