April is Sexual Assault Awareness Month

April is Sexual Assault Awareness month, and a very important part of this month is Denim Day. Denim Day is an annual event in which people are encouraged to wear blue jeans (denim) in order to raise awareness of rape and sexual assault. Denim Day NYC is a coalition of survivors, advocates, community organizations, city council members, and city agencies working together to raise awareness about sexual assault. Denim Day NYC hosts events throughout the year all around NYC to promote awareness about sexual assault and connect New Yorkers to resources. Since 2010, Denim Day NYC has hosted a rally and press conference in April to unite New Yorkers around the issue of sexual assault and show solidarity with survivors.

Why Denim?

In Rome in 1992, a 45-year-old driving instructor was charged with raping an 18-year-old female student during her first driving lesson. While the alleged rapist was convicted and sentenced, the Italian Supreme Court overturned the conviction in 1998 because the victim wore tight jeans. It was argued that she must have had to help her attacker remove her jeans, thus making the act consensual. The Italian Supreme Court stated in its decision "It is a fact of common experience that it is nearly impossible to slip off tight jeans even partly without the active collaboration of the person who is wearing them." As of 2008 the Italian Supreme Court has overturned their findings, and there is no longer a "denim" defense to the charge of rape.

What can you do?

On April 25th please encourage your staff and colleagues to wear denim, join the marches, attend the rally and post pictures supporting Denim Day by using the hashtags #DenimDayNYC #whatyoucansay #whatyoucando.
