Message from Commissioner Cecile Noel

April is Sexual Assault Awareness Month, providing another opportunity for all of us to let victims and survivors know that they are not alone and that there is help. More than a quarter of a million people are sexually assaulted in the United States every year, and most victims first experience sexual violence before the age of 25. The Rape, Abuse and Incest National Network has created a helpful guide for how each of us can make a difference, from volunteer and activism opportunities to simply reaching out to a loved one. I also encourage you to follow the New York City Alliance Against Sexual Assault, another important organization working to prevent sexual violence and reduce the harm it causes through education, research and advocacy.

A critical piece of prevention is educating our youth about healthy relationships. Understanding that approximately 72% of 8th and 9th graders are dating, in 2005 OCDV launched the **NYC Healthy Relationship Training Academy** to provide interactive workshops – in English and Spanish – on dating violence and cyber-abuse for adolescents, young adults, parents and service providers. These peer educator-led workshops educate our youth to recognize unhealthy relationships and provide them with the tools they need to build healthy relationships.

OCDV sits on the planning committee of Denim Day NYC, a coalition of community agencies, elected officials, students and volunteers united to promote awareness around the issue of sexual assault. This year, Denim Day will be commemorated throughout New York on Wednesday, April 27th. The day will consist of a rally at City Hall as well as events throughout the five boroughs. Queens Borough Cabinet Discusses Stalking

OCDV, NYPD and QDA intend to expand a collaborative program that addresses intimate partner stalking throughout Queens in the coming months. Cecile Noel, the Commissioner of the Mayor's Office to Combat Domestic Violence, relayed the news about the plan to beef up the Coordinated Approach to Preventing Stalking (CAPS) during a meeting of the Queens Borough Cabinet at Borough Hall. Steven Banks, Commissioner of the Human Resources Administration, was in Albany to lobby to include domestic violence victims in a state rental assistance program (FEPS) designed to prevent homelessness. Mayor de Blasio also hosted a roundtable at City Hall with advocates, survivors of domestic violence, and key leaders in the administration, including OCDV Commissioner Cecile Noel, to discuss the expansion of funding and eligibility for the FEPS program in the New York State budget.

A new initiative announced last week from the Vera Institute of Justice, a New York City-based nonprofit, and the U.S. Department of Justice's Office for Victims of Crime aims to change that by training police officers to facilitate communication with deaf victims, such as teaching them how to find legitimate sign language interpreters.

In a similar story closer to home, 12 jurors will hear evidence about Cherelle Baldwin, a 24-year-old Black woman from Bridgeport, Connecticut, whose attempts to escape her ex-boyfriend ended in his death.


Domestic violence by a partner or expartner during pregnancy doubles the risk of pre-term birth and low birth weight, according to a study by the University of Iowa.
