Memorandum of Agreement April 14, 2016

WHEREAS, the undersigned parties desire to enter into amendments to their collective bargaining agreement, including the 2008-2016 MOA, to cover the employees represented by the Union;

WHEREAS, the undersigned parties intend by this 2016 MOA to cover all economic and non-economic matters and to incorporate the terms of this MOA into the collective bargaining agreement covering the period from January 1, 2008 to December 31, 2016,

WHEREAS, the undersigned parties intend by this 2016 MOA to continue all of the same terms and conditions specified in the collective bargaining agreement terminating on December 31, 2007, as modified by the 2008-2016 MOA, including applicable side letters, except as modified or amended below, and

WHEREAS, the undersigned parties intend to eliminate the indirect system of Custodial Services and perform Custodial Services through a not-for-profit corporation with Local 891 Custodian Engineers ("CEs") serving as Department of Education ("Department") employees and site managers;

1. Salaries

Effective July 1, 2016, Local 891-represented Custodian Engineers' annual salaries will be based on the applicable Maximum Permissible Retainage identified in Appendix C to the Collective Bargaining Agreement, as modified by the 2008-2016 MOA.

2. Transition Bonus

A lump sum cash payment in the amount of \$10,000 shall be payable on or before December 31, 2016, upon ratification of this Agreement to those Local 891 bargaining unit members who are on active payroll as of the day of ratification. The lump sum cash payment shall be pensionable, consistent with applicable law.

For circumstances that were not anticipated by the parties, the First Deputy Commissioner of Labor Relations may elect to issue, on a case-by-case basis, interpretations concerning the application of Section 2 of this MOA. Such interpretations shall not be subject to any contractual dispute resolution procedures.

3. Mergers

Effective July 1, 2016, Article XXX of the Collective Bargaining Agreement shall read as follows:

- The Department may merge all buildings up to and including 89 thousand square feet. This limit will be the subject of continued labor/management discussion between the parties, and may be adjusted (down) by mutual agreement. The list of buildings intended to be merged for the 2016-2017 school year is attached to this agreement as Appendix A. In no event shall the number of permissible mergers be fewer than 247.
- The salary for all Custodian Engineers for all merged assignments shall be based on the higher of either (a) the applicable salary based on Paragraph 1 above (MPR), calculated based on the square footage for the primary assignment plus <u>twice</u> the square footage of the merged assignment; or (b) the applicable salary for the Custodian Engineer's primary (parent building) assignment only plus \$9,908; whichever is greater.
 - Unless agreed otherwise, the \$9,908 shall be increased by future collective bargaining (salary percentage) increases, as per the past practice of the parties.
 - Examples:
 - A Custodian Engineer is assigned to a building that is 150,000 square feet. A building that is 50,000 square feet is merged. The annual salary for the assignment will be the greater of (a) the MPR in Appendix C for 250,000 square feet, 150,000 + (50,000 x 2), or (b) the MPR in Appendix C for 150,000 square feet + \$9,908.
 - A Custodian Engineer is assigned to a building that is 290,000 square feet. A building that is 40,000 square feet is merged.
 The annual salary will be the highest MPR (277,000+) in Appendix C, plus \$9,908.
- The primary assignment for purposes of calculating salary is the largest assignment (parent building) by square footage.
- Once a building is merged, it shall not be de-merged unless discussed with a Joint Committee on merged buildings of Local 891 and the Department.
- For any assignments de-merged to effectuate this MOA or to ensure future operational efficiencies, a Custodian Engineer of a previously merged assignment that has had the merged building removed will continue to receive no less than the current salary he/she was earning until they transfer, or for up to three years; whichever occurs first. In order to remain eligible to receive the higher salary, the employee must apply for any transfer opportunities at assignments equal to or greater than the MPR their salary is based upon.

- Building allocations for each building are to be identified separately.
- Only one building (child) may be merged with a second (parent) and the continued merged status shall be subject to Joint Committee discussion as above.
- In the event the Department merges an assignment of 89,000 square feet or less in which there is a CE permanently assigned, that CE will be given the opportunity to bid on an assignment off the transfer/vacancy list. If he/she is not awarded a transfer, they have the right to remain in their assignment, but may be required to accept a merged building assignment.

4. Contracting-Out

Article XVI Section 4 of the Collective Bargaining Agreement will be replaced by the following:

Effective as soon as practicable after the execution of this agreement, other than the role of the not-for-profit corporation as the employer of custodial helpers, Local 891 shall have exclusive jurisdiction over the day-to-day supervision of all custodial helpers in school buildings. During the period of exclusive jurisdiction, the Department may not utilize a for-profit contractor (i.e. a FMS vendor) for custodial services. The Department may adopt the "direct system" at any time, but that will not impair Local 891's exclusive jurisdictional rights under this paragraph. This would not prevent the Department and/or the not-for-profit corporation from using a contracted vendor for administrative or consulting functions (e.g. payroll) in connection with custodial services. The provisions of this paragraph shall expire on December 31, 2027.

5. <u>Lump Sum Payments stemming from the 2007 – 2009 round.</u>

Those employees who died while in active service from January 1, 2008 through June 30, 2020 shall be eligible for a single lump sum payment on their behalf equivalent to the amount they would have received if they had received 4% increases on 1/1/08 and 1/1/09, which had not already been paid.

6. Employment of School Cleaning Staff

Local 891 Custodian Engineers will no longer be an employer, and the parties will amend relevant portions of the collective bargaining agreement to reflect this change. Custodial helpers will be employed by the not-for-profit corporation who will supply the custodial helpers to the schools. The custodial helpers may not be employed under FMS.

Custodian Engineers can recommend potential candidates for employment by the NFP as custodial helpers.

For employees newly hired after transition to the new system is complete, Custodian Engineers must select from at least three candidates per position, where practical, provided by the NFP as potential candidates to be assigned as custodial helpers.

Nothing contained in this Section shall preclude the not-for-profit from transferring employees from one work location to another for operational reasons.

The parties agree to form a labor management committee to discuss any other transition issues, including outstanding custodial helper-related arbitrations or lawsuits and the processes for hiring and discipline in light of these changes.

Custodian Engineers will be represented and indemnified by the Department, consistent with the current contract and with the General Municipal Law, in litigation, human rights charges, or other proceedings that are pending at the time of transition from the indirect system, and/or that occurs thereafter.

7. Budgets

Upon implementation, the contractual building allocations shall be eliminated except that the MPR (salary) schedules shall remain. The Department shall have the right to determine the appropriate labor and supply budget for each school building.

Each school shall be budgeted for the period from the transition from the indirect system through June 30, 2017, based upon the current custodial allowance for day school schedule +/- 10%.

For the fiscal year 2018 (i.e. July 1, 2017 through June 30, 2018) and beyond, each CE will be notified in advance as to what the base school allocation will be for the upcoming school year. Beginning with fiscal year 2018, it is anticipated that such notification will occur before May 1, to be effective July 1. The CE, in consultation with the Principal, will be responsible for establishing a building plan which will fit within that base budget.

All allocations based upon extra activities outside the school day shall be eliminated. However, school allocations will be supplemented and adjusted by the Department based upon the volume of extra activity at the site, as well as emergency conditions or other operational changes which may occur during the year.

8. Other Financial Items

- Custodial bank accounts will be closed and eliminated.
- Custodian Engineer held worker's compensation insurance policies will be eliminated. The Department will absorb any costs associated with

- payroll audits by the NYSIF and any new costs associated with the transition to the not for profit as employer of custodial helpers.
- Custodian Engineers will promptly request and participate in payroll
 audits by their worker's compensation insurance carrier once their
 insurance policy is cancelled. Custodian Engineers will surrender to the
 Department any refunds paid to them. The Department will bear the cost
 of any balance due the insurance carrier.
- Custodian Engineers will be responsible, under the terms of the existing collective bargaining agreement, for any payroll or worker's compensation issues up to the day before employees are transitioned to the not-for-profit.
- Processes that are currently managed financially through the Custodial Payroll system (e.g. – Permits, Space Sheets, DAR's, Audit, etc.) will be modified and integrated into the new financial management systems.
- Custodians will be responsible for managing to building budgets provided by the DOE, but will no longer have personal financial liability.
- All deficits (from the inception of the use by the Department of 1099s to report CE compensation to the present) at the time of implementation of this agreement will be used to reduce the amount of current excess or otherwise waived.
- The reimbursement for travel between merge building sites shall be eliminated. Travel reimbursement for other official business will continue consistent with other DSF employees.
- The Legal Defense account contribution will be reallocated to the Local 891 Annuity Fund.

9. Custodial Rating System

The parties will form a labor/management committee of equal representation to address the rating system in light of the overall systemic changes. Any changes will be approved by mutual consent of the parties.

10. Work Schedules

Employees hired into the Local 891 collective bargaining unit after May 1, 2016, may be assigned any of the following work schedules, at management's discretion:

6am-3pm 7am-4pm 8am-5pm

After they complete their one year probation, they may request a change to any of the other available work schedules. The decision on such requests will be made by the Division of School Facilities on a case-by-case basis and shall not be subject to

contractual dispute resolution procedures. Custodian Engineers may also request a 9am-6pm work schedule with the approval of the Division of School Facilities.

Custodian Engineers hired before May 1, 2016 shall continue to be assigned to the 8am-5pm schedule, except for those currently approved to work a different schedule. Custodian Engineers hired before May 1, 2016 may request to be changed to any of the three additional work schedules with the approval of the Division of School Facilities.

Custodian Engineers are not required to be physically present for after school activities or times outside their normally scheduled hours, and their duties shall remain consistent with the job specification.

11. Education

A relevant two year associate's degree, or four year degree (e.g. engineering technology, construction technology, construction management, building management) from an accredited College/University will be treated as the equivalent to a Stationary Engineer License (High Pressure Boiler Operator) for promotional purposes.

12. Emergencies

The parties' settlement with regard to extra work performed during Hurricane Irene and Hurricane Sandy shall be applied to future City-wide emergency conditions in which school buildings' use as shelters require extra work performed by Custodian Engineers.

13. Release Time

City/DOE agree to an additional release time position with pay, for a total of three positions. The union will also be allotted one release time position, which the Union will continue to reimburse the Department that employee's actual cost.

14. <u>Labor/Management Committee</u>

Upon ratification a joint committee of the parties will be formed to incorporate language changes only necessitated by the MOA. No other sections will be modified. The joint committee of the parties will meet further, but only by mutual agreement of the parties, to modify or delete obsolete sections of the existing CBA, the intent being to craft a new consolidated agreement.

15. Civil Service

Nothing in this agreement shall be construed to change the civil service status of current or future Local 891 represented Custodian Engineers. Neither this Agreement, nor any current or new responsibilities of the Custodian Engineers shall be construed to change their status as competitive class civil servants and may not be used as evidence in any case in which managerial or confidential status is at issue.

Custodian Engineers do not have direct involvement and participation in the negotiating process on behalf of the Department nor do they have direct and powerful influence on policy formulation at the highest levels of management; accordingly, their eligibility for collective bargaining status as Department employees will continue unimpaired.

16. Economic Pattern

Upon establishment of a civilian economic pattern for the period beginning in 2017 ("the successor agreement"), Local 891 and the City will promptly commence expedited negotiations and Local 891 will be offered an economic package consistent with the net cost of the pattern established.

17. Other Negotiations

This Agreement is not contingent upon, or subject to, negotiations between the City/Department and/or the not-for-profit corporation and any other union.

18. Savings Clause

In the event that any provision of this Agreement is found to be invalid or unenforceable, such invalidity shall not impair the validity and enforceability of the remaining provisions thereof. In the event that the underlying system (i.e. the not for profit employer) is no longer viable, the other provisions of this Agreement will be presumed valid, Custodian Engineers may employ custodial staff unless the Department adopts the "direct system," and the parties shall meet and negotiate the effect on the terms of this Agreement. Local 891 shall not support, directly or indirectly, any challenge related to the creation or operation of the not-for-profit corporation.

19. Continuation of Terms

All of the terms and conditions of the parties' collective bargaining agreement terminating on December 31, 2007, as modified by the parties' 2008-2016 MOA, including applicable side letters and interpretations, shall remain in effect except as modified by this 2016 MOA.

20. Ratification

This Agreement is subject to ratification by the Union, and adoption by the Board of Education.

Dear Mr. Troeller:

The parties agree to the following procedure related to a one-time transfer, as soon as possible after ratification and adoption, in order to effectuate the provisions of this 2016 Memorandum of Agreement:

- 1) <u>All</u> Custodian Engineers, regardless of time served in their present assignment, will be eligible for transfer on the next effective vacancy list (One time only).
- 2) All available assignments will be listed on the next vacancy list.
- 3) A second vacancy list will immediately follow, listing all assignments available after the results of the first vacancy list are determined.
- 4) Custodian Engineers awarded assignments from the first vacancy list are **NOT** eligible for transfer on the second vacancy list.
- 5) If a Level II assignment is not accepted by a Level II Custodian Engineer, the assignment may be selected by a qualified, eligible Level IR. If no Level 1R selects the assignment, a qualified, eligible Level I with the most seniority shall receive the assignment. Appendix A to the MOA will be published and disseminated by the Department to all Custodian Engineers immediately before the first transfer list is promulgated.
- 6) The transfer move date for both lists will be implemented on the same day.
- 7) All vacancy lists thereafter will be pursuant to Article IV of the Collective Bargaining Agreement between the parties.
- 8) A delayed transfer may be required to implement the terms of this side letter.

The parties agree that the amendments to Article XVI, Section 4 shall not be construed to limit the DOE's right to contract-out or to otherwise change the system of custodial operations after January 1, 2028. Local 891 acknowledges that it does not have exclusive jurisdiction over the work after January 1, 2028. Consequently, after January 1, 2028 DOE has the right, without restriction from the collective bargaining agreement, to change the system of custodial operations, including contracting directly with private contractors, without agreement of the union.

Dear Mr. Troeller:

This letter is in response to the Union's query regarding the provision of supplies to Custodian Engineers.

The Department intends to continue its current practice of purchasing materials through the DOE integrated supplier, SDI, for a period of time to allow Custodian Engineers to operate uninterrupted during the transition.

It is the Department's intent to transition to a supplies purchasing system that utilizes the current DOE FAMIS system, known as Shop DOE (or similar system). We expect to begin to publicly procure supplies through rationally-arranged commodities group contracts and enter such supplies items in the DOE on-line catalog system. It is envisioned that Custodian Engineers would log onto the on-line system and place orders for supplies, materials and some services (e.g. - dust mop service). Purchase orders would be generated by the system, and assigned to a supplies budget code specific to the individual building. Custodian Engineers (and DOE management/supervisors) shall monitor order status through the system. Budget codes for supplies are expected to be separate from labor or other budgets. There will be a management approval process for all orders placed through the system.

Custodian Engineers will still have the ability to purchase small items on an urgent basis either in a manner comparable to the current system or other system to be determined by the Department.
