NYC2010 – Results from the 2010 American Community Survey Socioeconomic Characteristics by Race/Hispanic Origin and Ancestry Group

The following charts show socioeconomic data from the 2010 American Community Survey (ACS) for those race/Hispanic origin and ancestry groups in New York City with a total population of at least 65,000 persons, the minimum population required to obtain 1-year ACS profiles for specific population groups.

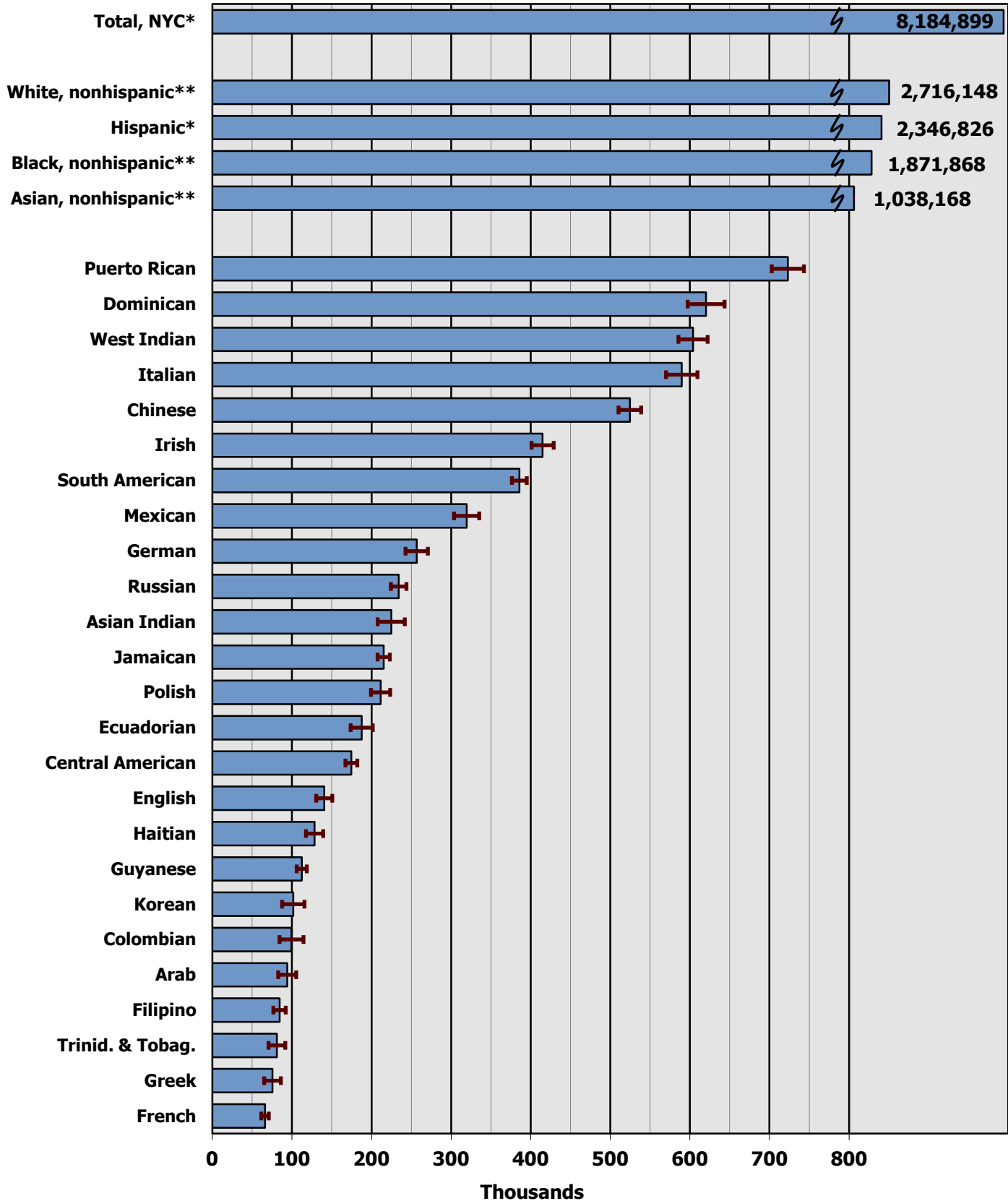
The groups are arranged in three tiers. The first tier consists of the total population. The second tier consists of the four major mutually exclusive race/Hispanic origin groups: white nonhispanics, black nonhispanics, Asian nonhispanics, and Hispanics. The third tier represents the most inclusive definition of selected Asian groups (specific Asian groups alone or in combination with other Asian groups or races as derived from the responses to the detailed race question); Hispanic origin groups (derived from responses to the detailed Hispanic question); as well as ancestry groups as defined in the Selected Population Profiles. These third-tier groupings are not mutually exclusive.

The ACS estimates are created using a sample of population and housing, so the numbers in each chart are subject to sampling error. The “confidence interval” expresses the degree to which an estimate may vary due to sampling error. For example, while the point estimate of Puerto Ricans in the first chart is 723,069, there is a 90% chance the actual number of Puerto Ricans is somewhere between the confidence interval’s lower bound (702,861) and upper bound (743,277). The charts show ACS estimates for various characteristics along with their confidence intervals, represented as dark red brackets.

Users should note that the charts rely on the population estimates within the Selected Population Profiles. These numbers may differ slightly from the estimates provided under Total Ancestry Reported in Census Bureau tables. If an ACS respondent listed their ancestry as “Berliner” and “Bavarian,” for example, this reply was counted as two separate reports within “German” ancestry under Total Ancestry Reported, while under the Selected Population Profiles it was considered as only one response within “German” ancestry.

It should also be mentioned that the Arab and West Indian ancestry groups represented in these charts are nested categories with many ancestry responses included under a single group name. For example, the Arab ancestry group includes respondents who identified themselves as “Arab,” as well as those who provided more specific responses, such as “Egyptian,” “Iraqi,” and “Jordanian.”

Total Population by Race/Hispanic Origin and Ancestry New York City, 2010

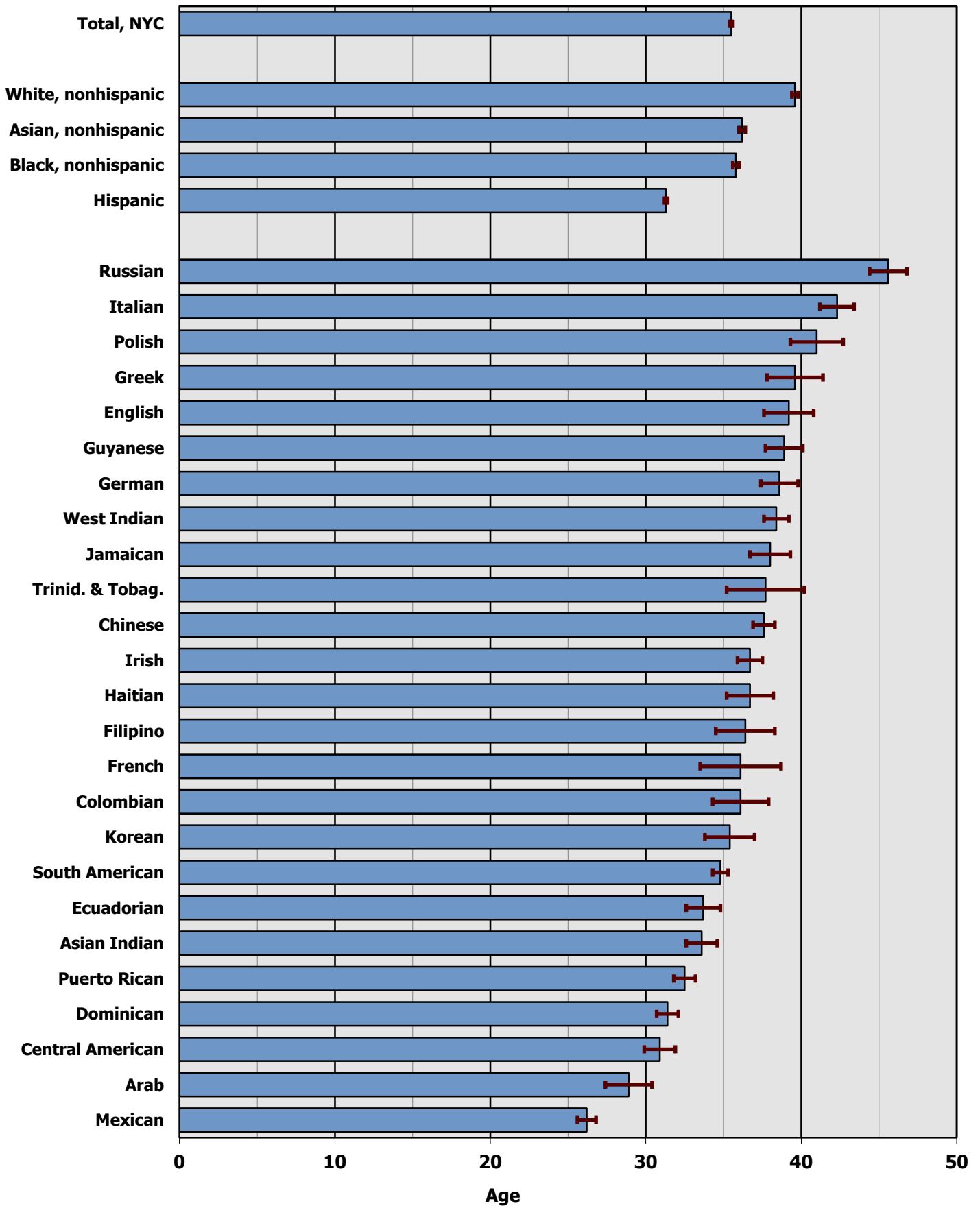

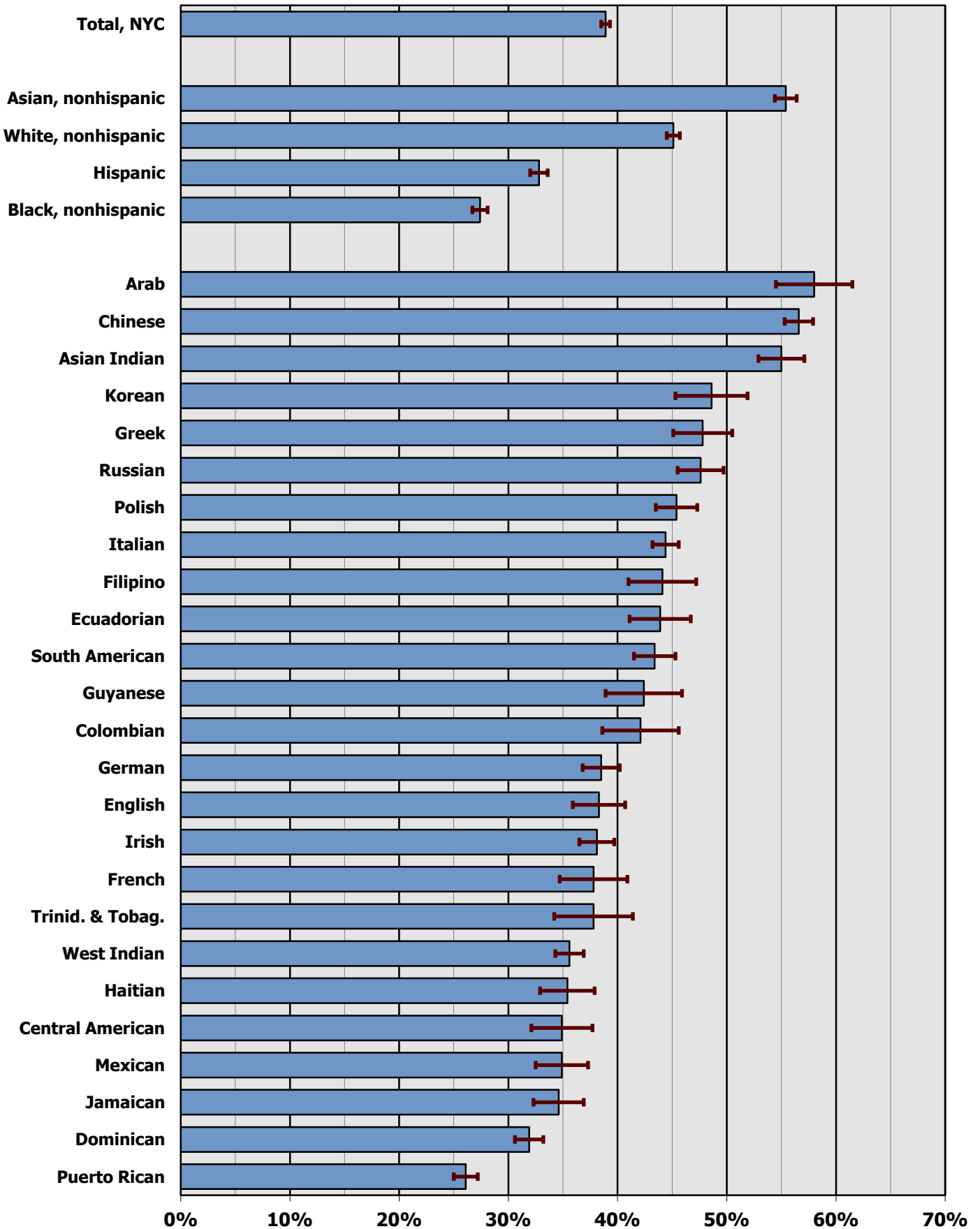

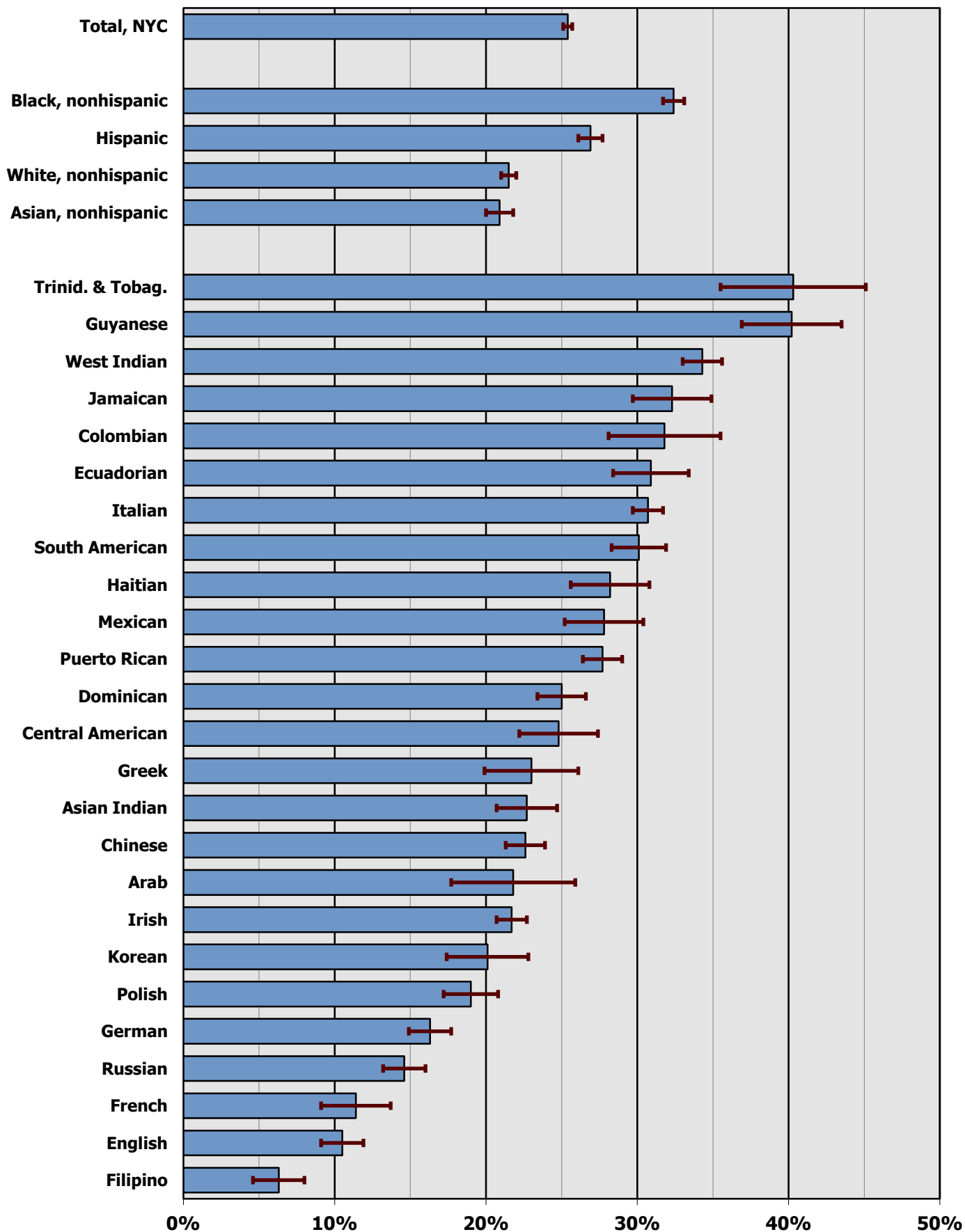
**Median Age of Total Population

New York City, 2010**



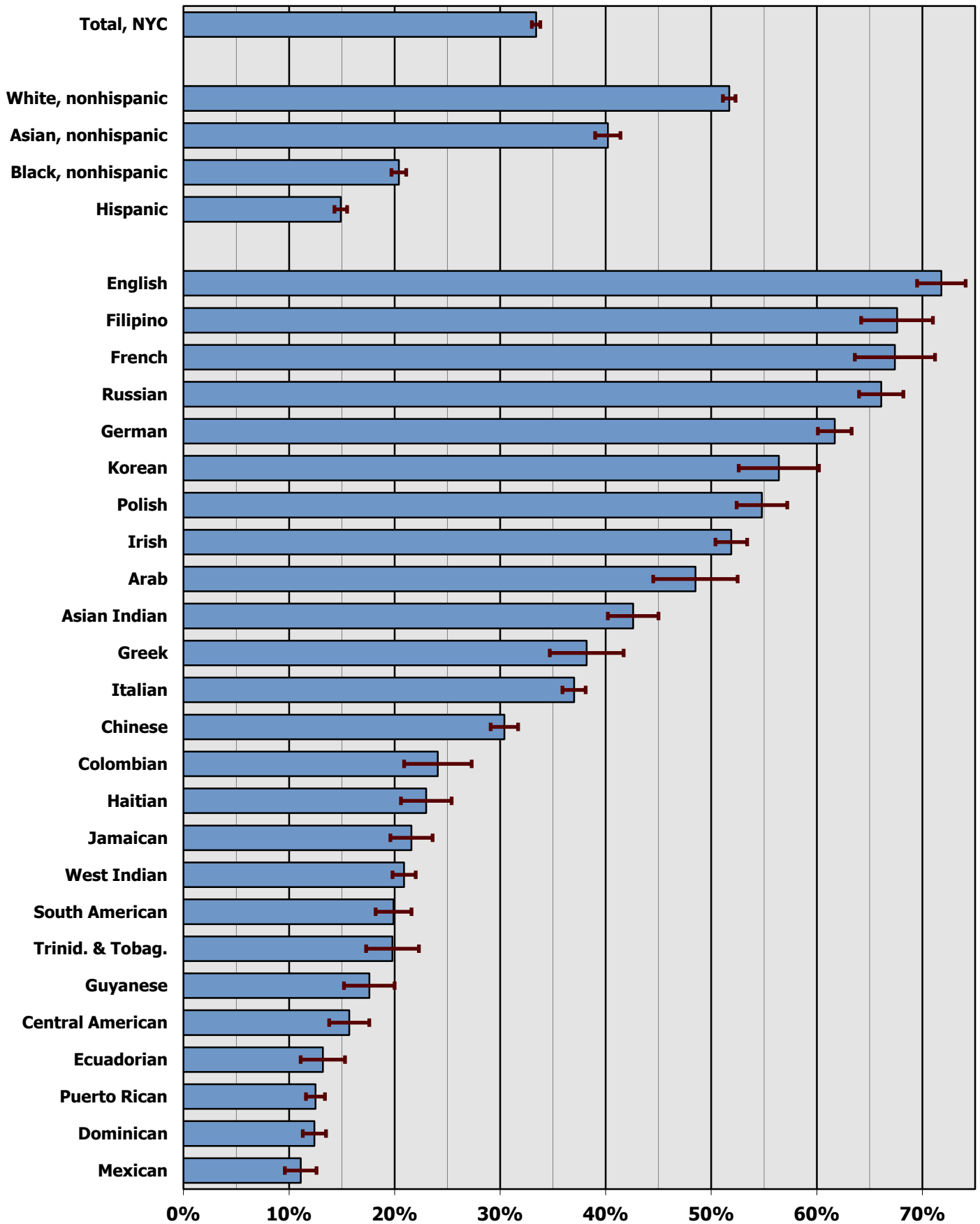
**Percent of Total Population

by Race/Hispanic Origin and Ancestry, New York City, 2010**



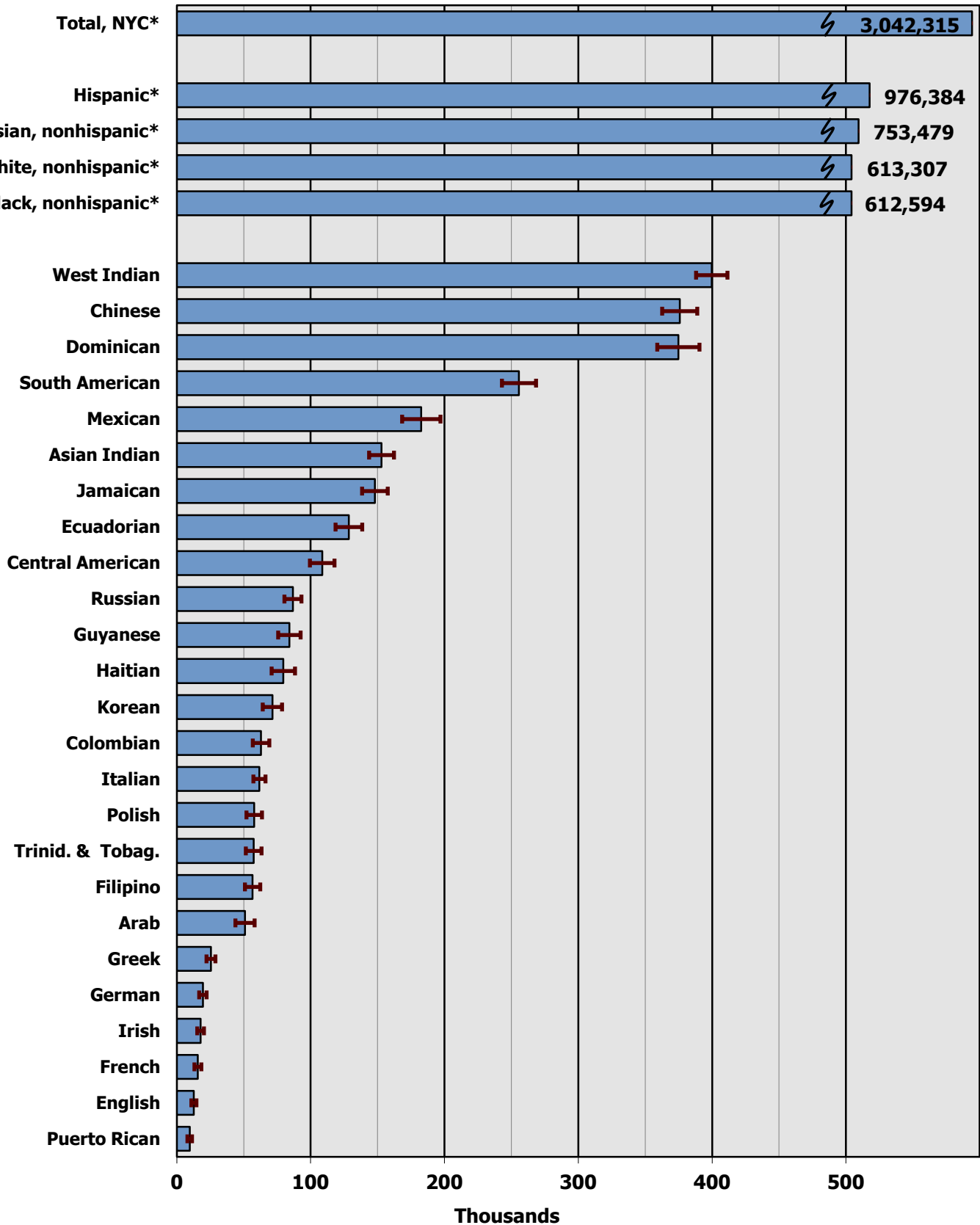
**Percent of Total Population 25 Years and Over

by Race/Hispanic Origin and Ancestry, New York City, 2010**



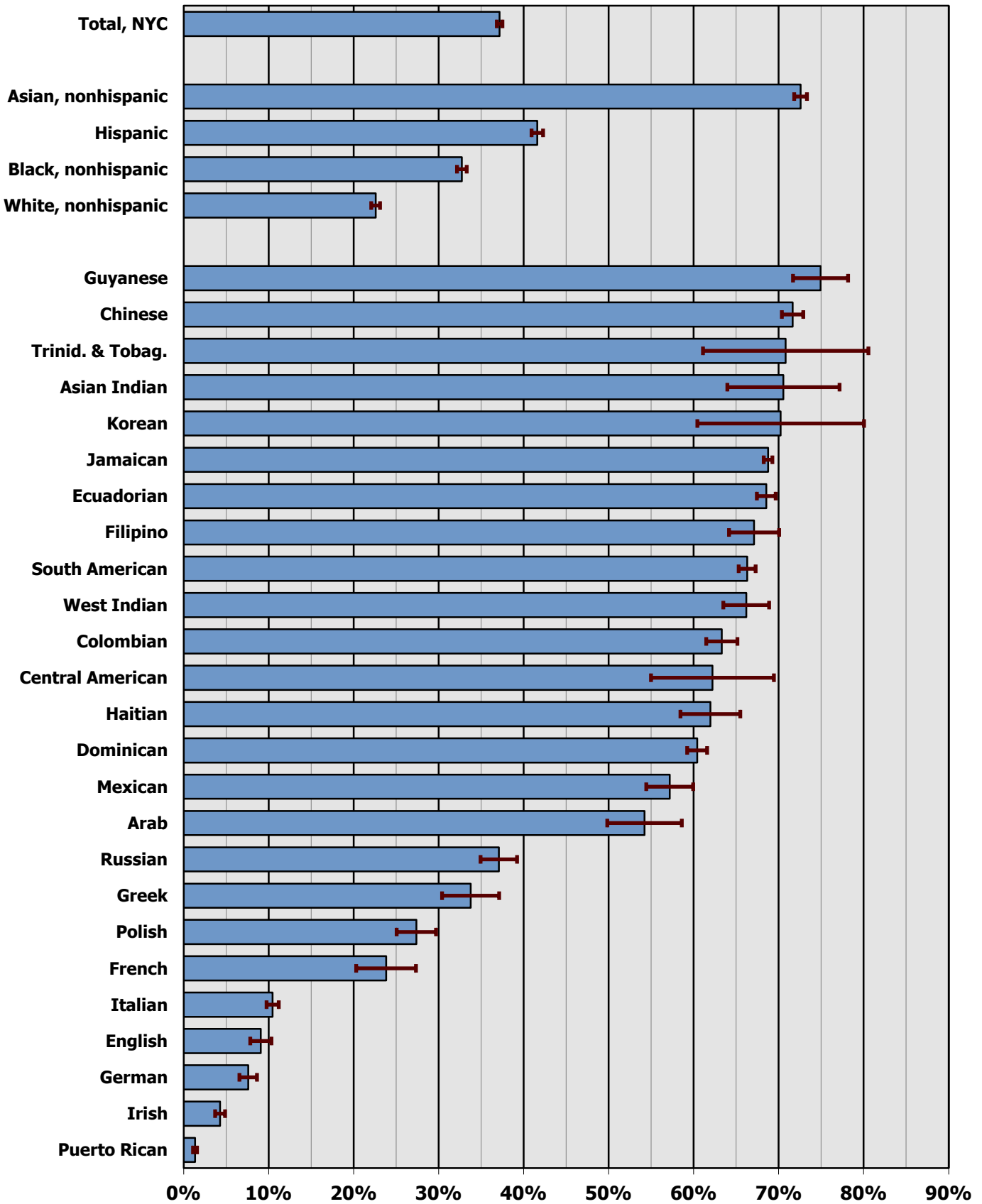
**Foreign-born Population

New York City, 2010**



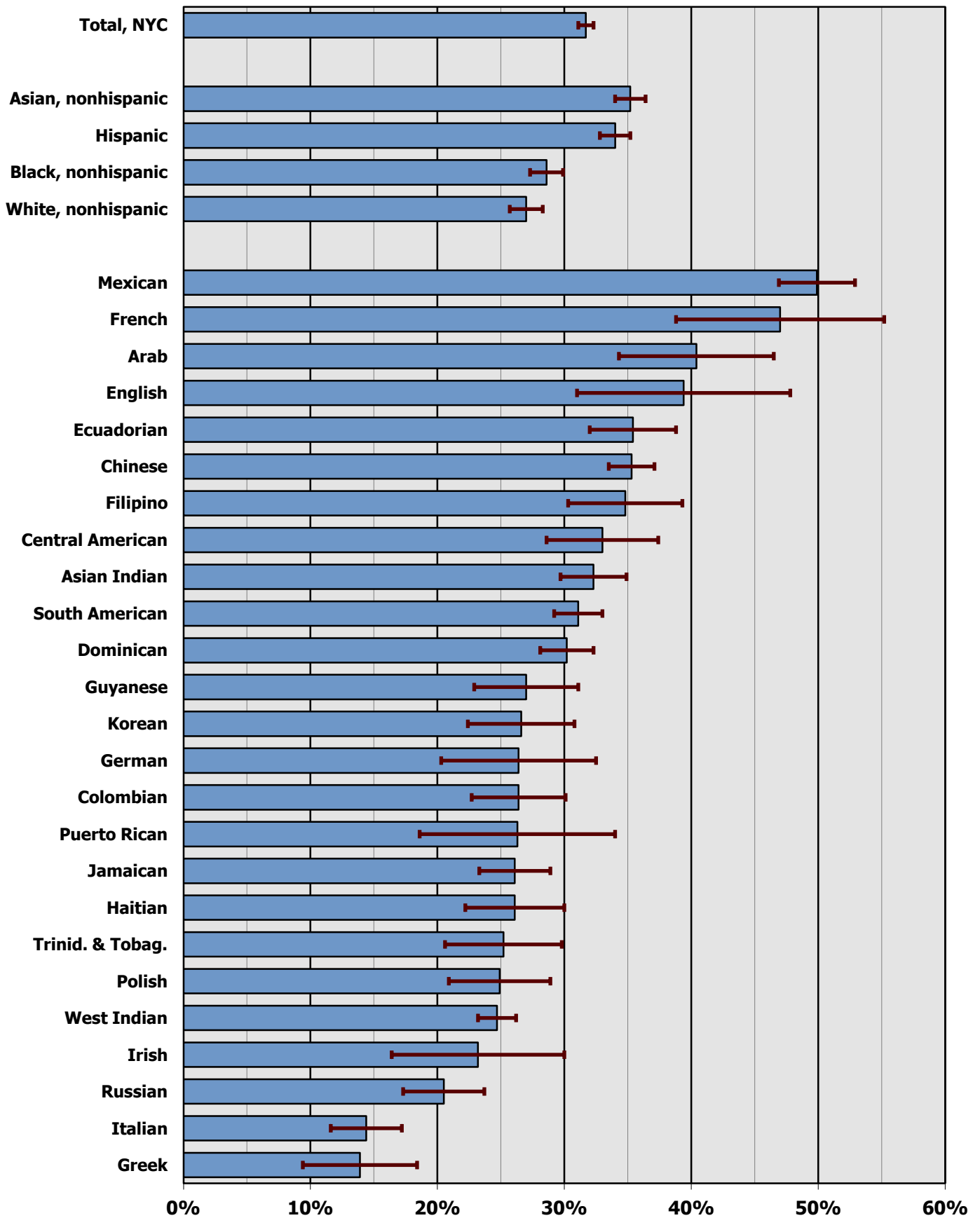

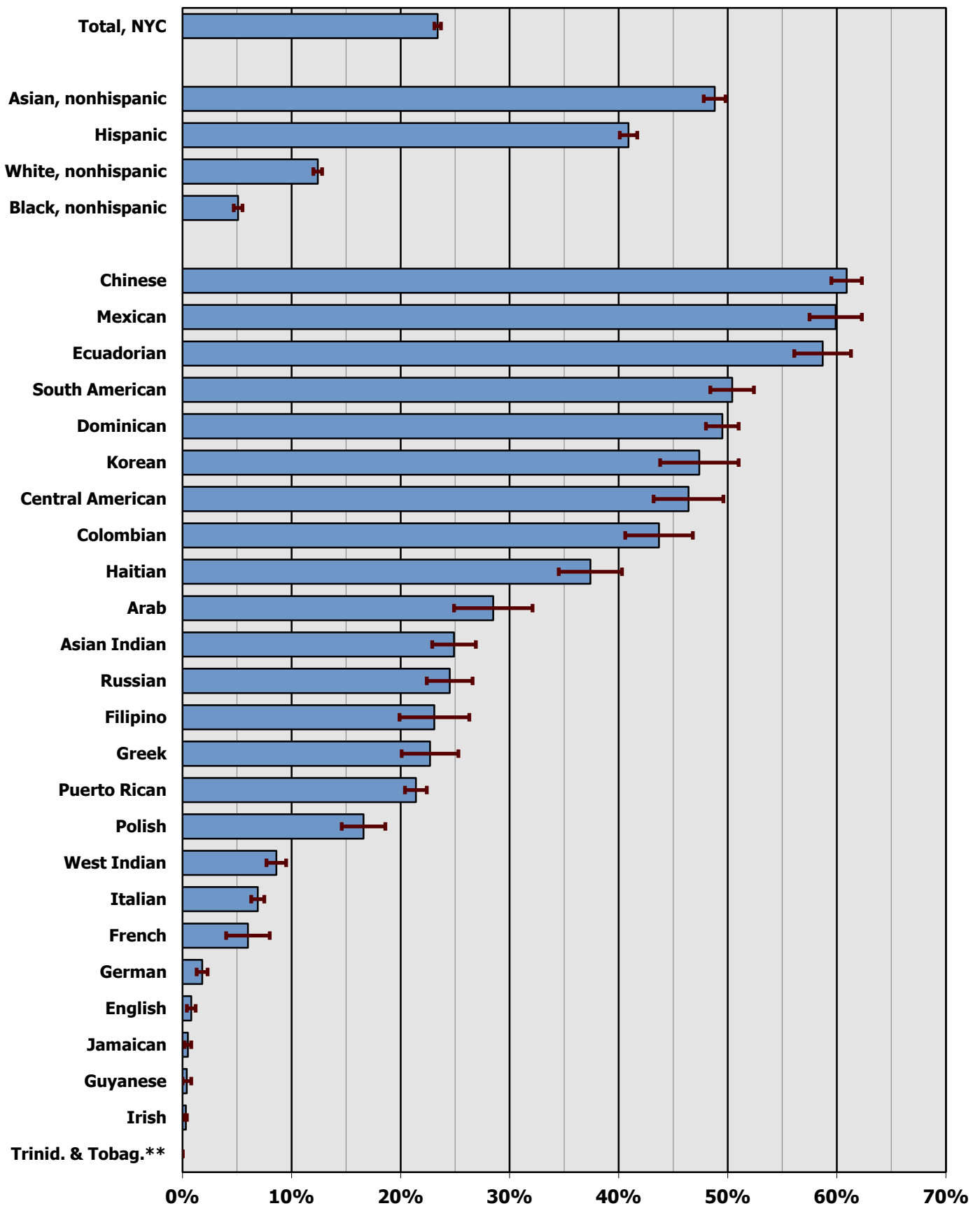
**Percent of Total Population that is Foreign-born

Percent of Total Foreign-born Population that Entered the U.S. in 2000 or Later by Race/Hispanic Origin and Ancestry, New York City, 2010



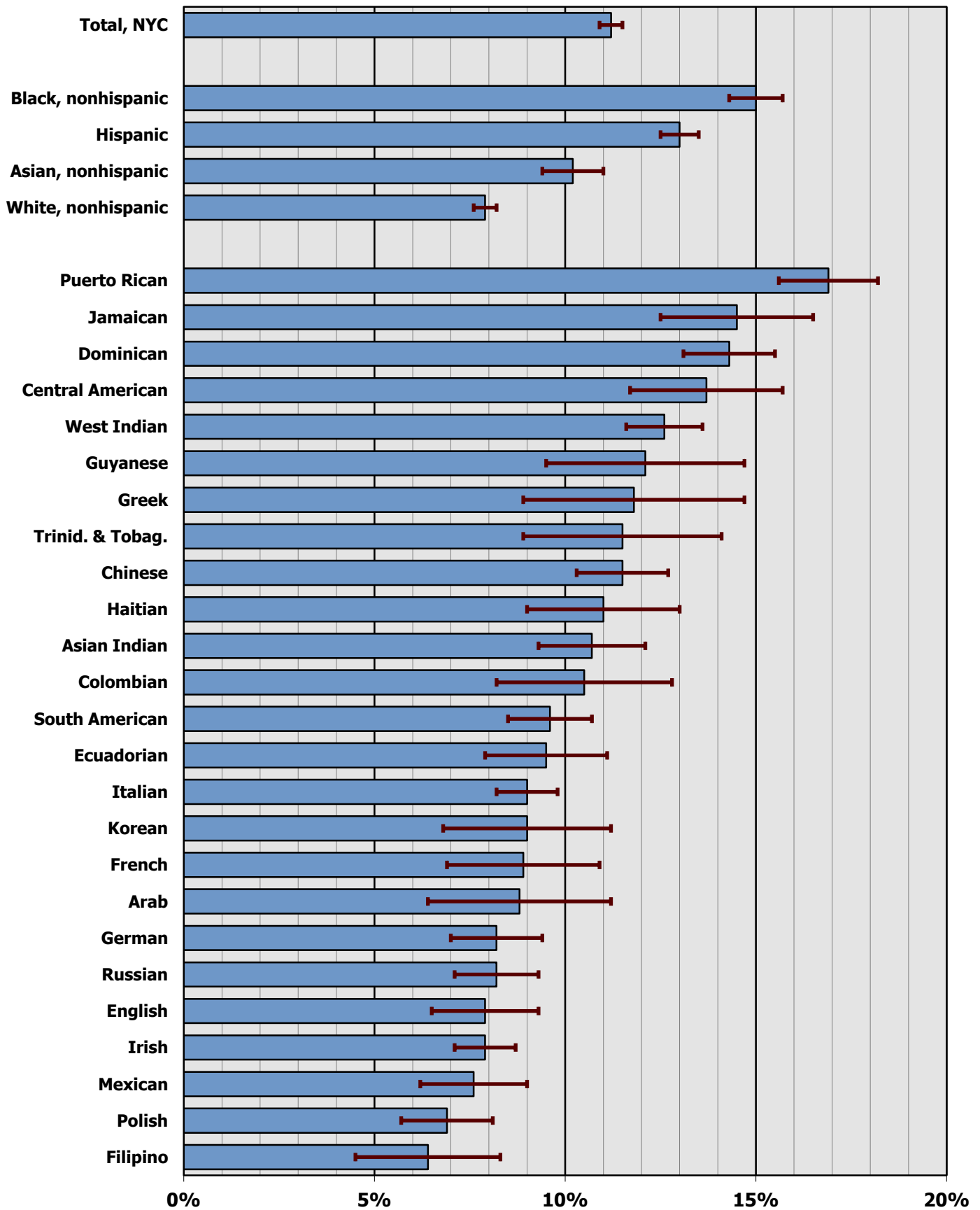
**Percent of Population 5 Years and Over that Speaks a Language other than English at Home and is not English Proficient*
by Race/Hispanic Origin and Ancestry, New York City, 2010**



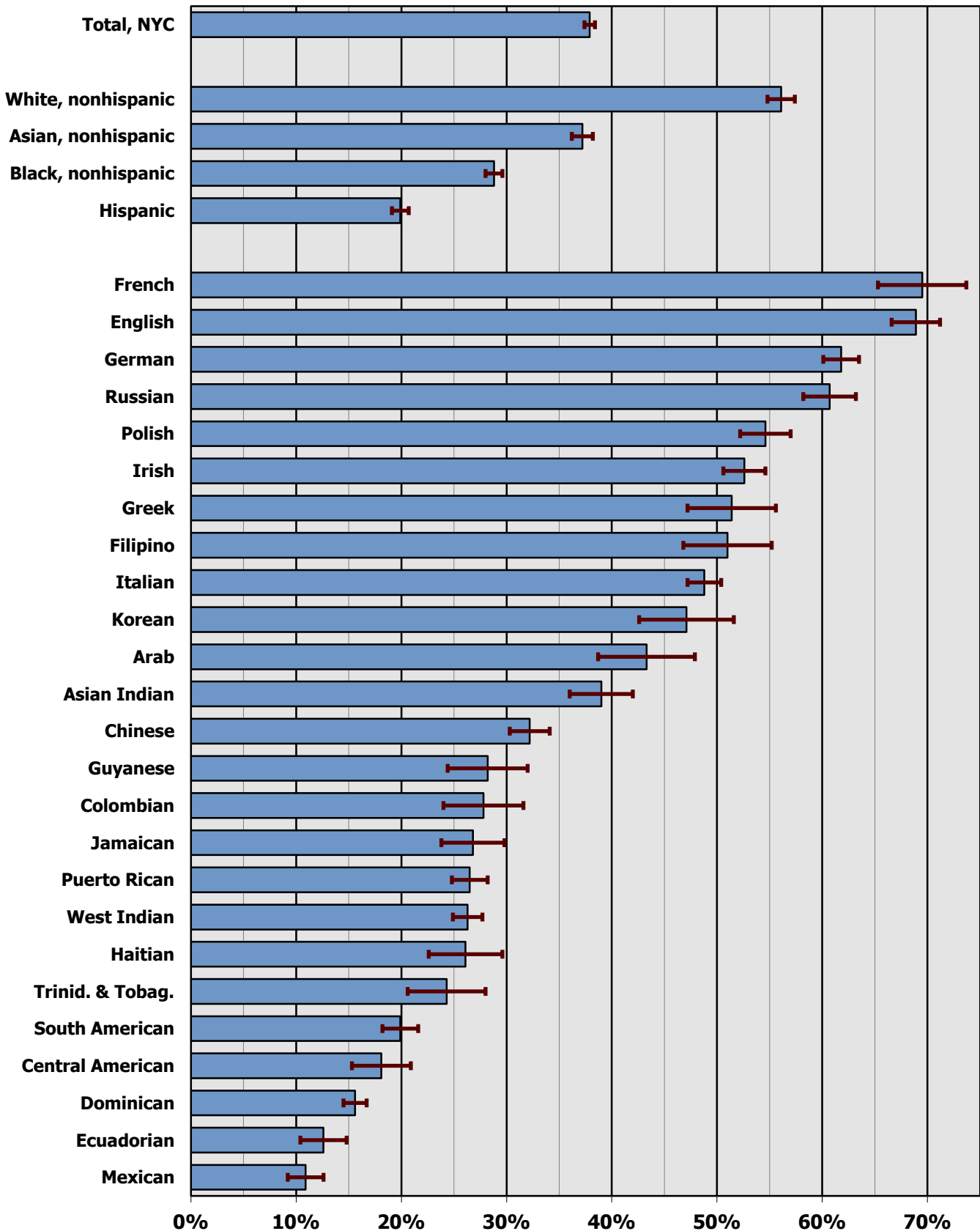

by Race/Hispanic Origin and Ancestry, New York City, 2010**

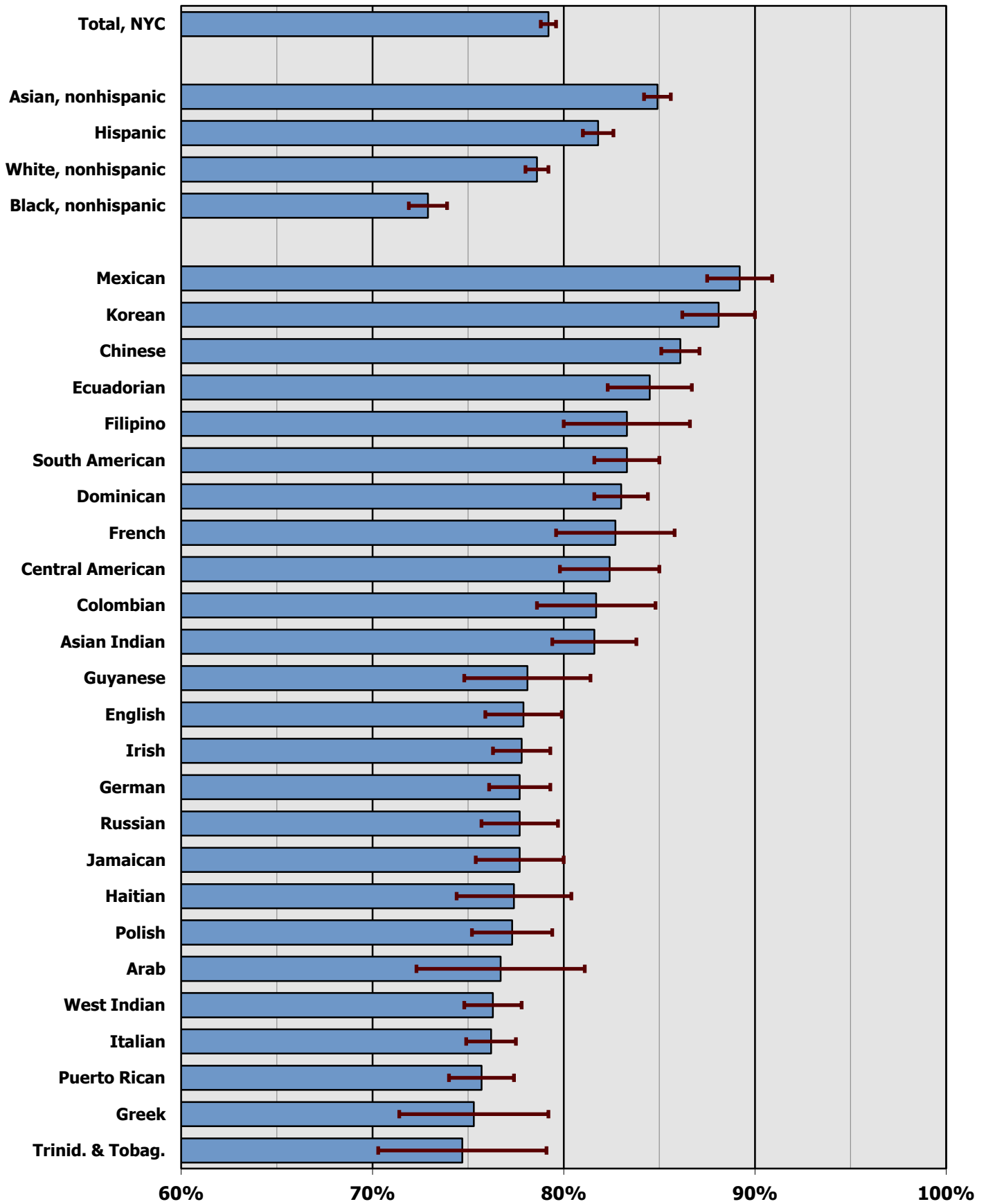

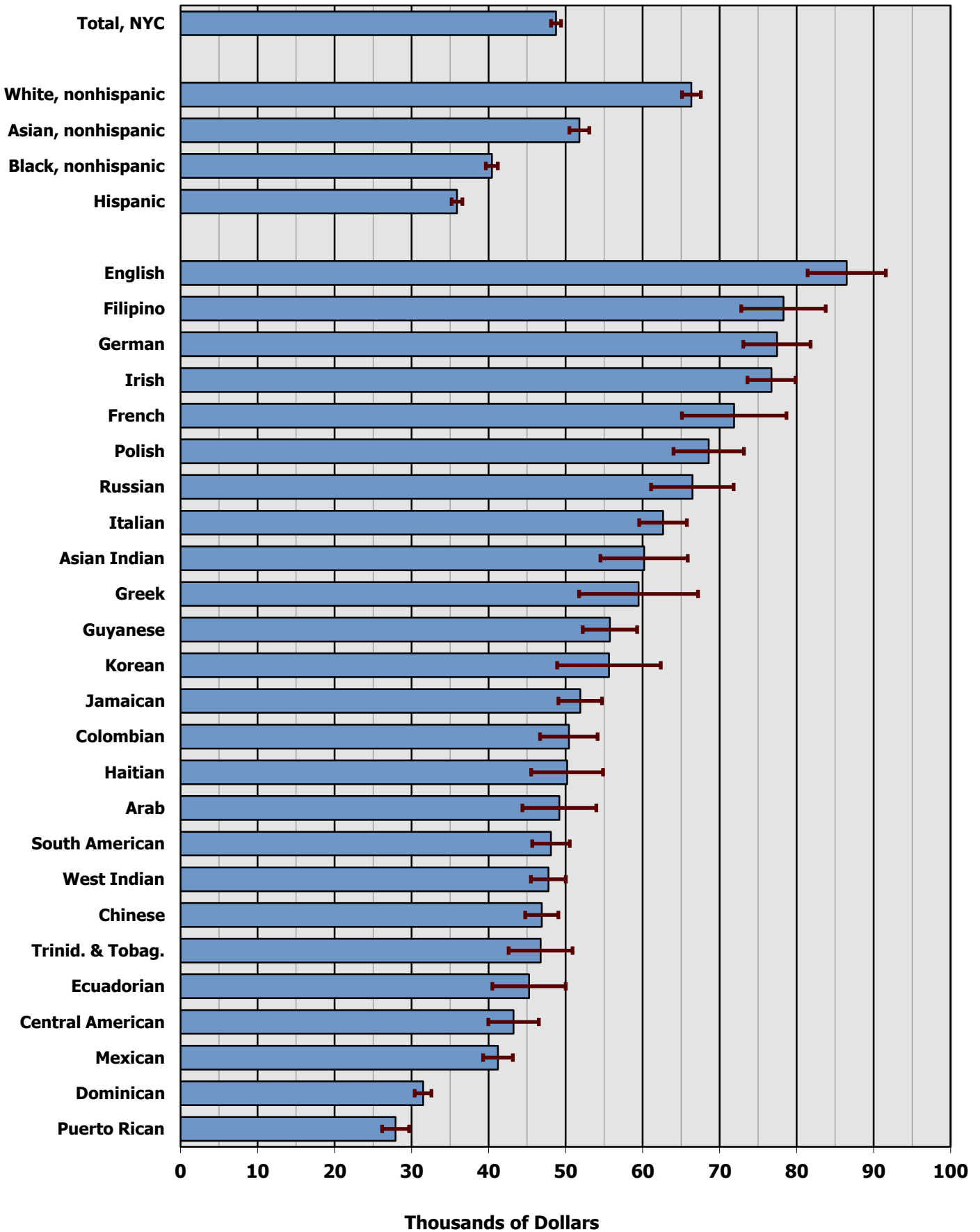

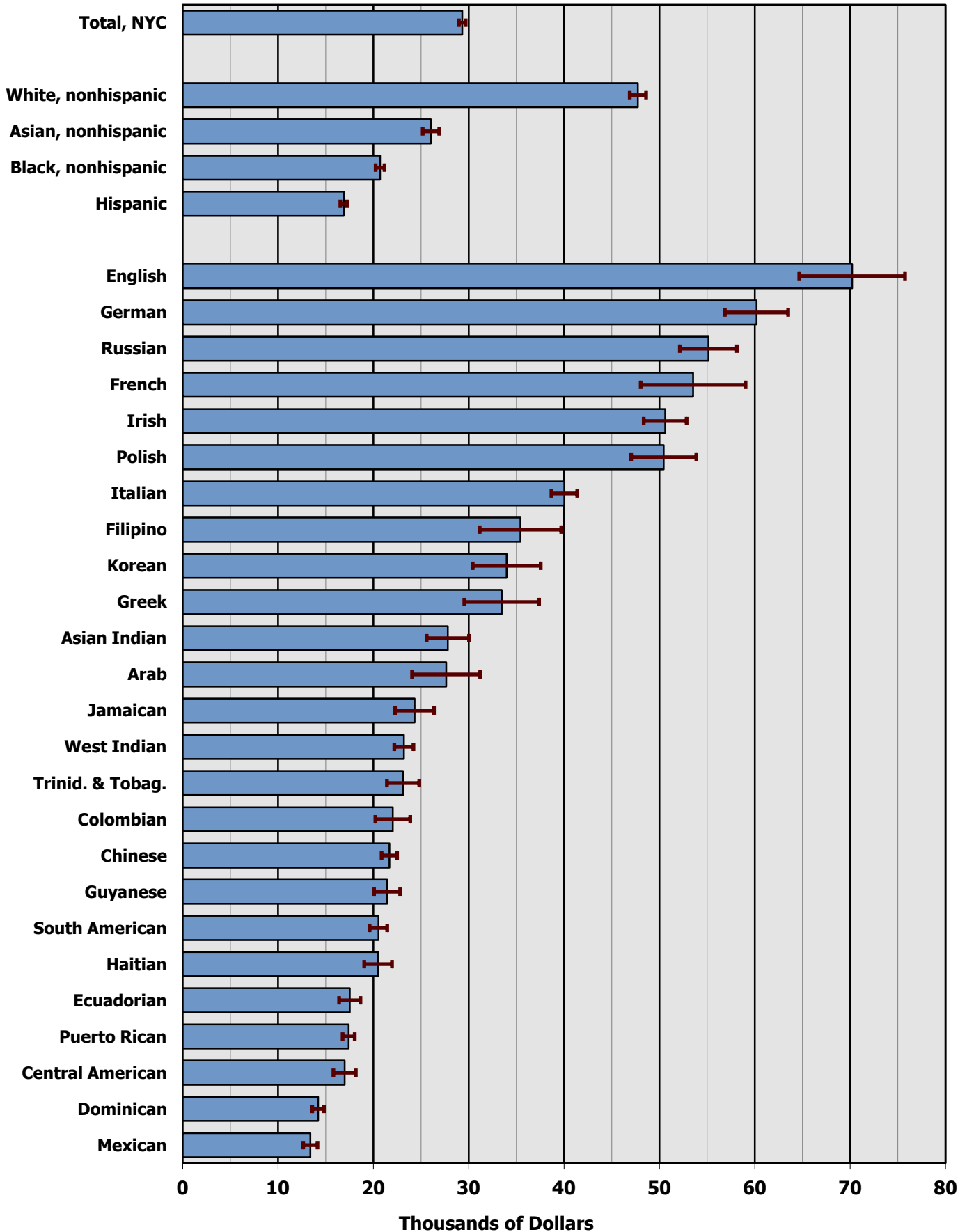
**Percent of Employed Civilian Labor Force 16 Years and Over

by Race/Hispanic Origin and Ancestry, New York City, 2010**



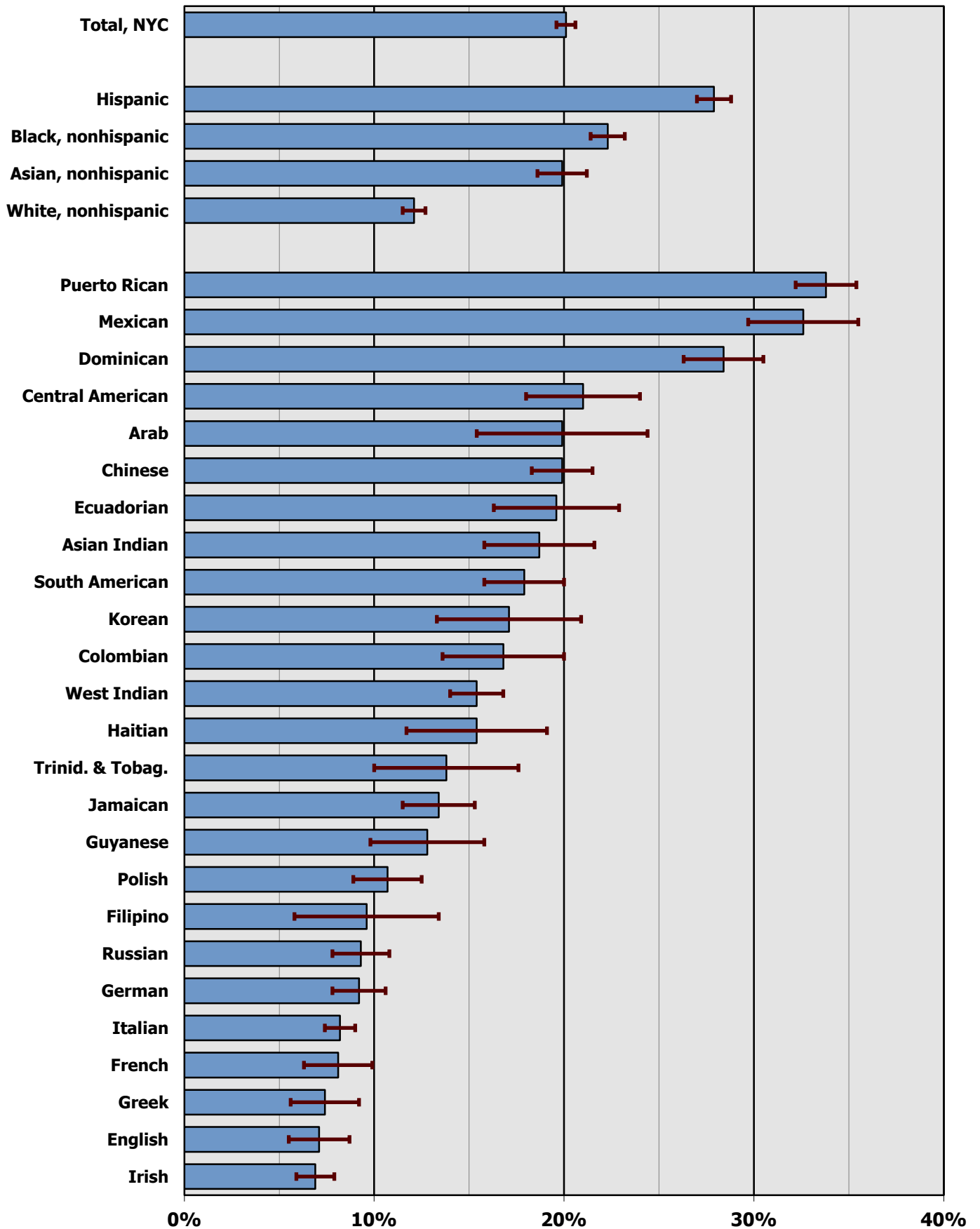
**Median Household Income

New York City, 2010**



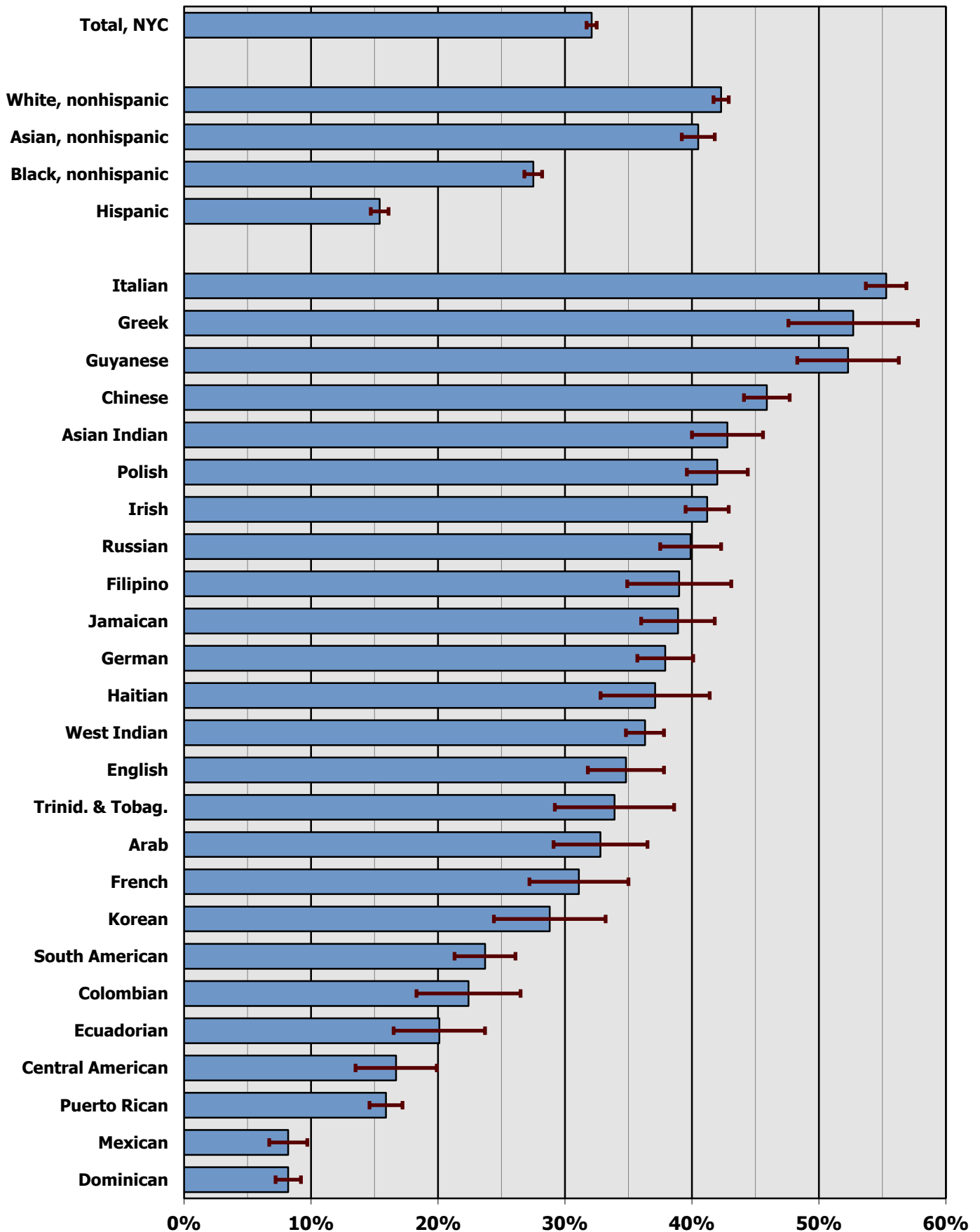
**Per Capita Income
