The new regulations affect the following area:

North: Astoria Park South (included) from Shore Boulevard to 21st Street

East: 21st Street (not included) from Astoria Park South / Hoyt Avenue South
To Broadway

South: Broadway (included) from 21st Street to Vernon Boulevard

West: East River from Broadway to Astoria Park South

The changes do not affect the 8 a.m. to 6:00 p.m. rules, parking meters, or any rules which are not Street Cleaning Regulations.
