**Chair Evie Hantzopoulos:** Meeting called to order at 6:30pm. Agenda presented.

**Presentation and Q&A: YouTube marker 0:01:50**

**Queens District Attorney Melinda Katz** - The District Attorney discussed the difference between misdemeanors and felonies and explained how each suspect coming through her office is vetted for mental health issues. The office handles 60,000 arrests every year with 47,000 arraignments every year. The District Attorney's office has helped about 43,000 individuals through victim services. The office balances about 1,500 gun cases at once - which would be possession, shootings murder, assault.

The DA discussed the following cases:

The stabbing murder of an EMS Lieutenant who was buying coffee in a bodega. The suspect was convicted and was sentenced to 25 years to life; The case of a well-publicized home invasion. The suspect is facing 13 life sentences; The case of a plastic surgeon practicing without a license which resulted in death.

The DA also spoke about her focus on preventing car thefts and her office addressing the scooter problem in the borough.

The DA discussed her staff and their interaction with the community to help people protect themselves from crime.

The DA discussed her office addressing retail theft through the "Trespass Affidavit Program" which gives people a second chance so they don't go directly to jail. Instead the accused is not allowed to return to the store. 1400 Affidavits were given out and only 100 returned to that store. Those people received the mental health help they need.

Lastly, the DA discussed the various scams that are occurring where people call seniors pretending to be their children or grandchildren who need money for bail, or they receive a call from someone saying they are from the DA's office asking for money for bail. Also, she cautioned about romance scams and advised people to contact her office if they were a victim of a scam and they will try to get their money back.

**Dan Aliberti:** What do you say to people who are involved in romance scams who don't believe you when you explain they are being scammed.

**DA Katz:** I don't have official advice, but I would ask if they have ever Facetimed with the person. Do they know who that person really is?

**Tom Ryan:** People with long rap sheets are let out of jail. When will it stop?

**DA Katz:** The law has changed for the better and now they allow District Attorneys to ask for bail and we do when someone has multiple arrests. We can always hold someone on violent crimes. NY is the only state where you can't ask because someone is a danger, but usually the violent crime overlaps.

**Stacey Eliuk:** How do you combat scams using AI?

**DA Katz:** I have experts on board who are experts on these types of scams. We are able to get people's money back when it comes to crypto-currency. We had an issue with Stub Hub where 2 people were diverting emails. It was a \$600,000 scam. We have modernized the office with technology and experts.

**Christina Chaise:** What is your office doing about targeted sexual violence and guns?

**DA Katz:** When I became DA I formed the Human Trafficking Bureau, especially because we have 2 airports and many hotels that service those airports. We go out in the community to hand out fliers to prostitutes who may need help. We also have a Youth Bureau, so young people understand gun violence and how to be safe. We try to stop people from getting involved in violent situations. The Special Victims Bureau also works with youth. We don't just prosecute - we educate and direct people towards the help they need. My staff have to go to community events because you can't be a good prosecutor if you don't know the neighborhoods.

**Presentation Q&A YouTube Marker 0:29:04**

**Alexander Kipp, Director of Education & Engagement, NYC Conflicts of Interest Board** - Gave a presentation about how board members comply with New York City conflict of interest laws. The two most important things that a Community Board member needs to know is that they are allowed to have discussions on matters where they have a conflict of interest as long as they disclose the conflict before participating in the discussion. However, a Community Board member may NOT vote on a matter in which he or she has a conflict of interest. When it comes to conflict of interest it can be an associated benefit or a direct benefit. Associated benefit means someone associated with you like a spouse, a parent, a sibling, child, a registered domestic partner or anyone with whom you have a financial relationship such as a landlord, a debtor, a creditor, someone who co-signed on your student loans, a client in your private practice or not for profit if you sit on its board or your private employer or the business you own. These are the types of entities that

you might be associated with which would cause a conflict of interest so you cannot vote. Direct benefit means that the financial benefit goes right to you. An easy way to sum it up is - Disclose - Discuss - Don't Vote.

Chairing a Committee - Conflict of interest can also impact committee chairmanship. If there's any issue where the chair must disclose, discuss, don't vote, somebody else has to chair that meeting to preside over that action. If the chair of a committee has to disclose, discuss, don't vote 3 times in a 12 month period, that person cannot chair that committee, however, s/he may remain on the committee as a member.

Quorum - Conflict does not affect quorum. If a person discloses then that person is not counted in the vote at all. When you disclose you don't say "abstain" because that is someone who is eligible to vote but chooses not to vote so the person remains in the vote tally. You say "ineligible" which means you are taken out of the count.

Gifts - The law states that no public servant can take a gift valued at more than \$50 from anyone doing business with the City of New York.

City Resources - May only be used for community business, not for financial gain.

Political - You can not do political business on the Community Board.

Presenting to the Community Board After You Leave Service - You may not present before the Community Board you served on after you leave on behalf of anyone you have a financial relationship with for one year.

Community Board Members ONLY Represent the Community. They do not represent private entities, friends, establishments they frequent, etc.

#### Q&A

**Dan Aliberti** - Are there penalties for violating the Conflict of Interest laws?

**Alexander Kipp** - There are many levels of penalty. If accidental, it may only be a letter. If it is knowingly, you can get serious fines and criminal penalties.

#### Item #1: 32nd Street Demapping C 250068 MMQ For CB Public Hearing and Vote YouTube marker 0:59:48

Application by Grace Lutheran Church to Amend the City Map to eliminate, discontinue and close a portion of 32nd Street between Ditmars Boulevard and 21st Avenue in Astoria. <https://zap.planning.nyc.gov/projects/2023Q0430>

No development is proposed for the area - it is just to remove the encumbrance of this mapped but unbuilt street from the school property. The property is currently used as a playground. There have been no objections from elected officials, government agencies or utility companies to the paper street being removed.

#### Q&A

**Adam Fisher-Cox** - Asked how the City could take over property if it is private.

**Ben Stark** - It's not public until the City acquires the title. There are paper streets all over our city. There happens to be more unbuilt paper streets in Queens than the other boroughs. The City could take the title of the property.

**Dan Aliberti** - Asked what the precipitating event is that is making the school ask for the demapping today.

**Ben Stark** - After the sale of some development rights, there is an endowment now to complete this expensive (\$60,000) demapping exercise. Also, though no one is trying to take the title now, that may not be the case in the future. The church wants to improve the playground without the concern that title can be taken.

**Ryan Van Manen** - Asked if there is any interest by DOT to connect to 21st?

**Ben Stark** - There is no interest according to our investigation with Queens BP.

**Dominic Stiller** - Asked if the playground could be opened up to the community for use.

**Ben Stark** - That would be something we would have to discuss due to insurance liability issues.

**Stacey Eliuk** - If it is passed, can the property be used for other uses?

**Ben Stark** - It could only be used for open uses.

**Christina Chaise** - Commented that as an alumni, she supported the school opening the playground to the community.

**Debbie Riggus:** Thanked the board and community members for getting the renovated portion of Astoria park open. Asked what could be done about the trash along the sidewalks around construction sites.

**Chair Evie Hantzopoulos** - Chair Evie Hantzopoulos requested a call to 311 to create a paper trail for the city.

**Lisette Cologne** - Wants to know what is happening on Steinway Street with respect to commercial entities.

**Chair Evie Hantzopoulos** - Will put her in touch with the Steinway BID.

**Donald Cogdall Jr. Director of Justice at Hope Astoria Church** - Asking members to put pressure on City Planning to create real affordable housing in One LIC. Invited members and the community to their November Harvest fair.

As the founder of Astoria Parents Against Noise, asked why out of the 5,239 noise complaints to 311 the 114th precinct responded and observed no evidence of a violation at that time.

**Angel Hart, Long Island City Partnership** - Requested that the community participate in a Greening and Cleaning Survey; informed about a public meeting on November 5th for a mobility study at Queens Plaza and Jackson Avenue - public mee. So. Please come to the public meeting on November 5th over Zoom; open street on Vernon Boulevard on Halloween from 4 to 6.

**Jeannie Ortiz** - Requested the immediate return of the Q102 and reinstate several Q18 school bus stops along 29th Street and 30th Avenue going both ways; the top of the hill on 8th Street and 27th Avenue going both ways and 30th Avenue and 14th Street heading towards 4th Street. Also, the reinstatement of the Q19 bus stop on Astoria Blvd and 18th Street.

**Chair Evie Hantzopoulos** - The transportation committee will take note of that as part of the work they are doing with the MTA.
