Item #1 43-02 Ditmars Blvd Rezoning Informational Presentation

Proposed redevelopment of the LaGuardia Shopping Center site with an eight- and nine-story, 416,000 SF building that provides approx. 66,000 SF ground floor retail and approx. 480 apartments of which 120 units would be affordable under MIH Option 1.

Item #2 31-17 12th Street Rezoning Report for CB 1 Public Hearing

- 1. Application to rezone 11 properties from R5B to R6B located along the east side of 12th Street between 31st Avenue and 31st Drive in Astoria and
- 2. Amend Appendix F of the Zoning Resolution to map the project area as Mandatory Inclusionary Housing ("MIH") area subject to MIH Option 1.

If approved, the actions will facilitate development of a new, five-story Quality Housing building at 31-17 12th Street (Block 518, Lot 13) with 34 units, 9 of which will be affordable. The project area encompasses Block 518, Lots 6, 7, 8, 9, 10, 13, 16, 17, 18 and parts of Lots 5 and 19.
