NYC Department of Transportation (DOT) will make several presentations regarding:

20th Road Pedestrian Safety Improvements:

As a response to community requests to enhance pedestrian safety on 20th Road between 35th and 36th Streets, DOT is planning to present planned pedestrian safety improvements to address the lack of sidewalk on the south side of the block.

Queensboro Bridge Street Improvement Project:

To complement the planned opening of the South Outer Roadway on the Queensboro Bridge to pedestrians, DOT will be presenting plans to improve pedestrian access to the South Outer Roadway with a street improvement project on the Queens side of the Bridge.

Metropolitan Transit Authority will present:
