### CHAIRPERSON'S REPORT

Sadly, James Earl Jones passed away today. A letter of support was written for Alley Pond Park to receive state funding for updated trail maps. There will be a Zoning Committee meeting for a zoning change at the site of the Bayside Pool Club. The area is zoned R1-2 and they are proposing to build a 8-story apartment building. The Chair and District Manger met the President of the Windsor Park Co-op Board to review a proposed zoning height authorization for a new building. Mr. Marziliano will discuss the property on 33<sup>rd</sup> Avenue and 213<sup>th</sup> Street with the Dept. of Buildings. This month there will be a Landmarks Committee meeting. In October there will be a Capital and Expense Budget Committee meeting. There was a Public Hearing at Borough Hall regarding the City of Yes where Mr. DiBenedetto testified on behalf of the Board against the proposal. There will be an event on Saturday, September 14, 2024, hosted by Bayside Historical Society (BHS) to celebrate the 60<sup>th</sup> anniversary of BHS and 110<sup>th</sup> anniversary of Bayside Day.

# BOARD MEMBER NEW BUSINESS

Mr. Euler gave updates on the Board of Standards and Appeals open applications. Mr. Euler spoke regarding a traffic issue at a Fed Ex Company located at 192<sup>nd</sup> Street and Northern Blvd. Also, a supermarket that is now at the former site of the Walgreens on Northern Blvd. is creating traffic concerns with patrons exiting from the parking lot.

Mr. Hadjiconstantinou requested a DSNY representative speak at the October meeting regarding the new garbage bin procedures.

Ms. Burke spoke stating that illegal parking at 35th Avenue and Bell Blvd. continues. She believes there is poor communication between the Board and residents. She stated that she believes the staff should seek to hire an intern to help with social media. Ms. Burke gave suggestions to help with non-English speaking residents

Mr. Dadras spoke regarding a CAB meeting for the women's shelter on Northern Blvd that he attended. He said that everything seems to be running smoothly.
