COMMITTEE REPORTS

Ad-Hoc Zoning Committee – Michael Budabin, Committee Chair, stated there are three URULP applications to be voted on.

1) City-wide Hotel SP Text Amendment – ULURP #N 210406 ZRY – A proposed zoning change that would require the City Planning Commission's approval for new and enlarged hotels and motels, tourist cabins and boatels in commercial, mixed-use and paired M1/R districts. A motion was made to approve the application by Mr. Budabin. The motion was seconded by Mr. Popa. A roll call vote was taken resulting in 41 in favor. The motion carried.

2) Zoning for Accessibility Text Amendment – ULURP #N 210270 – Zoning for Accessibility (ZFA) seeks to make NYC's transit more accessible and better coordinated with the streets and buildings around it. Through ZFA, developers would work with the MTA to set aside space where needed for station elevators. It would expand incentives for developers to build elevators and related station upgrades in new, high-density buildings. A discussion ensued regarding the maintenance and security of the MTA elevators. A motion was made to approve the application by Mrs. Haider. The motion was seconded by Mr. Euler. A roll call vote was taken resulting in 39 in favor, 1 opposed and 1 abstention. The motion carried.

3) Health and Fitness Zoning Text Amendment – ULURP #N210382 ZRY – A proposal to amend the Zoning Resolution to modify regulations related to gyms, spas, licensed massage therapy, and other health and fitness facilities defined in the "Physical Culture of Health Establishments". The proposed text amendment will remove the requirement for such facilities to receive a special permit by the Board of Standards and Appeals (ZR-73-36). Mr. Solomon explained how this would impact large gyms in commercial districts. A lengthy discussion ensued that the community needs to voice their opinion regarding establishments in their area. The Board Members raised several concerns regarding illegal, stand-alone massage parlors. Mr. Solomon noted that massage therapy applies to licensed massage therapist. A motion was made to approve the application by Mr. Haber. The motion was seconded by Mr. Popa. A roll call vote was taken resulting in 4 in favor, 34 opposed and 2 abstentions. The motion was denied.

Transportation – Victor Dadras, Committee Chair, turned the floor over to Benjamin Turner who spoke regarding the proposed LGA Air Tran Connection. Mr. Turner said construction is estimated to begin next year. He stated this connection will be at the Willets Point station and can be accessed by taking the LIRR Port Washington Line and the 7 Flushing subway line. This will create additional ridership to an already crowd system. Impact studies and outreach to the adjacent communities were not adequately performed. This proposal also affects CB7. Mr. Turner made a motion for CB11 to submit a resolution (Mr. Turner read the resolution) requesting that a thorough study be performed; with results as to why this is a good option for the community. The motion was seconded by Mr. Popa. A roll call vote was taken resulting in 39 in favor, 1 opposed and 1 abstention. The motion carried.

Government Affairs/Legal – Albert Galatan, Committee Chair, spoke regarding New York State Assembly Bill 4854 and New York State Senate Bill 4547. He said that the Committee recommended forwarding a letter with concerns regarding the proposed bills. These bills mirror each other and will allow accessory dwelling units like a basement or garage to be use as rental units. Discussion ensued as to the concerns that would be addressed in the letter. A motion was made to approve forwarding a letter with concerns by Mr. Turner. The motion was seconded by Mr. Euler. The motion carried. A roll call vote was taken resulting in 41 in favor and 1 abstention. The motion carried.
