Norman Cohn spoke regarding the Mayor's decision in eliminating geographic lines for students applying to HS.

Janet McEneaney spoke regarding the proposed bike lane program. She was opposed to the suggestion of a bike lane on 33<sup>rd</sup> Avenue from Crocheron Park to Francis Lewis Blvd. Ms. McEneaney said that the Board must inform the community and allow for input. Mr. Budabin stated that there will be a third Transportation Committee meeting on this topic and a vote taken by the full Board at the January meeting.

# **CHAIRPERSON'S REPORT**

Mr. Budabin stated that there was a Transportation Committee meeting to discuss the proposed bike lane program. It was decided to have another meeting and then take a full Board vote at the January general meeting. This month's scheduled committee meetings are: Douglaston Zoning, Transportation and Library.

## **BOARD MEMBER NEW BUSINESS**

Mr. Euler gave an update regarding open Board of Standards and Appeals cases. Mr. Euler said that DSNY representatives did not confirm attendance for the scheduled Environmental Committee meeting, therefore, it was canceled. He stated that a Joint Park and Environmental Committee meeting will be scheduled to discuss street tree removal.

Mr. DiBenedetto stated that the Bayside Historical Society was asked to consult with the selection of artwork for PS 41. He said the artwork has been chosen. He also spoke regarding the comment made by Norman Cohn. He said that all City high schools are open to City students. The Mayor and/or DOE are proposing to remove the zoned school status. He explained the importance of zoned schools and requested an Education Committee meeting be scheduled to discuss. Budabin asked Mr. Chew to schedule an Education Committee meeting.

Ms. Burke stated that the website is missing the link to the May and September written minutes and the November committee meeting minutes are not posted. Ms. Martino discussed how the Board took a vote on posting the audio for general and committee meetings. The Board approved posting the audio for general meetings. Discussion ensued regarding community outreach under the City guidelines.

Mr. Galatan announced that he completed the NYC Marathon. He also spoke on the progress of the Vanderbilt Motor Parkway construction.

### **COMMITTEE REPORTS**

Transportation Committee – Victor Dadras, Committee Chair. Mr. Dadras spoke regarding the Transportation Committee report of November 22, 2021. He said the Committee voted to have another meeting to discuss the bike lane proposal and then bring it to the full Board at the January general meeting. He stated that there is a full, detailed report of the outline of the proposed bike lanes and asked that each member review for the January meeting. Mr. Dadras spoke regarding the 33<sup>rd</sup> Avenue proposed location that Ms. McEneaney spoke of. He said that 33<sup>rd</sup> Avenue was suggested as a potential alternative to 35<sup>th</sup> Avenue. Mr. Dadras said that input is recommended, and safety is the main concern. Mr. DiBenedetto said that the proposed lanes should be visited in order to make the right decision.
