#### **COMMITTEE REPORTS**

# Joint Health & Human Services and Education Committee – Eileen Miller, Health & Human Services Committee Chair and Justin Chew, Education Committee Chair

Mr. Chew stated that there was a joint meeting to discuss Covid-19 guidelines in public schools. He said present at the meeting were outgoing Principal of Bayside High School, Michael Athy, who introduced the incoming Principal, Tracy Martinez. Ms. Martinez spoke regarding her plans for the incoming months. Also, at the meeting was, Peter Georgatos, Assistant Principal, Benjamin Cardozo High School. Mr. Georgatos spoke about a mural project at Benjamin Cardozo High School. Mr. Chew said that there will be 20 murals that will be painted outside and inside the school. Mrs. Miller spoke regarding Covid-19 related testing and in-home testing. Mr. Chew asked Mr. Galatan to speak on the topic of removal of impartial hearings regarding special needs students who have individual education placement (IEP). Mr. Galatan stated that there were two bills being proposed: Assembly Bill 7943 and Senate Bill 7189. He stated that the process currently in place is if a parent does not agree with the plan for their child, it goes to an impartial hearing and a hearing officer is assigned to the case. There are over 60 hearing officers in New York City and most have over 40 years of experience. The proposed bills recommend this process be executed under the auspices of the Office of Administrative Trials and Hearing (OATH). Mr. Galatan said that the judges are less experienced in this matter. This causes great concern and could be a costly process. If a parent/guardian cannot make payment, they lose by default. Mr. Galatan made a motion to forward a letter to NYC elected officials in opposition to the rule change/executive order transferring special education hearings to OATH and to keep the current process in place. The motion was seconded by Mr. Euler. Mr. Dadras asked why would one vote against these proposed bills? Mr. Galatan said that he feels OATH will vote against parents' requests to save City tax dollars. Mr. Galatan said that parents can represent themselves if they do not have the means to pay for representation at OATH. He added that it is very difficult and stressful to represent your own child for services. Mr. Marziliano stated that he was informed by State Senator Liu's office that these bills were not moving because these they were passed at the local level by an executive order by the Mayor before he left office. Mr. Budabin stated that the CB11 letter should also include that a representative come before the Board. A roll call vote was taken resulting in 35 in favor, 4 abstentions and 1 present. The motion carried.

# Government Affairs and Legal – Albert Galatan, Committee Chair – Accessory Dwelling Units (ADU's)Bills at the State Legislature

Mr. Galatan said that the Committee discussed the pending bills regarding ADU's and Transit-Oriented Development (TOD's) as outlined in the committee report of February 2, 2022. Mr. Galatan introduced Paul Graziano, Urban Planner, who gave a presentation at the committee meeting of January 22, 2022. Mr. Graziano gave current updates that have taken place since the last committee meeting. He said that the Governor inserted the ADU bill and the TOC bill into her budget. This means that if the bills are not removed by February 17, 2022, they will remain and be voted up or down with the budget bill. ADU's means all single-family homes can have a minimum of one ADU on their property. TOC's means that any community that is within a half mile radius of a rail station must allow for a 25-unit dwelling minimum, per acre of land. These Mr. Euler said this is very unfair and goes against home rule. Mr. are two separate bills. DiBenedetto said each community should have local control. Mr. Euler made a motion to forward a resolution to remove these two items from the budget bill. The motion was seconded by Mario Ferazzoli. A correction and addition were made to the resolution by Mrs. Garippa and Mr. Graziano. Discussion ensued as to the negative impact this would have on the City and State of NY. Mrs. Miller stated that the Bayside Hills Civic Association is opposed to these two bills. Mr. Turner said that there is a housing shortage, and he understands that this would be market value which does not help. He recognized that something must be done to help the housing shortage. Discussion ensued how this does not help affordable housing, how property values will increase, and basement apartments are not safe. Mr. Budabin said the housing crisis is understated and this will not solve the major problem but may create new problems. Mrs. Garippa said that the Board has been up-zoning areas and that this is how it should be done, not blanket zoning. Mrs. Guidice spoke regarding the stress on communities with the increased population. Mr. Marziliano stated that this concern was addressed in the resolution. A roll call vote was taken resulting in 33 in favor, 3 opposed and 2 abstained, 2 present. The motion carried.
