CHAIRPERSON'S REPORT

Mr. Budabin announced the Committee meetings that were held in the month of February. The Governor's emergency order that suspended open meetings law is due to expire March 16, 2022. We should expect April's meeting to be in person, unless the Governor extends the emergency order. Mr. Budabin stated that a grant was given for the wetlands at the entrance of Udall Cove. He read an article on this topic from Save the Sound. A grant was received in the amount of \$600,000 to restore and protect the wetland, natural habitat, and the shoreline at the entrance of Udall's Cove and along Memorial Field.

PUBLIC HEARING

Co-naming of 217th Street and Corbett Road to "BIG JIM" Corcoran Way. Victor Dadras, Transportation Committee Chair said the Committee held a meeting to discuss the request to coname 217th Street and Corbett Road to "BIG JIM" Corcoran way. Mr. Corcoran was a long-time resident of Corbett Road. His family submitted a letter of support. The Committee voted unanimously in favor. A motion was made to approve this request by Mr. Dadras. The motion was seconded by Mr. Popa. There was no discussion on the motion. A roll call vote was taken resulting in 37 in favor and 1 opposed. The motion carried.

BOARD MEMBER NEW BUSINESS

Mr. Euler gave an update regarding the BSA application for 15 Stuart Lane. He advised the application was approved. He said BSA applications for three gas stations were adjourned: 218-01 Northern Blvd, 204-12 Northern Blvd. and 35-04 Bell Blvd.

Mr. DiBenedetto stated that Bayside Historical Society has an opening for a part-time bookkeeper. Information can be obtained at their office.

Mr. Galatan said that there will be a 5K marathon on April 21, 2022, at Alley Pond Park. Information can be obtained on the Alley Pond Park website.

Mr. Montgomery spoke about a "Get out of Covid" music event at the Catherine Turner Richardson's Park on April 23, 2022. Also, there will be another recycling event, date to be announced.

COMMITTEE REPORTS

Joint Environmental and Parks Committee – Henry Euler, Environmental Committee Chair and Paul DiBenedetto, Parks Committee Chair

Mr. Euler stated that Queens Forestry was present at the Committee meeting to discuss tree issues. Also, present was the Department of Environmental Protection (DEP) who presented the design and reconstruction of the Little Neck Pump Station on 40th Avenue between 247th and 248th Streets. This station takes in all the wastewater from the surrounding area, about 150 acres. The water is then pumped to treatment centers so that it can be released safely. The current station is below grade. The area currently floods due to poor grading. This proposal will upgrade the station. It will be a one-story building that will blend into the community. The project will begin October 2023 and continue through March 2026. The Committee asked DEP if they could present to local civics. The Committee voted to forward a letter of support. Joan Garippa opposed stating that the building would be too high (20 ft.) and the run-off from the building roof would cause flooding. Majority of the Committee voted in favor. A motion was made by Mr. Euler to approve the design proposal with a condition that DEP meet with the community to discuss the design, answer questions, and problem solve. The motion was seconded by Mr. DiBenedetto. Discussion on the motion ensued. Alicia West, representing DEP, was present to answer any questions. Mr. Lander stated that the improvements would enhance the community and Udall's Cove. He stated that there is debris that collects at the station. Ms. West said this is an unmanned facility. If there is debris at the station, it best to call 311 for cleaning. Ms. West addressed Mrs. Garippa's concern regarding the height of the building. Ms. West said the electric pumps will be above grade and the station is 18.6 ft. high. The storm water run-off will be managed onsite. Mr. Euler asked if DEP would meet with the local civics, Little Neck Pines, Udall's Cove and Westmoreland. Ms. West agreed. Mr. DiBenedetto said that this structure is lower than a R2A dwelling. Ms. James stated that the design must be above grade to accommodate the electrical pumps. She agreed with the design and the height. A roll call vote was taken resulting in 36 in favor, 1 opposed and 2 abstentions. The motion carried.

Christine Haider was nominated for 2nd Vice Chair by Eileen Miller. The motion was seconded by Christina Scherer. Mrs. Haider accepted the nomination.

Benjamin Turner was nominated for 2nd Vice Chair by John Kelly. The motion was seconded by Stephan Popa. Mr. Turner accepted the nomination.
