- TMBNY 212-03 48<sup>th</sup> Avenue was approved for a Wine, Beer and Cider License with the hours of operation from 10:00 AM to 10:00 PM daily (closed Tuesday). There is no outside dining.
- 2) 4017 Burgers 40-17 Bell Blvd. was approved for an On-Premises Liquor License with the hours of operation from 11:00 AM to 2:00 AM daily. The Committee added two conditions; that the rear outside patio dining area be closed at 11:00 PM and the C of O to include backyard patio dining. There will be no live music.
- 3) Co Hen Kitchen 194-15 Northern Blvd. was approved for a Wine, Beer and Cider License with the hours of operation from 11:00 AM to 12:00 AM daily. There will be no outside dining and no live music.
