**Hollis LIRR Station** 

Beginning Monday, March 24, the LIRR contractor will move in heavy construction. Demolition of the existing platforms and other related work.

The first two weeks will be spent working on the eastbound platform, followed by three weeks on the westbound platform.

- When working on the eastbound platform, there will be no train service in that direction from approximately 10:00 am to 3:00 pm, Monday thru Friday.
- When service outage is on the westbound track, there will be no service in that direction, it will begin and end approximately 9:30 am to 2:30 pm., Monday thru Friday.
- They are working on a messaging campaign onboard trains and at stations in the area to advertise the changes.

• Flyers will be going to local business and residents around the station property.
