- Stephen Everett, NY City Planning will discuss the MTA and DCP are proposing a citywide zoning text amendment, ULURP N210270ZRY that will allow the MTA to work more efficiently with private developers to help achieve systemwide accessibility. The proposal includes a system-wide transit easement certification and an authorization for transit improvement bonuses in high density areas to facilitate the implementation of ADA access at stations throughout the city more quickly and efficiently.
