#### Michael Butler, Novocognia, Inc.

- Represent a newly formed non-profit organization called Novocognia, Inc.; they began last year, and have been quietly working with the Community Board members (Dora Griszell).
- Recently began corresponding with Rene Hill and Ms. Reddick to address the health concerns
  of the African American Community, specifically for kidney disease. There is a great need for
  education and engagement. Because of the Covid crisis this year, they had to cancel a lot of
  events that were planned, scheduled, and ready to go.
- They were scheduled to be in the Community Board 12 area in March to highlight World Kidney Day
- Involved with the National Kidney Foundation, earlier this year he was chosen to go through a 40 hour intensive training to get certified as a Self-Care Manager for a program they are envisioning in the near future.
- There is a high rate of diabetes, high pretension, and these numbers in time translate to kidney patients; we would like to put an end to this. The best way to do that is to educate everyone about the associations of these statues of diabetes, uncontrolled diabetes, uncontrolled high pretension, and other issues that can lead to kidney failure.

#### Yvonne Reddick, District Manager

- All of the agencies will be cut according to Mayor DE Blasio, but in the district 12, I was
  informed by Sanitation that the cuts will be include recycling and the litter baskets. One of
  the main things not being affected by the cut is garbage collection. Please call your
  Councilman to let them know that the Community does not want Sanitation cut.
- Community Board 12 district is the second largest board in Queens County, the second largest in the City; and with all the new developments going on, the Board cannot deal with the cuts.

#### Ilsa?????

- Everyone should have received from either the Board office or the Chairperson a proposed Resolution in regards to Inquiring into Information Used by the Office of Labor Relations when negotiating a new Union Contract with the Police Union.
- I am asking that the Board pass this Resolution, what it does is it just starts the formal process inquiring into the Office of Labor Relations. The goal of the whole effort is to begin to foster more transparency into how the police department does its business such as union contracts, collective bargaining agreements which in many ways serve to create and/or perpetuate some of the conduct within the police department.
- The end goal of the inquiry is to get to a point where the City produces a police department report card from period to period.

### Michele Keller, 1st Vice Chair

- In response to the Resolution, I do not know if there is a deadline, but Mr. Ilsa is asking that the Board vote on the Resolution before the contract goes in. Sometimes each contract can go on for many years, because the union sit back and wait for other unions to get it.
- When Mr. Ilsa and I spoke he was speaking about the department report card. Spoke with former colleagues who are veterans with NYPD and still active in various ranks, there are similar proposals be put out now; I agree with some of the board Members to vote on the Resolution

tonight without having a clarity would be a mistake. I would like to discuss this Resolution with people that she respects; maybe the board can have another meeting in about a week or two to vote on the Resolution.
