- > CM Brooks-Powers calls in to respond to the Parks Chair comments:
 - o A Dog Run costs more than the \$1M presently in the budget.
 - o There can be no Capital investment until it is fully funded.
 - There are other requests for Brookville Park like a comfort station which costs at least \$6M.
 - There was more opposition than support for the Dog Run at the two locations proposed.
 - Speaking with CM Williams about a site in Roy Wilkens Park.
