Meeting called to order at 7:30 PM.

The Chair called for a "Moment of Silence" to remember the victims of the shooting in Nashville, Tennessee.

The Chair acknowledges the myriad of religious holidays taking place: Ramadan; Festival of Colors; Passover; Holy Week and Easter.

Queens Borough President Donovan Richards:

- > This has been a good year for Queens.
- > A banner year for community board member applications.
- > His office has spent \$130M for capital projects.
- > \$75M has been allocated to Queens this fiscal year:
 - Focus on education.
 - Public schools vs charter schools.
 - \$22M has been spent on schools the past 2 years.
- > Health Care Sloane Kettering is going into Jamaica Hospital
 - BP putting \$20M into hospitals to expand the number of beds.
- Crime Queens numbers down the past 2 years.
- > Unemployment down from 27% to 4.9%.
- > \$15B of private investment in JFK Airport:
 - Up to 10K new jobs.
 - MWBE numbers have been good.
- > Roy Wilkens Park getting \$147M in investments.
- > 116 Precinct progressing on budget and on time.
- > Hosting meetings with Queens Public Library System and DDC on libraries
- Plans to visit high schools:
 - Despite disinvestment in schools, principals are doing amazing things.
- > Questions where the money from "gambling" is being allocated:
 - BP has a vote on any gaming licenses
- BP has no position on Creedmoor:
 - Wants community input.
 - Does NOT support shelter(s) at this location.
- > BP supports legalizing basement apartments:
 - Must be up to code.
 - Reasonable timeframes for compliance.
 - Basements are already being rented.
 - Wants financial support from both the federal government and the state.
 - Does NOT support ADUs (accessory dwelling units).
 - Will NOT support any plan to reduce residential zoning.
 - However, there may be places in Queens where it could work.
 - Governor Hochul's Plan (Housing Compact) falls short because there was no engagement for community input.
 - However, there are 80K people who are homeless.
- > BP funds both Charter and public schools
 - Co-location absolutely takes away from public schools.
 - Big Charter Schools need to purchase their own buildings.
 - Enrollment is down in both public and Charter schools.
 - Supports "choice" for parents.
