- > Thanks community board members for their service.
- > Remarks on the Rite Aid site in Cambria Heights:
 - He had a direct conversation with Mayor Adams who stated this will <u>not</u> become a homeless shelter.

- He is working directly with the other elected officials in the area to address and monitor this situation.
- The mayor will come and state this directly to the Cambria Heights Civic Association.
- > The Board Chair thanks Congressman Meeks for coming to the meeting.
 - Chair Block will inform the community when the mayor is attending a meeting in the rea.

Nomination Committee

The Chair states this is the time when a nomination committee is organized to create a slate for the Executive Committee elections in June.

The Chair nominate BM Corey Bearak. He accepts. BM Bearak nominates BM Bess DeBetham. She accepts. BM DeBetham nominates BM Sophia Mighty. She accepts. BM Mighty nominates BM Robert Glover. He accepts. BM Glover nominated BM Delroy Dawkins. He accepts. BM Dawkins nominates BM Charles Farruggia. He accepts. BM Farruggia nominates BM Barbara Clements. She accepts.

Chair Block states having requisite number of committee members, he nominates BM Bearak to Chair this committee. He accepts.

Committee Reports

Public Safety Committee – Committee Chair Michael O'Keeffe:

- Expressed condolences to members of the 105 Precinct on the killing of P.O. Jonathan Diller.
- > Spoke about the 105 Precinct Council Meeting:
 - The issues of illegal smoke shops and squatters were discussed.
 - Collective City Clergy Preventing Gun Violence presented and would be attending the May PSC meeting.
 - A new policy of e-commerce exchanges being done in front of all police precincts.

Seniors & Special Needs Committee – Committee Chair Kangela Moore:

- Dr. Carol Grant spoke about her Op-ed which advocated the need for more senior housing in NYC.
- BM Lorraine Gittens-Bridges spoke about education for special needs children and the creation of a new advocacy group (NYCCSEPTSA) using the model of parent and community leadership structures that already exist in this space.

Transportation Committee – Committee Chair Moh Ishmael:

- > Open Plans Group gave a presentation on "Daylighting:"
 - NYS law NYC is not up to date on compliance with the law.
 - A Resolution will be drafted and reviewed at the next committee meeting before being brought to the full board.

- > The outdoor dining process has now been implemented by DOT.
 - It goes from April through November.
 - There can be sidewalk tables year-round if they meet the regulations.
- DOT now has lockers where people can receive packages (a response to porch pirates).
- > New parking meters are being rolled out the first batch in Manhattan.

Youth, Education & Libraries Committee – Committee Vice Chair Lorraine Gittens-Bridges:

- There were three speakers
 - "Empower My 'Hood" presentation by BM Bobbi Cole on the organization she runs getting young people into college.
 - Vanessa Sparks spoke in detail on the college financial aid process.
 - Trina Mitchell, CEC for District 29, spoke about her 3 children who are at different points in the education process.

Public Speaking

- > BM David Pecoraro welcomes new board members.
- Dwayne Moore has concerns about the proposal to lower the speed limits for motor vehicles in NYC; he states there are already too many fines. He expresses that the roads should be fixed.
- Harry Lature questions whether ADUs (accessory dwelling units) are being made legal?
- Arecelia Cook she serves on cb12 and sees the need to collaborate on the shelter issue.
- Jax Dolly does not express positive feelings about the local elected officials and the community board. She thinks there is a better way to communicate with the community.
- > BM Sylvia Cothia requests information on the MTA Bus Redesign.
- Juanita attended the Bus Redesign meeting and had concerns about the Q4 bus.
- BM Jackie Wilson states the Laurelton Memorial Day Parade will begin at 9:00 am on Memorial Day at Merrick and Francis Lewis Boulevards.
- BM Marcia O'Brien states the Rosedale Memorial Day Parade will start after the finish of the Laurelton Parade on 243 Street & Mayda Road.
