## **UPDATES FROM NYPD/ ELECTED OFFICIALS:**

# 100th Precinct - Lieutenant Powel

Major Crime is Down. Crime has decreased by approximately 40% over the past 28 days.

#### 101st Precinct – Lieutenant O'Shea

further improvements.

Crime is down 17% for the last month and year-to-date down 5%. Year to date we have made 54 arrests involving firearms. Our rookies are focusing on Mott Avenue and near the schools.

**Legislative & Community Engagement** – Actively visiting community boards during the legislative break from Albany. Francesco's Law was passed in the Assembly to strengthen firearm storage requirements. It's pending Senate approval. Ongoing efforts to improve bank access in underserved communities. Recently met with Chase Bank and Ponce Bank to encourage local investment. **NYCHA & Housing Advocacy** – Hosted NYCHA CEO Lisa Bova-Hiatt for a tour of developments to address mold and infrastructure issues. Plans to revisit Redfern and Ocean Bay developments for

**Budget Wins for the Rockaways** – \$3 million in capital funding secured for Nordeck Mitchal Lama Coop. Funding secured to complete Arverne Playground on Beach 54th Street. In partnership with AM Pheffer Amato \$350,000+ for local schools, such as Channel View School for Research, Challenge Charter School and Peninsula Preparatory Charter School. In partnership with Senator Sanders and Councilwoman Brooks-Powers \$300,000 for YMCA upgrades, including HVAC improvements and expanded swimming programs.

**HEAP Program** may face significant cuts this fiscal year.

**Federal Benefits Payment Change** – Paper Checks Ending: By September 30, 2025 must switch to direct deposit via GoDirect.gov or call 1-800-967-6857.

**Education & Student Loan Updates** o FAFSA Launch: The 2025–2026 FAFSA opens on October 1, 2025. New Rule: Small businesses (≤100 full-time employees) will have those assets excluded from aid calculations. Income-Based Repayment: borrowers no longer need to prove financial hardship to enroll through June 30, 2026. To qualify, loans must be received before July 1, 2026.

**Statewide Rebate Checks** will be mailed to New York residents between mid-October and early November.

**9/11 Moment of Silence Law** passed in 2019 by Assemblywoman Pheffer Amato and Senator Addabbo. All public schools must observe a moment of silence and reflection on September 11<sup>th</sup>. Aimed at helping students understand and honor the significance of the day, especially since none were alive during the attacks.

# <u>Chairperson's Report – Dolores Orr</u>

#### Beach & Parks Update:

- Summer Debrief Pending: Parks Department will later report on beach attendance and
- lifeguard staffing.
- Edgemere Beach Reopening Milestone: For the first time in 25–30 years, beaches between 43rd and 47th Streets reopened after piping plover chicks fledged. Lifeguards were relocated from other beaches to support the reopening.
- The Chair and District Manager will be attending the upcoming Parks Budget Meeting which is scheduled later this month to discuss agency needs and community priorities. Updates will be shared in October.
- USACE will resume resilience work. Staging area is Beach 116th Street and 19th Street.

**Neponsit Senior Day Program** on Beach 101 Street is closing on September 19<sup>th</sup>. It was the last medical-model senior center in Queens. Despite strong advocacy, the closure is confirmed, leaving many heartbroken.

# **JFK Airport Committee**

- Ongoing efforts to address airplane noise over Broad Channel and Rockaway.
- Port Authority has hired a firm to conduct virtual noise monitoring. Residents experiencing frequent plane noise are encouraged to contact Community Board 14 to suggest monitoring locations.
- After 10 years of advocacy, officials are now reviewing runway usage and noise distribution.

## 9/11 Tribute Ceremony

- September 11 at 8:25 AM at Tribute Park (Beach Channel Drive & 116th St.)
- Honors the 78 Rockaway residents who died in the attacks.
- No speeches—only the names of the victims are read aloud.

#### District Manager's Report - Felicia Johnson

#### Community Board Updates o New Branding & Outreach:

- Introducing a new logo and table setup.
- Now active on Facebook, Instagram, and YouTube.
- Monthly board meetings will be live streamed for broader public access.
- Meeting Accessibility, exploring rotating meeting locations to better serve residents across all neighborhoods.

# **Sanitation & Maintenance**

- Ongoing issues with sanitation staffing shortages.
- City is using weed-spraying methods in medians and roadways due to lack of manpower. Awaiting results to see if the new spray is effective, as previous chemicals were banned.

#### Correspondence

- Supported real property tax exemption for affordable housing at 2932 Beach Channel Drive to help keep units accessible.
- Letter to Parks Dep. requesting an 8-foot fence for Arverne Playground redesign.
- Parks responded, only a 4-foot fence will be approved under new design standards.
- Hammels Houses Community Center:
  - o Center remains closed due to poor post-Sandy repairs and lack of funding. A letter was sent in conjunction with elected officials to take action and reopen the facility.
  - o The center was also a polling site, and its closure affects senior voters.

# **Transportation & Safety**

- Speed Reducer Installation: Coming to Healy Ave. between Bay 25<sup>th</sup> St. and Bay Park Place.
- Beach 39<sup>th</sup> St. Conversion: After a request from CB14Q DOT is now converting it to a one-way northbound.
- Raised Crosswalk Project: Planned for Beach 40<sup>th</sup> St. and Beach Channel Drive in 2026 to improve pedestrian safety.

# Open Streets Program:

- Applications for Open Streets are now online.
- Two current Open Streets will run through December 28th.
- Info will be posted on the Community Board's Facebook page.

# **Community Resource Guide**

- Created by summer youth workers; nearly ready for release.
- Will be available as a PDF download from the Board's website.
- Religious and civic organizations are encouraged to submit current info (must be registered entities like 501(c)(3) or LLC).

## **Disaster Preparedness & CERT Training**

- OEM canceled their scheduled presentation; signage and evacuation plan is still pending.
- Efforts underway to bring CERT (Community Emergency Response Team) training to the peninsula.
  - o Need 30 participants to host local training; only 13 signed up so far.
  - o Strong push for residents, especially in apartment complexes to enroll.

# **Parks Department Policy** Changes

- Mobile Stages: Only available for events organized by government agencies or elected officials;
  must reimburse Parks \$721.
- Inflatables: Approved only for Parks-managed events with 500+ attendees; water-based inflatables will no longer be permitted.

# **Bus Redesign & Performance**

- DOT released bus performance grades:
- Most local lines received C or D ratings
- Only the Q35 received an A
- A link to the full report will be posted online.

# FIFA World Cup 2026 Planning

- NYC and NJ are host cities; Queens is joining planning discussions.
- Community Board is advocating for Rockaway's inclusion in promotional efforts.
- Ideas include beach marketing, restaurant decals, and local branding.

# Capital and Expense Budget Requests – FY 2027

Committee Meeting Date: 8/11/2025

• Felicia Johnson provided an explanation of the Community Board Budget Process:

- Due to changes in the city's submission platform, capital and expense items must now be entered separately.
- o Previously, they were combined; now they must be clearly distinguished.
  - Capital vs. Expense Requests: Capital Requests: Brick-and-mortar projects (e.g., buildings, infrastructure). Expense Requests: Items requiring studies or planning before funding (e.g., storm sewers) are considered the "wish list" and can't become capital until studies are completed and funded.
- Budget Prioritization, Board Members review and rank the draft items for capital and expense categories.
- A third category, continued support, tracks ongoing funding needs.
- The Board requested changes which are reflected in the attached DRAFT FY 2027 Register of Capital & Expense Budget Requests (attached). At the October 14<sup>th</sup> Board Meeting. CB 14Q will host a Public Hearing on the Budget and take a vote on the Final Budget Request at the October 14<sup>th</sup> Board Meeting.
