#### 1:37:06 BSA Application for 58-02 Northern Boulevard

Sandy Anagnostou, Caliendo Architects representing the applicant provided the following update:

- Introduced Damian Corbett, General Sales Manager, Lincoln Auto Group.
- This is a variance application pursuant to §72-21ZR NYC Zoning Resolution.
- The proposed variance which would permit the development of a new two-story automobile showroom with accessory offices (use group 9) at the subject site.
- It is located in R5 residential zoning district where commercial use is not permitted as of right.
- It has frontage on three streets, Northern Boulevard, 58th Street and 60th Street, formerly an eating and drinking establishment that has been empty for decades.
- It is on the south side of Northern Boulevard.
- They are proposing a two-story and cellar commercial automobile dealership that will be Lincoln Motor Group and the cellar will be for accessory storage.
- The first floor will be an automobile showroom. The upper floor will be for accessory sales offices.
- Met with the Land Use Committee of Community Board 2 and they made some recommendations such as two publicly accessible charging stations (58<sup>th</sup> and 60<sup>th</sup> Street) as well as landscaping in planters.
- There is no used car, auto sales and there's no repair work done on the premises.
- No maintenance of the automobiles is done at the premises. It's a boutique retail type of automobile showroom.
- This is a minority owned business and one of the partners in the business is a retired, NBA player, John Starks, and they would be hiring locally. If approved it would create approximately 15 jobs, union jobs.

- The applicant is JPB Realty Co.
- Applicant is seeking to purchase the adjoining property, which is city-owned.
- The application is to demap the property and then to purchase it from the city.
- It is zoned M2-1, a manufacturing district and also is within an IBZ.
- Proposing the elimination discontinuance and closing of a mapped but not utilized area adjacent to the Queens Midtown Expressway on-ramp.
- Proposed development: an outdoor eating, drinking and seating area.
- The first floor is 10,000 square feet plus or minus warehousing food preparation and delivery. On the second floor, it's 4,000 square feet. It's used for offices, jpbs offices and on the southern part of the site, there's a one-story building, one-story Warehouse, which also currently is used with food for food, prep and delivery.
- The property they are looking to acquire from the city is not going to be built upon.
- It will be an open area and would be an outdoor eating and drinking space, as in conjunction with that, they would convert part of their property.

Given the lack of publicly owned land as well as the lack of green space in the surrounding area, there was concern that future disposition of the lot after depmapping would not be in the public interest. The Land Use and Housing Committee voted to disapprove the application.
