**0:11:19** Anatole Ashraf welcomed everyone to the meeting and provided housekeeping rules and reminded everyone their vote is their opinion. He requested everyone follow the WAIT Rule, (Why Am I Talking).

#### 0:11:34 Pledge of Allegiance

0:12:06 Evelyn Li, Representing Congresswoman Grace Meng provided the following update:

- Reported we are still in a government shutdown, but their office is still open.
- If anyone needs assistance regarding their benefits, contact their office.
- Announced the Congresswoman will keep fighting and will try to pass a spending bill that protects healthcare for hardworking families.
- Announced a recycling event, on October 18, 2025, in LIC and another one on October 23, 2025, in Forest Hills for electronics and textile recycling.
- Announced the Congressional App Challenge will take place on October 30, 2025.
- Reported that their office keeps track of how many federal agencies have stopped responding to their office because of the furlough. She reported that ICE is a big problem in our district, and they have stopped responding to their office. Their office received confirmation, including the IRS and SSA, which are still working but they are being a little bit cautious.

- She reported they do have delays in their congressional increase, and they do have delays in how they are processing cases. They are still navigating how to work with them during the shutdown.

### **0:20:12 Tiffany Echevaria, Representing Congresswoman Nydia Valazquez** provided the following update:

- Echoed much of what Evelyn Li reported.
- They are on day 9 of the federal shutdown. It stems from a fight over health care funding, basically from the Affordable Care Act.
- If anyone needs help, please reach out to the Congresswoman's Office.
- They will continue working without pay until the shutdown ends.
- All federal agencies will be going at a significantly lower pace and keep in mind that if
  you are trying to do any new case work applications that all agencies will be significantly
  slower.
- Announced the Congressional App challenge will take place on October 30, 2025.
- Received word that the ICE offices are moving at a very significant slower pace. They
  are closed. This means that all their fieldwork is still happening. As a Congressional
  office they can't really advocate for those that are being detained because the liaison
  offices are closed.

### **0:25:54 Mercedes Jennings, representing NY State Senator Michael Gianaris** provided the following update:

- Announced that State Senator Gianaris and Senator Kristen Gonzales presented a
  proclamation to Sheila Lewandowski on September 30, 2025, for her amazing work at
  the Chocolate Factory.
- Announced the Inflation Refund Checks have started being mailed and should be received no later than mid-November.
- Reported there is a scam happening with these checks. The checks will be sent out by mail and will not be directly deposited. There will be no emails, phone calls or correspondence about it. If anyone tries to call, or email or ask for your personal information, do not provide any information. Contact the Senator's office.
- Announced their office has officially moved to:

- Provided an update about a possible Con Ed Scam. If anyone has an issue to reach out to their office.
- Thanked the CB 2 Transportation Committee for welcoming her.

- Announced their office has been tracking the Queens Bus Network Redesign as there
  have been a lot of concerns and issues with some of the stops. If anyone has any issues
  to reach out to their office.
- Reported there have been complaints about the OMNY Card and the way it is operating, especially for seniors. If anyone has any issues reach out to their office
- There will be no more metro cards after December 31, 2025, they will be retiring.
- Q&A

Reilly Owens announced transfers are still in effect. OMNY is supposed to cover transfers, it is not the fare capping which is a good program. Free transfers should still be happening. He spoke with someone from the MTA about it and their response was that OMNY does not tell you at the tap that is a transfer and that you should check your online trip history to see if you did get a free transfer, which is not the easiest way for people, especially people who are not online.

Reilly Owens stated that people should not be double charged and anyone who is experiencing this to contact the Board office or the State Senator's Office.

- A board member reported that over the past weekend that the system had shut down so that you could not load or buy a card from the machines. People could have easily been trapped in the borough instead of being able to navigate. They also shut down in terms of getting cards in bulk, which is a problem for non-profit organizations who give the cards out to their clients.
- When you use the OMNY machine, the default setting, the amounts they give are not divisible by \$2.90, the cost of a far. The board member stated she bought a card for \$34.00 but should have actually paid 34.80 to get that 7-day cap.
- It is not user friendly, and they should not have shut down some of the perks that were received with MetroCard.
- A board member discussed that student's cards do not work and are flimsy, students are hopping turn styles.
- There is a backlog at the schools as they have run out of cards, and this is a citywide issue.
- A recommendation was to give them a monthly option as it is not affordable.
- A request was made to go back to MetroCard and cancel OMNY.

### **0:40:30 Carlos Hernandez, Representing New York State Assembly Member Steven Raga** provided the following update:

- The Assembly Member secured \$110 million for Mitchell Llama capital improvement funding.
- \$30 million for NYC Mitchell Llamas. They were able to secure universal school meals throughout the state, and they also co-sponsored Bill Number A6955 which would place limitations on lithium-ion battery energy storage specifically restrictions on residential and commercial areas, and stronger community engagement requirements.

- Their office has partnered with ACE for the cleaning of areas around the district and they happen quarterly. If anyone has any location, to reach out to their office.
   Reported that they passed a bill that would require the Department of State to submit their universal periodic review to the United Nations Human Rights Council. The Bill number is 9068.
- The FOIL bill which is 3425 has passed onto the Governor's desk for her to sign or veto.
- Their office hosts a monthly 2-hour mobile office session.
- Reported the Assembly Member's Office has moved to the Big Six Towers at 60-10
   Queens Boulevard, lower level, Woodside, NY.

# **0:45:24 Simon, Representing New York State Assembly Member Claire Valdez** provided the following update:

- Reported that two weeks ago, their office co-hosted with Borough President Donovan Richards a celebration of 215 years of Mexican Independence at Queensborough Hall. The Assembly Member is the first elected Mexican American representative in the history of the state legislature.
- The Assembly Member joined a rally held by the Living Wage for All Coalition in advocating for a \$30 minimum wage and an end to the sub-minimum wage for tipped workers, disabled workers and incarcerated workers.
- Their office attended a tree planning event and the opening of the first portion of the Blissville bikeway in Blissville.
- Reported the DEC fined Green Asphalt \$25,000 for the conditions that their plant is causing.
- Their office was pleased to see their order requiring Green Asphalt to double the height of their existing smokestack by December 11, 2025. They have recently signed a letter along with other local elected officials calling on the DOT to end their relationship with Green Asphalt if that is not complied with by the date they are supposed to.
- Wished everyone a Happy Biketober and to look out for Biketober events in Sunnyside and Long Island City on the 17<sup>th</sup> and bike giveaway at PS 12 on the 14<sup>th</sup>.
- Announced along with Assembly Member Raga, Assembly Member Valdez was arrested along with 10 other city and state elected representatives at 26 Federal Plaza in protest of the sites use as a makeshift detention center and ICE's refusal to allow elected officials to inspect the premises. The assembly Member is deeply committed to using her platform to advocate.

#### **1:54:10** Richard Lobel, Sheldon Lobel provided the following update:

- Introduced his colleague Fayanne Batan.
- The location is between 63<sup>rd</sup> and 64<sup>th</sup> Street and Broadway
- Attended the Land Use Committee on October 15, 2025 and received approval from the Committee.
- The applicant is Broadwood Realty LLC.
- This is for a zoning change along Broadway. The zoning along Broadway in this area is R5 with a C2-2 overlay. The result of that zoning is what you would get on an 11,000 square foot lot, a one-story taxpayer lot, 7,000 square feet, there are some businesses located there.
- When they approached City Planning the idea was that they would be able to come in
  with the rezoning that would allow for a mixed-use building to create some residential
  units, including affordability, as well as a ground floor with commercial and update the
  property.
- The building was built in 1931 and is old with outdated commercial space. This would allow them to update the commercial space and add a little bit of commercial space which is nicely utilized in that area and to build residential above. The result would be a proposed mixed-use building, ground floor, about 9,000 square feet of commercial use, with roughly 46,000 square feet of residential use above. There would be roughly 67 units and about a third or 22 units would be affordable pursuant to MIH.

- Reported the Land Use and Housing Committee recommendation was to approve the application for rezoning at 63-12 Broadway with the following conditions:
- The Inclusion of MIH Options 1, 2 and 3 to allow deeper affordable options in the future.
- Use of Union Labor.
- Where street trees are not feasible, the addition of street greenery through street planters. These should be reflected on the site plan.
- Increase in the proportion of 2- and 3-bedroom units.
- Designation of an appropriately sized loading area accessible to the trash and receptacle area.

**2:48:00** (Motion made by Stephen Cooper and seconded by Sheila Lewandowsk) that we adopt the Land Use & Housing Committee recommendation with the stipulation that instead of union labor we use the word prevailing wage labor.

- The Newtown Creek Combined Sewer Overflow Tunnel has been certified and is now in the ULURP process and we will be reviewing and voting on this at the next board meeting.
- The Draft Industrial Plan was released in September. City Planning is now conducting public town halls in every borough. The Queens Town Hall will be held at the CUNY Law School on October 23, 2025, at 6:30 pm.

#### 2:58:44 Reilly Owens, Chair, Transportation Committee provided the following update:

- Reported DOT was not in attendance at the meeting however, they provided updates.
- Review Avenue, part of what we call, the Blissville Geenway has been completed.
- Visited Maspeth Park, the new skate park, and it was awesome.
- DOT celebrated the completion of the 29<sup>th</sup> Street Plaza at LaGuardia Community College
- The DOT commented that the markings on the Queensboro Bridge have not been completed in the bike lane, but they are waiting for the construction of the crosswalk at the base of the bridge to be complete. Then the team will continue and remark the bike lane so that it is showing the actual law which is that pedestrians are not allowed on that lane and that it is a two-way bike lane.
- We continue to express to DOT that it has taken far too long for that to happen.
- Tom Mituzas had brought to us the Dutch Kills Tributary, a park in Blissville that has been created by residents of Blissville, but not by the city. He is advocating with the Blissville Civic Association for that to become a city park. The Committee will be sending a letter to the Council Member.
- This weekend the G train is not coming to Court Square for the entire weekend, there will be no G between Bedford Nostrand Avenues and Court Square.
- The 7 Train will not run next weekend.
- On the 17<sup>th</sup> starting at 11:30 pm and until Monday October 20, 2025, at 3:30 am, the #7 line will run between Flushing and 74<sup>th</sup> Street which will be the last stop. There will be free shuttle buses.
- F & M Trains will swap lines in our district, beginning on December 8, 2025.
