0:07:46 Anatole Ashraf welcomed everyone to the meeting and provided housekeeping rules and reminded everyone their vote is their opinion. He requested everyone follow the WAIT Rule, (Why Am I Talking).

0:08:55 Tiffany Echevaria, Representing Congresswoman Velazquez provided the following update:

- Reported the Congresswoman did an immigration round table with all the Western Queens Community leaders.
- Announced the Congresswoman's Office has prepared a flyer called Know Your Rights Flyer is provided in both English and Spanish and there will be more languages to come.
- Congresswoman Velazquez co-sponsored the Department of Education Act.

- This Tuesday, the Congresswoman rallied at the Department of the Treasury for ending Musk's government take over.
- Congresswoman Velazquez is the ranking member of the House Committee of Small Business, and she wrote a letter to address the Small Business Administration acting Administrator to clarify the extent of Musk's access to the SBS systems.
- Reported on the plummet of the stock market due to the tariffs on Canada and Mexico, which have been paused but now we are having one on China. The Congresswoman is opposed to all these tariffs because she believes they will hurt working class families.

- The Congresswoman's office is advocating for the community. She encouraged everyone to reach out to their office with any concerns.
- If anyone is affiliated with a non-profit organization looking to upgrade its security, their office may be able to assist with identifying available grant programs.
- Announced that the IRA has the direct file and its tax season, so be sure to take advantage of this.

- Announced she attended the inauguration of New York State Assemblywoman Claire Valdez.
- Announced she is back in session.
- Wished all who celebrated a Happy Lunar New Year.
- Thanked LIC Partnership for the many events they put together.
- Provided an update on Congestion Pricing and that their office is collecting data on the impacts and surveying our communities. If anyone has any questions, the MTA is putting out some information in an FAQ.
- Provided an update on Heat reminders, landlords are required to provide heat until May 31st. Their office can provide assistance if anyone needs help.
- Announced their office held a successful pet adoption event at the Chocolate Factory Theater.
- Provided an update on the federal administration's executive order threatening to cut federal funding to any hospital providing gender affirming care and discussed NYU's

- decision to cancel appointments for trans youth under the age of 19 who were receiving care. Her office is speaking with the Attorney General's office.
- Her office held a rally on Monday planned by DSA in her district and held a press conference with her colleagues.
- They have been organizing with other offices to do roundtables on what to do in terms
 of protecting the immigrant community. Gave a shout out Congresswoman Valazquez
 for her roundtable in LIC and thanked her, and the overlapping elected officials for
 working together and coordinating with community-based organizations and nonprofits
 to do Know Your Rights Trainings and to hand out flyers.
- Her office is continuing to work on the budget process and are submitting their letter on Monday. There are a number of proposals that they are supportive of in the governor's budget including the child tax credit.
- Provided an update on bills that have passed.
- Discussed the OneLIC and that she has been excited to have been a part of these conversations with the community and recognized Council member Won's Office. Her office is looking through what the Community Board has proposed in the points of agreement.

- Announced we are in budget season and there are a few budget letters that the Assembly Member is circulating. One of them is a Mitchel-Lama Letter to have \$500 million to be invested specifically in New York City Mitchell-Lama's.
- The Assembly Member was able to secure \$80 million last year, but a lot of that funding went to Michelle-Lama's upstate, and we are in a housing crisis. He wants to make sure we are investing in NYC Mitchell-Lama's.
- The Assembly Member is also working on a budget letter in partnership with Assembly Member Reyes to alleviate medical debt in New York State.
- The Assembly Member is working with the non-profit organization Open Plans in order to do an automated enforcement curb program in the city to create safer streets for pedestrians and drivers and provide citations for those blocking crosswalks.

- 1:44:34 Landmark Application 21-20 45th Avenue, Long Island City, Enlargement of Existing Building within a Landmark District

Victor Han, Architect provided the following update:

• The property is located in the Hunters Point District located at 21-20 45th Avenue, LIC.

- Any renovations and enlargements require Landmark Preservation Commission review and approval. As part of their review and approval process the application gets referred over to the Community Board for comments and recommendations.
- The application does not seek any relief whether it is the zoning resolution, building code or fire code.
- The proposal is to replace the basement sunroom that is already there in the rear yard they are going to reframe that so that they can add two floors above the existing sunroom, the sunroom comes out approximately 20 ft and they are only coming out on the first and second floor, approximately 10 ft. Rear yard at the basement level will be about 38 ft, the rear yard at the first and second floor level will be about 48 ft, so they will far exceed the 30 ft minimum requirement for the rear yard floor area. They are below what the zoning permits height lot coverage and are below whatever the zoning requirements are.
- The project cannot be seen from the street level. It is an existing two family, but the
 enlargement is 10 ft. On the first floor it will allow for an extension for a dining room
 adjacent to the kitchen and on the second floor 10 additional feet would allow for
 bedrooms.

2:05:12 Christine Hunter, Chair, Land Use & Housing Committee provided the following update:

Landmark Application – 21-20 45th Avenue, Long Island City, Enlargement of Existing Building within a Landmark District

(Motion made by Lisa Deller and seconded by Danielle Brecker) to support the Land Use and Housing Committee's recommendation to support the application.

Motion carried: All were in favor of the motion to support with the application with (35) thirty-five in favor of the motion with (0) none opposed and (0) no abstentions.

2:09:57 OneLIC Draft Zoning Proposal

Christine Hunter reported on the following:

- City Planning reps came to the Land Use and Housing Committee to provide a detailed breakdown of the zoning proposal itself and the nature of the zoning districts.
- It is quite complex and why they are proposing for the range of districts that they are proposing throughout the area that they are proposing to change.
 It would be helpful for the full board to see this. DCP were unable to attend, however will attend the March meeting, which is pending.
- It may be among the largest scale rezonings the city has done.
- It is going to change the neighborhood, the Queens waterfront.
- We try to listen to many aspects of the community and have an obligation to look at the stated goals of every aspect of the community and try and balance them.
- She reported that late in the fall they asked for and had a meeting with the Council Member's office where City Planning was also part of the meeting and presented to them these draft points of agreement which we tried to align to points that the Council Member actually has on her website, land use guiding principles for community engagement, affordability, community investment and labor.
- This is not a document that we have to entertain any motions on tonight.
- It was reported that there have been some public meetings where some more information has become available, and more detail of what City Planning is thinking.
- She discussed a recent workshop on January 25, 2025, which was about these public sites. We have expressed a strong conviction as a board that we think the public sites should be maintained for public use and no simply rfpd. Another request has also been that they prioritized open space and community facilities in the DOE building.
- There are two main sites, currently owned by the DOT and a parking lot owned by the DOT and part of the city planning proposal is to connect through the DOE site with a new road that would connect two city streets 44th Avenue and 44th Drive. This would create a new loop road.
- They discovered the DOE building has a major structural expansion joint, and it would be easy to save part of the building.
- Announced on February 18, 2025, from 6:00 pm to 8:00 pm there will be a panel discussion which will be held at Culture Lab and will include Anatol Ashraf, CB 2, Lisa Goren, LIC Coalition and a representative from the Western Queens Land Trust. She encouraged everyone to attend.
- Christine Hunter discussed the Waterfront Access Plan which should include the widening of the standard 40-foot-wide walkway to accommodate both an anticipated bike and foot traffic to include the continuation of the Blissville LIC Greenway.
