- Spoke about a wave of new arrests by ICE coming up in our community. If anyone is need of help to reach out to their office.
- They are seeing a change in the immigration cases, especially with work permits and employment authorization. Seeing people denied when they try to renew.
- Discussed the I-730K this is for relatives for asylums applications. They are being transferred to a new office of USCIS.
- Provided an update on mail theft.

0:16:22 Tiffany Echevaria, Representing Congresswoman Nydia Valazquez provided the following update:

- Congress is now back in session after a recess period.
- Federal Fiscal year is set to end on September 30, 2025.
- When votes are held on the upcoming Congressional Budget, the Congresswoman will
 oppose any appropriation bills that reduce funding to critical services essential to
 people's survival and wellbeing.
- In July, the Congresswoman was denied again her right to perform oversight at 26 Federal Plaza building. She has visited this building multiple times, believing that it was being used as an ICE detention facility. The Congresswoman has called on the Department of Homeland Security to further investigate the facility.
- The Congresswoman is hosting a Congressional App Challenge. This is for middle school and high school students interested in STEM.
- Announced the Flood Solutions Fair will be taking place at Sunnyside Community Services on September 13, 2025 from 1:00 pm to 4:00 pm.

0:24:40 Mercedes Jennings, representing NY State Senator Michael Gianaris provided the following update:

- Reported Senator Gianaris has provided funding for 14 schools within our district to help provide additional academic and extracurricular support to students.
- Reported on August 22, 2025, Senator Gianaris was at Woodside Houses alongside
 Assemblywoman Jessica Gonzalez-Rojas giving out backpacks and lunch bags to students
 in the community.
- The Senator was at the backpack event for CEC30 on August 26, 2025, giving out lunch boxes, backpacks and activity books to the students. He was also at Queens Community Day at the Met.
- This Saturday, Senator Gianaris will be at the Maspeth Federal Savings for the 9/11 Memorial Ceremony. He will also be at the Variety Boys and Girls Club at the back-to-school event giving out more backpacks and activity books.
- Senator Gianaris will also be at the GBK community picnic in Queensbridge Park.
- Senator Gianaris has been keeping a close eye on the Queens Bus Redesign.
- The Senator thanked CB 2 for the support that the Transportation Community has provided to the constituents. The Q32 and the Q60 have had a lot of protests about some of the stops and those stops were reinstated, especially the one that is by Sunnyside Community Services. Their office is still receiving complaints and concerns from the community. They are keeping their eyes and ears to the ground so that they can provide continuous support to their constituents and see if there is anything that could be done to make the redesign a much easier transition for all.
- Announced their office will be moving, and at the October meeting there will be an announcement with the official address and information for everyone in the community.

- Announced the Queens Bus Network Redesign went into full effect on September 2, 2025. Their office is working the MTA and constituents to help them navigate route changes and any concerns they have.
- Encouraged all to reach out to their office with any concerns.
- The MTA is monitoring and taking this feedback in the first few months of the redesign so they can make it as good as possible.
- The MTA is raising the rates to \$3.00 starting in January of next year. They are still accepting public comments on these rate increases.

- Thanked the NY State Senator Gianaris and Council Member Julie Won, Woodside on the Move, St. Sebastians and other key stakeholders and community leaders for having the reinstatement of the bus stop outside of St. Sebastians.
- Announced their office has allocated discretionary funding to ACE, who are doing cleanings 5 days a week.

0:05:18 Farah Salam, Representing New York City Council Member Julie Won provided the following update:

- Announced there was a CPC vote, and the OneLIC passed through the CPC that has not started the process of negotiation.
- The final public hearing on OneLIC will be on Wednesday, September 17, 2025, beginning at 10:00 am at city Hall. This is a final critical opportunity for the public to weigh in on their rezoning ahead of the City Council vote later this fall. It is recommended to attend and testify in person. Testimonies will begin an hour or so after the hearing, and there is also a remote option available after that.
- Announced on September 29, 2025, the Committee on Parks and the Committee on Contracts will host a hearing on Griffin's Landscaping a vendor whose owner Glenn Griffin was recently sentenced to two years in federal prison. The company has been placed under monitorship by the NYC Department of Investigation and continues to receive taxpayer funded contracts. Anyone interested in attending that hearing can attend in person or view it online through the City Council website.
- Thanks to the \$2 million dollars secured in the Fiscal Year 2026 Budget, the Hunters Point Library will now have 7-day services beginning this Sunday.
- The Council Member thanked Speaker Adams and the public library for prioritizing literacy, learning and safe community places in our district.
- Their office distributed over 700 backpacks throughout to community members at over 12 different events.
- Their office conducted bike helmet fittings and giveaways, several movie nights and they have three different types of clinics coming up.
- Their office will have their Legal Immigration Services Clinic, and individuals must call their office to set up an appointment.

- Their office will have their Housing Lawyer on September 8 and 23, 2025 through Communities Resist.
- Their office will have a Veterans of Foreign Wars Clinic from 10:00 am to 5:00 pm.
- Their office along with NY State Assembly Member Valdez's office; they have been hearing a lot about the Green Asphalt issues in Blissville. Their office met with Green Asphalt and are asking them to be compliant with state regulations and that Green Asphalt monitors and shares air testing data and communicates directly with community members.

1:26:21 Fran Casso spoke about the following:

- The Bus stop on 58th Street and Roosevelt Avenue that was restored still has the old sign that says the bus will not stop here. Had a hard time trying to convince the bus driver to let them off the bus because they restored the stop. There is a lot of confusion about where to get to the bus stops that are supposed to be on Roosevelt and 52nd Street. There is no sign there. She reported she had to go to 48th Street and Queens Blvd because the bus driver kept continuing going on Roosevelt Avenue because the 51st Street bus stop was eliminated. There is a lot of construction going on at 53rd, 54th Street, and riders don't know where to get the bus.
- Her bus stop on 53rd Street has been eliminated but they are still picking up passengers.
- She also spoke about the OMNY card which charges transfers. She was charged another fare when she took the Q32 to 58th Street to try to get to the Q18.

Mercedes Jennings, Representing NY State Senator Michael Gianaris, provided an update about the OMNY card and that the MTA did in fact change the system. They are asking constituents to let their office know so they can continue to advocate.

We had an Executive Committee meeting joined by our Land Use Chairs and CB2 wrote a letter to Council Member Won in support for developer community commitments in the OneLIC plan. We received hardball thoughts and requirements and commitments from the Council Member which overall track and line up with what we requested. Overall, we support the letter saying that we support her efforts in trying to hold developers accountable and get benefits for the community. - Reported the Transportation Committee heard a presentation by Open Plans. They discussed low traffic neighborhoods.
- DOT provided updates from the Review Avenue Safety Improvement Project.
- Reported he sent letters to the DOT over the summer about the Queensboro Bridge
 markings on the north side bike lanes which are still marked with pedestrian symbols in
 the bike lane which causes confusion and conflict between pedestrians who find
 themselves there and cyclists who are in the same lane.
- Woodside Avenue in our district is getting repainted. The Committee asked that
 Woodside Avenue and 39th Avenue see some safety improvements because there is a
 long crosswalk, and the area is in the middle of a lot of elementary schools and parks.
- CB 2 received a letter from DOT about parking at Hunters Point South, Center Boulevard, 2nd Street and 57th Avenue. There are lane markings going in for parking lanes on both sides of Center Boulevard formalizing curbside parking on both sides of Center Boulevard from 57th Avenue to Borden Avenue which will also be added on the street from 54th Avenue to 57th Avenue as well as 57th Avenue from 2nd Street to Center Boulevard. There is a lot of confusion and a lot of problems with trucks.
- The agency is also aiming to install plastic bollards at the bending of the curb on Center Boulevard on 57th Avenue. This will help deter illegal parking which has been observed to block safe clearance and turns for vehicles as well as congestion. There were problems with the Q101 bus stop there because of this.
