

## 70th Street Sewer Upgrades Project

### 70<sup>th</sup> Street Sewer Upgrades

The New York City Department of Design and Construction (NYCDDC) continues to manage construction project #SE859 - Replacement of Combined Sewers and Water Main in 70th Street.

Scope of work includes:

- Upgrade public utilities
- Replacement of water mains
- Installation of 96" combined sewer by Micro tunneling
- Install Catch Basin
- Curbs and Sidewalks
- Install new roadway surface

This \$101 Million-dollar capital investment in Community Board #2 and #5, Queens, is anticipated to be completed by Summer 2023.

#### Work Completed to Date:

- Micro tunneling operation
- Completed construction of Special Manholes No. 1 through 8
- Completed installation of Catch Basins
- Completed Watermain and Sewer installation
- Installation of curb, sidewalk and permanent asphalt placement on:
  - Calamus Ave
  - 70<sup>th</sup> Street
  - 54<sup>th</sup> Avenue
  - 71<sup>st</sup> Street
  - Grand Avenue
  - Mazeau Street between Grand Avenue and Queen Expy Service Road

#### Proposed Work Schedule/January 2023 – April 2023

- Continue installation of 12' x 8' Box Sewer on 69th Street under LIRR
- Construction of new Chambers 1 & 2

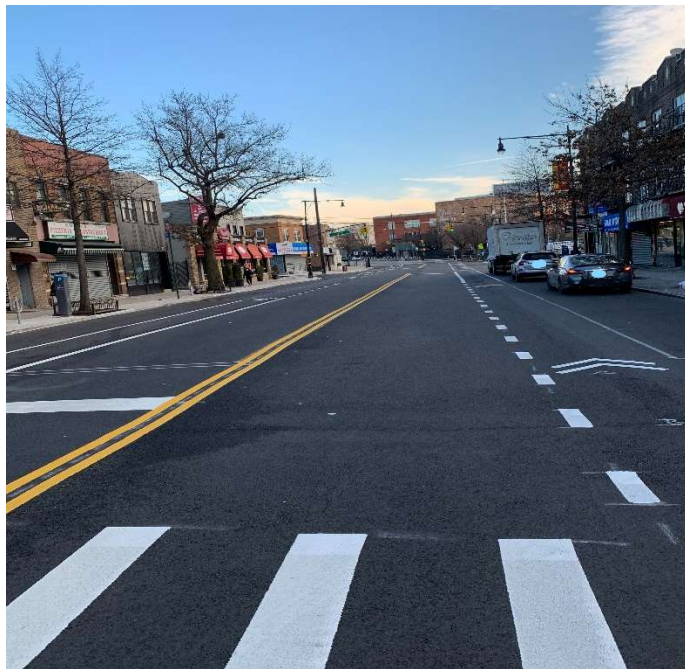
#### Special Needs
