Lisa Deller welcomed everyone back to the virtual CB 2 Board Meeting tonight and said that until further notice all CB 2 meetings and committee meetings will be conducted by Zoom teleconference.

Lisa Deller welcomed the following individuals:

Honorable Jimmy Van Bramer, NYC Council Member

Council Member Van Bramer provided the following update:

- Welcomed everyone back.
- Discussed Hurricane Ida Recovery and spoke about a tragedy at 64th and Laurel Hill where a family of three drowned in their basement apartment, including a child.
- Council Member Van Bramer stated his office has been assisting people who live on that block and have requested from DEP a walk through of this location along with other places in the district which include Sunnyside north and south of the Boulevard.
- Met with Congresswoman Ocasio-Cortez, Senator Gianaris and Julie Won to check in on La Adelita and Maggie Maes. He also spoke about the area of 48th Street and 37th Avenue near Stop and Shop where there was horrific flooding
- Council Member Van Bramer announced that ACE will go out to help out with clean up on 48th Street.

- Spoke about the Emergency Service Center at IS 125 and will be there until 8 PM tonight and announced that FEMA was there along with other agencies which were there for support. However, they will have to move the location from IS 125 as the space will be needed for when school opens. OEM is working on a new location.
- Council Member Van Bramer's Office will continue to assist people with their claims.
- Discussed that there have been additional sanitation pick-ups there has been improvement there.
- Discussed the short term and long-term issues.
- Spoke about the Barnett Avenue middle school which took in a lot of water and that construction of the school continues.
- Announced PS 384 is opening on Monday.
- Discussed the Northern Blvd High School which is currently the site being used as a COVID testing site.
- Announced Doughboy Park is nearing completion.
- Announced Open Culture is a great success and that he is excited to introduce an extension of Open Culture at the City Council.
- Announced that he has allocated funding for WNET in the amount of \$40,000 for CB 2 meetings to be recorded.
- Spoke about the need for traffic calming measures on Northern Boulevard and that he has spoken with DOT concerning the streetscape which needs to be dramatically changed for pedestrians and young people that will be going to that future school

Council Member Van Bramer entertained questions.

Lisa Deller thanked Council Member Van Bramer for allocating the funding for WNET which will be a big help to us.

Lisa Deller thanked Assembly Member Barnwell for his help with Hurricane Ida and for his assistance in amending the Open Meetings Law.

- Announced the CEC will be having a meeting on September 20, 2021 at 6:30 concerning the school on Northern Blvd. They will present the new rendering and floor plans. He is engaging with DOT to make this area safe.
- Eviction moratorium has been extended to January 15, 2022.
- Every Sunday at 10 am and Wednesdays 2 pm his office conducts clean ups in the community. If anyone is interested in volunteering the meeting location is 55-19 69th Street.

Assembly Member Barnwell entertained questions.

Tiffany Hurdato, Representing Assembly Member Jessica Gonzalez-Rojas

Tiffany Hurdato provided the following update:

- Spoke about the Hurricane Ida Resource List which is available and anyone who needs a copy may contact the Assemblywoman's office with their email address.
- Their office is helping constituents with E-Wrap applications as well as the Exclude Workers Fund and to apply as soon as they can.
- Call their office to set up an appointment for assistance.
- Their office held a backpack giveaway.
- The Assembly woman's Office is hosting two paper shredding events on the following dates:
 - September 18, from 10:00 am to 2:00 pm in front of St. Marks at AME Church at 95-15 Northern Blvd.,
 - November 13, 2021 from 10:00 to 2:00 in front of 398Q on 69th Street and 34th Avenue

- Their office will be hosting an e-waste drop off site at 75-35 31st Avenue, Suite 286B, East Elmhurst, NY.

Questions were entertained.

Sheila Lewandowski asked about the curbside composting program and asked for an update and inquired about larger buildings participating. Matt Wallace stated you have to sign up online. They are encouraging neighbors to sign up.

Matt Wallace stated that the Curbside program is only focused on 1 to 4 family homes and that people have to sign up. He would provide the link in the chat.

Christine Hunter discussed the lack of public outreach and asked for more information and that the community understand what is at stake. Matt Wallace will provide the information and their office will help with the push to get people to sign up.

Mercedes Jennings, Representing NY State Senator Michael Gianaris

Najee Phillips, Representing Congresswoman Alexandria Ocasio-Cortez

Najee Phillips provided the following update:

- Expressed sincerest condolences to the families that lost loved ones and belongings in the wake of Hurricane Ida, particularly the Lama Sherpa Family who were lost in Woodside. Their office is working with the state department to facilitate their relatives attendance at the funeral services.
- Congresswoman Ocasio-Cortez will be hosting a virtual town hall on Tuesday, September 14, 2021 at 5:30 pm to discuss Hurricane Ida recovery efforts and resources. FEMA and Small Business Administration will be in attendance.
- Congresswoman Ocasio-Cortez, Mayor de Blasio, and Governor Hochul joined FEMA to survey the damages in the wake of Hurricane Ida throughout 64th Street and 48th Avenue.

ULURP/CITYWIDE APPLICATION

CITIWIDE PROPOSED OPEN RESTAURANTS TEXT AMENDMENT ULURP# N210434ZRY

The New York City Department of Transportation (DOT) and Department of City Planning (DCP) are proposing a citywide zoning text amendment that will allow the DOT to administer the Permanent Open Restaurant Program (POR). The proposal will remove sidewalk café

regulations from the Zoning Resolutions to increase geography eligibility as sidewalk cafes will become part of a unified sidewalk and roadway outdoor dining program administered at DOT.

Lisa Deller stated at the Land Use Special Meeting the DCP presented their piece of the text amendment and at that time the DOT was unable to present. We realized at this meeting was that This is not a DCP Program but a DOT program. Lifting the zoning to allow for open restaurants that will be supervised by the DOT is something we are interested in hearing a lot about. Zoning has huge control over the use of the street and to give the DOT purview over controlling access is a sea change. This gives the DOT huge purview over control and access to the streets.
