00:42:15 **Replacement of the current Hunters Point Ferry Landing:** NYC Economic Development Corporation (NYCEDC), represented by Tara Das and Franny Civitano, presented plans and asked the community to share thoughts with [nycferry@edc.nyc](mailto:nycferry@edc.nyc). A m lengthy exchange ensued with board members.

**01:56:35 Public Hearing – Hunters Point Ferry landing**

01:56:43 **Emilia Decaudin** lives across the street from the proposed ferry stop. She spoke in support of the proposal.

01:58:50 **Mark Christie**, Hunters Point Park Conservancy (HPPC), spoke in opposition stating that the park near the proposed landing site is very actively used, especially by children who might be adversely affected by emissions from the ferries. Ferry service was never part of the park's design.

02:02:31 **Rebecca Hornstein**, HPPC board member spoke in opposition stating the adverse effect on the view of the river and Manhattan.

02:05:16 **Leonard Klipper**, Certified Planner and community member opposed the planned location citing a negative impact on the Hunters Point Park South linear park. He also requested ebb- and flow-tide elevation data.

02:30:37 **Frank Ottomanelli** has the concession near the ferry dock. He is opposed to the aesthetics of the plan, stressing that the park is now peaceful and calm.

02:12:59 **BSA 68-01 / 05 QUEENS BLVD CAL NO. 271-90-BZ**: Representing the owner, Todd Dole presented the proposal for an Extension of term of a zoning variance previously granted permitting automobile repair (Use Group 16) and used car sales (Use Group 16) in a R 7X/C2-3 district. Board members had questions, especially regarding assurances (e.g., about not parking on the sidewalk) which have not be followed. There was no Community Public Comment.

05:15:00 **NYC Economic Development Corporation (NYCEDC) regarding replacement of the Hunters Point Ferry landing to a location somewhat north.** Considerable discussion occurred.

**Motion:** To send a letter to the EDC and the Army Corps of Engineers stating that CB2Queens:

- (1) rejects the proposal as presented,
- (2) objects to the placement of the docks, loading and cueing areas in and in front of an park that operates above its capacity and which is a valuable public amenity,
- (3) urges EDC to consider the community's comments and concerns with more transparent and timely outreach,
- (4) affirms that CB2 Queens regards and supports current and expanded ferry service as part of the public transit network - we want the ferry service on the Queens waterfront, just not at the proposed location and
- (5) encourages the EDC and Army Corps of Engineers to explore an expansion of the LIC Ferry landing as well as a site providing greater equitable access to those living midway between the LIC and Astoria landings.
