Sheila Lewandowski and Tom Mituzas welcomed everyone to the meeting.

## UPDATE BY 108<sup>TH</sup> POLICE PRECINCT ON TRAFFIC ENFORCEMENT ISSUES

#### Sgt. Pak provided an update on the following:

• Discuss enforcement need from parked cars and warehouse south of Wynwood Gardens and Mt. Zion Cemetery. Provide an update

Sgt Pak reported that he inspected Tyler Avenue between 60<sup>th</sup> Street and Maurice Avenue. License plates and registrations were check and everything is up to date. There are no stolen vehicles in the area. The PD needs more feedback from residents of the area. If a vehicle is parked for more than several months, then they will go out to chalk the tires

• Request for Enforcement and discussion of wrong One-way conversion of 37<sup>th</sup> Street between Review Avenue and Bradley Avenue. Provide an update

Gretha Suarez discussed follow up with the street light unit.

• Drag Racing – Woodside, Sunnyside

Sgt. Pak reported that 911 calls has decreased by 85% and 311 calls have been reduced by 77%. Drag racing is reduced

Sheila Lewandowski discussed motorized vehicles such as e-bikes zipping through lights, going in the bike lanes in the park and on the streets.

Sgt Pak reported the 108<sup>th</sup> Police Precinct is conducting enforcement at the Queens Borough Bridge and distributing educational flyers.

If there are any locations that need to be addressed to notify them.

Laura Shepard spoke about a fatality that occurred on 43<sup>rd</sup> Street. She stated there was an individual delivering food utilizing a motorized scooter which involved a driver making an illegal U-turn. She asked if the driver was summonsed and if PD are doing any enforcement. She also asked DOT if they are doing any street design changes to reduce speeding and reckless driving in this area.

Sgt. Pak stated the driver was making an illegal u-turn. He did not see the motorized scooter and there was a head on collision. It is still under investigation and are waiting for the highway unit to see what happened.

Lisa Deller discussed that she has reported complaints concerning two abandoned vehicles in front of 39-40 45<sup>th</sup> Street. Sgt. Pak will investigate this matter.

## **DOT TRANSPORTATION - PRESENTATIONS**

12<sup>th</sup> Street Plaza Proposal - Presentation will be provided at the November Transportation Committee Meeting

46<sup>th</sup> Avenue Plaza Proposal - Irene Figueroa-Ortiz provided a presentation on the Proposal.

Tom Mituzas asked how many parking spots will be lost? The response was none. Tom Mituzas stated this is something that should be highlighted next time as it is something important for the community to know.

Lisa Deller spoke about the DOT survey and asked if was sent for distribution outside of pedestrians who could pick up a flyer with a QR code, and did it go to the Community Board 2 office so we could share it more widely. The response from DOT was yes. Gretha Suarez stated that it went to the Community Board and the area elected officials. A flyer was shared and the social media post so it could be easily distributed. Lisa Deller asked if they had any geographical analysis of the respondents. The response was that they made the survey anonymous.

Lisa Deller stated that not everyone is as literate when it comes to QR codes and responding and people still need to be asked or physical surveys and she is sensitive to this and there are older people in this community who are underrepresented in a lot of the communication since the pandemic occurred.

Lisa Deller stated it has been over 10 years since this Community Board has been advocating for PS 1 since the wall was been put to take down the wall and that is unconscionable that MoMA PS 1 administration right now is giving no time line for when they are going to open up that wall and providing additional space on the street for them to utilize is like a expansion of their space. It doesn't make it all that interactive with the courtyard and welcome people to the

courtyard. She is opposed to PS 1 being the steward of the space as they are not being a good and open and equitable steward of the courtyard for neighbors

We need a time line for when the wall is coming down they have been stalling and hedging and postponing for so many years now and it is unconscionable the behavior of the administration protecting this space and there has to be a way to open it up.

Kate Fowle, MoMA PS1 stated they can create a clearer timeline as soon as they get a clear time frame from the City as the wall is City owned. She stated that she cannot speak for the administration before them and that there isn't anyone on the call from PS 1 this evening that would disagree with what she was saying, the fact is that use value of that wall and that kiosk is still perceived by the city as to still be in within the amount of time that they don't want to change it. They are currently working with the City to see what they can do and they can't give a time scale that would be misinformation until they get the information themselves.

Mary Torres discussed the number of languages on the survey and the QR code. The response was they had a lot of limitations due to the pandemic. She also discussed the location of the flyers and where the QR codes were posted and suggested they look at other subway locations.

Sheila Lewandowski asked if the leadership was willing to make a commitment from leadership of PS1 to taking the wall down and making the courtyard a publicly accessible space again. PS1 never said they were working on new designs that would make it less imposing, with a greater sense of openness but they were clear that the wall is not coming down.

Kate Fowle stated that she would be able to show the plans.

Sheila Lewandowski stated we would like to see more of that courtyard be part of that open space. She said she did not feel the same kind of care from DOT, there are so many ways to reach people without using a QR code and it can be in different languages and asked why this was not considered, why not have a phone number so people could participate.

DOT stated they followed the process they have followed for other streets and hosted workshops and did a online survey and went the extra mile for projects in this area.

Tom Mituzas discussed his concerns about the survey that was conducted by DOT.

DOT reported 18 bike spots will be added.

## <u>Sunnyside</u>

## 39<sup>th</sup> Avenue Bike Boulevard

Gretha Suarez reported this will be discussed at the October 7, 2021 CB 2 Board Meeting. To hear and address concerns. They are installing missing markings and are addressing element that are missing. The DOT is trying to work as quick as possible.

In the discussion of the Bike Boulevard a number of us were quite effusive about how the DOT did not do their due diligence of meeting with and working with the local community to prepare them for the changes. We said they should have people on the ground helping people navigate the changes and we said it was rushed into place. We also pointed out that in their prior presentation they said there would be NO (zero) loss of parking whereas here they were saying it was a minimal loss of 20 parking spaces. At the meeting, they outright denied that they had ever said there would be zero loss of parking. This is important. Thomas and Sheila pushed back on the term "minimal".

Tom Mituzas discussed that they should have done a better job of educating and communicating to people on the ground. Discussed the loss of parking.

Gretha stated there was minimal parking loss approximately 20 spots.
