# Jack Bernatovicz, Representing Council Member Jimmy Van Bramer

Mr. Bernatovicz provided an update regarding the Council Member's activities. He announced that Council Member:

- o joined small businesses owners and cultural entertainment venues in Astoria to "save our small arts businesses" at a Town Hall and Press Conference.
- o attended a ribbon cutting for a barbershop in Woodside and supported small businesses in Woodside that opened during the pandemic.
- o helped sponsor and pass legislation to help businesses have a COVID-19 Recovery.
- o Is working with his colleagues to push for Fair Wage Legislation.
- o celebrated the reopening of the local community compost site.
- o joined Transportation Alternatives on the Queensborough Bridge calling for the south outer roadway to be a dedicated pedestrian path and opening the northern outer roadway for bicycles. Thanked CB 2 Board Members that were present at the event.
- o toured the MoMA PS1 with the Commissioner of Cultural Affairs.

# RXR LIC PROJECT 42-11 9TH STREET ULURP 20DCP078Q

A special permit (pursuant to ZR 74-96) and related text amendment to facilitate a new 21-story, 321,347 sf mixed-use (commercial/industrial building in a new industrial business incentive area (IBIA), is being sought by RXR 42-11 9<sup>th</sup> Holdings LLC at 42-11 9<sup>th</sup> Street in Long Island City, Community District 2, Queens.

Jeff Nelson introduced the team who would be speaking, and they are listed as follows:

Mr. Nelson provided a power point presentation and discussed the project overview, project goals and next steps.

Carlos Escobar, Titan Machine Corp. informed the Board that Titan is a family owned elevator machining business founded in LIC in 1973. Titan is the current owner operator and occupant of the project site at 42-11 9<sup>th</sup> Street. The facility is outdated an no longer properly configured for its business needs.

RXR was selected as a partner based on their reputation for thoughtful development and shared commitment to the vision of strengthening the city's industrial sector.

Titan will remain an owner of the project and a part of the development team.

Jeff Nelson, RXR provided an overview of RXR which is a NY based approximately 500-person vertically integrated real estate firm.

Ellen Lehman discussed the zoning actions.

Emma Manson discussed the Project Goals and Overview, community jobs and partnerships with Urban Upbound and LaGuardia Community College.

#### Approval of the June and September 2020 CB 2 Meeting Minutes

A motion was made and seconded to approve the June 2020 and September 2020 Community Board 2 Meeting Minutes. All were in favor with none opposed and no abstentions.

# **Chairperson's Report**

Ms. Deller provided the following update:

- Ms. Deller thanked all the board members for their hard work.
- Thanked the Budget Committee and Chairs of each Committee who have been working hard on the Capital and Expense Budget Priorities.
- Thanked the Tech Task Force who have helped with the sign-in sheets and for their hard work and stated that we have made tremendous progress in getting the meetings up and running and thanked everyone for their leadership.
- Announced that we will combine the Health and Human Services and Education Committees and Taina McShane will be the Chairperson of the Committee.
- Ms. Deller reported that she has asked Christine Hunter to be the Co-Chair of the Land Use Committee.
- Thanked Tom Mituzas and Warren Davis for their hard work concerning the homeless shelter issues in Blissville.
- There will be a meeting on October 5, 2020 with the Northstar Community Advisory Board.
- Ms. Deller provided an update about the CB 2 By-Laws and stated that before we can move on with nominations, we need to address an issue within the By-Laws.
- Discussed the history of the ballot process and voting procedures.
- CB 2 By-Laws still technically provide that voting for officers needs to be conducted by Ballot in Article VI, section 1, Nominations and Election of Officers. Due to the COVID emergency, due to changes in voting technology, we believe it is wise to amend the by-laws. Ms. Deller stated that we are proposing the Board to conduct the vote by roll call, voice vote in November and thereafter as per the changes we are proposing. The procedures for amending the By-Laws which is spelled out in Article VIII, entitled Amendment to the By-Laws. These By-Laws may be amended at the initiation of a majority of the members of the board present and voting at a monthly meeting. Ratification of an amendment shall be by a two-thirds (2/3) vote of the members of the Board present and voting at the next regular meeting of the Board.

Ms. Deller made a motion to amend Article VI Section 1 of the By Laws to remove the by ballot in the last sentence of this section and replace it with the following: instead of by ballot it would be by written electronic or other form of ballot.

Jake DeGroot made a motion and it was seconded by Ben Guttmann and Amparo Abel-Bey

The vote was 31 in favor with none opposed and no abstentions.

Ms. Deller announced that Diane Ballek and Pat O'Brien would not seek reelection to the Executive Board. Ms. Deller thanked them for their long-time service and dedication on the Executive Board.

#### **Nominations**

Ms. Deller made a motion and it was seconded by Sheila Lewandowski and Norberto Saldana to nominate Lauren Springer as Treasurer.

Mr. O'Brien made a motion to nominate the following slate of officers on the Executive Board:

Kenny Greenberg stated that he prefers to be 2<sup>nd</sup> Vice Chairperson rather than 1<sup>st</sup> Vice Chairperson. Kenny Greenberg was nominated for 2<sup>nd</sup> Vice Chairperson by Patrick O'Brien and it was seconded by William Garrett. Kenny Greenberg accepted the nomination.

Benjamin Guttmann made a motion and it was seconded by Nick Berkowitz who nominated Dr. Rosamond Gianutsos as Secretary. Dr. Gianutsos accepted the nomination.

Jordan Levine made a motion and it was seconded by Jake DeGroot and Julie Won who nominated Frank Wu for Treasurer. Frank Wu accepted the nomination.

## **Department of City Planning**

Teal Delys provided the following update:

- 50-25 Barnett Avenue is an application for a new mixed-use building with 167 dwelling units all
  of which should be affordable. This application came to the Land Use Committee on September
  16, 2020 and they anticipate ULURP certification in October.
- 48-18 Van Dam Street. This is the Teamsters application for a 4-story enlargement of an existing building for the union office, training and storage needs. They anticipate ULURP certification of the project on October 19, 2020.
- 62-04 Roosevelt Avenue. This s a private application for a new 13 story mixed-use building of 200 units, 64 which will be affordable. This application will be presented at the Land Use Committee in the next couple of months and ULURP certification will happen before the end of the year.
- Zoning for Coastal and Floor Resiliency Text Amendment will be referred this fall.

# New Revocable Consent for JB Industries Inc. Under Sidewalk Storm Drainpipes Mecho Systems, 42-03 35<sup>th</sup> Street, Long Island City, New York, Block 218, Lot 13

The legal counsel for the Applicant provided an update. She explained that this is a storm pipe that they are seeking to legalize.

Christine Hunter made a motion and it was seconded by Lisa Deller to approve the application. The vote all in favor of the motion by a show of hands with none opposed and no abstentions.

# <u>ULURP Project Application C200303 ZSQ, N 200304 ZRQ; CEQR: 20DCP078Q RXR LIC Project 42-11 9<sup>th</sup></u> Street, Long Island City New York

Sheila Lewandowski made a motion and it was seconded to support the project with the following conditions:

- RXR Realty/Titan (the developer) will set aside 10% of the industrial space at a rental rate of \$15.000 per square foot.
- Annual rent increases would be capped at 3% per year for ten (10) years and the lease would include a right to renew for an additional ten (10) years with the same terms.

The vote was 32 in favor of the motion to support the application with 2 opposed and 2 abstentions.
