COVID-19 Response – Application Processing

As part of the citywide response to the Coronavirus, Department of Buildings (DOB) customers are being encouraged to immediately limit the amount of walk-in traffic to DOB offices. Effective Wednesday, March 18, customers are strongly encouraged to make use the following methods:

- Continue to use <u>eFiling</u> for Hub Development, Full, Self-Service jobs and <u>AHV permits</u>
- Continue to use <u>DOB NOW: Build</u> for all applicable work types.
- The Administrative Enforcement Unit, Licensing and Enforcement units are currently maintaining their normal functionality. Additional Service Notices will be posted this week with updates on these transactions.
- <u>Customer Service Night</u> is cancelled on Tuesday, March 17, 2020 and until further notice.

Transactions conducted at a DOB borough office that are not listed, will continue to take place in-person, including Records Room requests and other functions that require a service ticket.

For the above transactions that cannot be processed in eFiling or DOB NOW, mail the application to the appropriate borough office and include on the envelope **Attn: Application Processing**. The application can also be hand-delivered to the borough office and put in the designated drop-off box. Attach to the application a check or money order for the amount owed payable to the NYC Department of Buildings.

PW1 approvals or objections will be sent to applicants by email. Plan sets will not be returned by email and will need to be picked up from the borough office by pulling a service ticket.

L2: Requests for Overrides, Reductions or Waivers of Civil Penalties for civil penalty paid (CPP) or no relationship to the violation (NRV) can be included with the permit application. L2s for other reasons will continue to require an in-person visit to a borough office.

For the above transactions that cannot be processed in eFiling or DOB NOW, mail the application to the appropriate borough office and include on the envelope **Attn: Application Processing**. The application can also be hand-delivered to the borough office and put in the designated drop-off box.

Post Approval Amendments and Supersede Requests

PAA applications and supersede requests that are filed in-person can be dropped off at the borough in the designated drop-off box. There will be no in-person processing. When the PAA status in the Building Information System (BIS) is PAA Fee due, return to the borough office to make the payment.

COVID-19 Response: Administrative Enforcement (AEU) and Licensing Units Updates

As part of the citywide response to the Coronavirus, Department of Building's (DOB) customers are strongly encouraged to immediately limit the amount of walk-in traffic to DOB offices. Effective Wednesday, March 18, 2020 the following changes are mandatory:

Certificates of Correction

Continue to submit documents by mail or hand delivery to:

Administrative Enforcement Unit 280 Broadway, 1st Floor New York, NY 10007

There will be no in-person review of Certificates of Correction. Put documents in the designated drop-off box; do not pull a service ticket. To verify receipt of a Certificate of Correction package, search for the summons/violation number in the <u>Buildings Information System (BIS)</u>. The Certification Status will be <u>Certificate Pending</u>, and the <u>Certificate Submission Date</u> will be updated with the date it was received by AEU.

All documents will be returned by mail and cannot be picked up at the AEU office.

Licensing

To apply for a new license, renew or make a change to a license, submit all required forms and fees by mail or hand delivery to:

<u>Licensing Unit</u> 280 Broadway, 1st Floor New York, NY 10007

The requirement to submit renewal applications between 30 and 60 days prior to the license expiration date has not been changed. Review applications thoroughly and monitor upcoming expiration dates carefully to ensure that all guidelines are met.

Continue to use **<u>DOB NOW: Licensing</u>** to submit gas work qualification, journeyman and welder applications. Continue to submit concrete safety manager, construction superintendent and safety registration applications to the appropriate email address.



There will be no in-person review of applications. Put documents in the designated drop-off box; do not pull a service ticket. Submissions will receive a preliminary review and will be returned by mail if found to not include all required documents and **payments**. Applicants will be contacted by phone or email with background investigation statuses, approvals and requests to appear in person to take photographs for new license cards.

Continue to submit updated insurance certificates to the appropriate **email** address by license type.
