Deputy Inspector Richard Napolitano, commanding officer of the 110th Precinct, will be on hand to discuss crime and quality of life issues. New York City Transit Communications Based Train Control (CBTC) on the 7 Line.

In order to carry out CBTC installation work in the Steinway Tunnel, we must schedule a series of service diversions affecting the 7 line service between Queens and Manhattan. As with the work that has taken place this Summer, tight tunnel clearances in the Steinway Tunnel make this section of the 7 line one of the most challenging areas in our subway system. MTA NYC Transit will also use these weekends to do other work on the 7 line. Additional track and tunnel maintenance work will take place in the Steinway Tunnel. We will install more resilient track plates, ten new contact rail power gaps and new contact rails, identify grout leaks in the tunnel walls and clean drain lines in the pump plants.

The next series of service diversions are scheduled to take place on the October 8-10, October 30-31, November 13-15 and November 20-22 weekends. On these weekends there will be no 7 line subway service between Times Square-42nd Street and Queensboro Plaza stations from 12:01am on Saturday to 5am on Monday. A similar diversion will also take place on the November 6-7 weekend between the hours of 12:01am on Saturday and 5am on Sunday.

A special fare-free shuttle bus service will operate between the Vernon-Jackson and Queensboro Plaza stations while this service diversion is in effect.
