Citywide Hotels Text Amendment-VOTE

THE PROPOSED ZONING CHANGE WOULD REQUIRE CITY PLANNING COMMISSION APPROVAL FOR NEW AND ENLARGED HOTELS AND MOTELS, TOURIST CABINS AND BOATELS IN COMMERCIAL, MIXED-USE AND PAIRED MI/R DISTRICTS. THE REVIEW PROCESS WOULD ALLOW THE COMMISSION TO ENSURE THAT NEW HOTELS DO NOT CREATE SIGNIFICANT CONFLICTS WITH SURROUNDING DEVELOPMENT. THE NEW SPECIAL PERMIT REQUIREMENT WOULD OVERRIDE EXISTING HOTEL SPECIAL PERMIT REQUIREMENTS. HOWEVER, THE EXISTING SPECIAL PERMIT PROVISIONS THAT APPLY IN MI DISTRICTS, WHICH REQUIRE THE COMMISSION TO MAKE FINDINGS SPECIFIC TO INDUSTRIALLY ZONED AREAS, WILL REMAIN IN PLACE.
