Pedro Rodriguez

Austin Street is currently not a pleasant place to be in. I am sure everyone knows what I'm talking about. Every time I'm walking on Austin Street it all feels claustrophobic. Everyone is crammed together on those small sidewalks. People with wheelchairs or mobility scooters can barely move around. Slower people end up causing pedestrian backups. And to make things worse, when the trash is put on the sidewalks, people have even less space to move around. Meanwhile, the street is clogged with traffic, the air is polluted, everyone's honking, the buses are stuck, trucks are double parked or blocking bus stops, and cars with loud pipes are speeding down the street, damaging everyone's eardrums. Additionally, we're getting more and more development in the area, which is great, as it means more housing and more people, but these people will go to Austin for work, shop, and play. The Austin/71st area is our Downtown, we can't continue to let it degrade like this.

Luckily, there is a solution that has been proven to work: Austin Street must be pedestrianized. We must expand the sidewalks and discourage personal driving on Austin as much as possible while prioritizing truck deliveries and buses. Austin should also get sealed, on-street containers for business trash and recycling. The Department of Sanitation is currently running a program to solve this, called

the Clean Curbs program, that we should apply for.

I know in the past some businesses have fought against the idea. This happens because business owners tend to heavily overestimate how many customers drive, while massively underestimating how many walk, bike, or take transit. Study after study has shown that pedestrianization leads to increase business activity as it increases foot traffic. At the end of the day, locals visit local stores, by foot or mobility scooters, more often than faraway drivers do.

Pedestrianizing Austin will be good for our health, our community, our businesses, and the city as a whole. It will turn Austin from a simple, congested business area to a destination for all of Queens and NYC at large.

MINUTES

The minutes of March 9, 2022 were approved as written.

COUNCIL MEMBER LYNN SCHULMAN

Council Member Schulman welcomed the new members and gave the following updates:

- The City Council will be voting on 98-81 Queens Boulevard Rezoning on 4-14-22. She is happy that they met almost all conditions from the CB and Borough President.
- Thanked the Forest Hills Green Team for assisting with clean ups at MacDonald Park
- The City Council is pushing for composting in the budget
- She met with the SCA to discuss capacity in our schools. They agree that it is an issue.
- The state voted to allow for hybrid meetings in the future. However, the logistics are still being worked out with the city. While these details are being worked out, meetings for all boards can be virtual for the next 60 days.

Last, Council Member Schulman asked the Community Board to consider a street renaming for Greg Stein. It was requested by Former Council Member Danny Dromm. Mr. Stein was a Forest Hills resident and very active in the community. He was on the board of the AIDS Center of Queens County, active in LGBTQ and Pride Events throughout Queens, and active with Our Lady Queen of Martyrs, where he taught. This will be requested for the corner of Queens Boulevard and 77th Avenue.

There is also a street renaming in the works for Former CB 6 Chair Joseph Hennessy. This will be requested for the corner of 108th Street and 62nd Drive.

CHAIR'S REPORT

Chair Beers-Dimitriadis announced that there will be an internal training for new CB Members on May 4, 2022. It is mandatory for new members, but all members are welcome to attend if they wish.

Chair Beers-Dimitriadis also announced that it is time for the board members to choose which committees they wish to sit on. An email will be sent out this week asking members to choose their desired committees. Members will be required to sit on 2 committees and have the option to sit on a third. If you wish to Chair a committee, please indicate this as well. All members are eligible to become Chairs and Co-Chairs of Committees. We will also send out a form to the public asking them if they would like to serve as a Public Member on a committee. Public Members are only permitted to serve on 1 committee. If any members of the public are interested, please contact the office. These selections are due back by April 22, 2022.

Chair Beers-Dimitriadis concluded her report by saying that 2 of the things that make her proud to be a member of this board is "our transparency and how we center the public's concerns and comments in our work. We see ongoing criticism on social media of the Trylon / Tower diner project. We can fully see tonight that our Council Member is really working very hard to meet the needs and concerns of this community and bring in affordable housing. The recent criticism is unfortunately uninformed, and it is very unfortunate. We all recognize that land use decisions are complex. We know that ULURP can be very complex, but given how open that entire process was to the public, there should be very little confusion. As always whenever there is confusion to any member of the public or any member of this board, we ask you to reach out to our office and we will answer questions and provide clarification. You can call or email, but we are here to serve this community."

Chair Beers-Dimitriadis announced that CB 6 will be sending a request to the MTA asking them to review all security cameras in subway stations across the city to make sure they are working for the safety of our residents.

DISTRICT MANAGER'S REPORT

District Manager Frank Gulluscio announced that there will be 2 trainings for new members; one at Borough Hall and one internally. Our training will be virtual.

Mr. Gulluscio reminded everyone that the Chair, DM and office staff are always available to answer questions. He reported that "in person" vs "virtual" meetings are still in question. We are waiting for further guidance. Virtual meetings could be extended to 2024.

District Manager Gulluscio thanked all the members for volunteering their time to improve our community. This board is very proactive.

PRESENTATION BY MAROUA RIGHI, CIVILIAN COMPLAINT REVIEW BOARD

Ms. Righi gave the following information about the CCRB:

- The largest independent oversight entity of the largest police force in the country.
- It investigates, mediates and administratively prosecutes complaints of police misconduct.
- The reason it is called the civilian complaint review board is because it is staffed entirely by civilians.
- CCRB isn't part of the NYPD, it is a separate agency to ensure an unbiased investigation.
- CCRB is governed by a 15-member board. Those board members are selected by the Mayor, City Council, Police Commissioner, and the Public Advocate's Office.
- CCRB uses the NYPD patrol guide as a resource when they conduct their investigations to determine if police misconduct has occurred.
- There are 4 types of police misconduct that they investigate: Force, Abuse of Authority, Discourtesy, and Offensive Language.
- The CCRB also investigates whether or not the Right to Know Act has been violated.
 - Right to Know Act is a law passed in 2018 that outlines what officers should inform people of during interactions. Officers must:
 - Identify themselves by providing their name, rank, command and shield number.
 - Explain the purpose of the interaction.
 - Inform you of your right to say "no" when asking for your consent to search your person, property, vehicle, or home

- Offer a business card with the officer's information that explains how to comment or complain about an interaction with the NYPD. Civilians may request this business card in all interactions.
- Inform that everyone has the right to language access services

Ms. Righi explained that there are many ways to report police misconduct

- Call the hotline (800-341-2272) or 311
- Visit the office at 100 Church Street 10th Floor, New York, NY 10007
- File a complaint online at www.nyc.gov/ccrbcomplaint
- DM on social media via Facebook, Twitter, Instagram
- Mail a complaint to the office
- File a complaint at your local precinct

Who can file a complaint?

- Anyone can file a complaint, regardless of a person's immigration status; this is something a complainant or witness will never be asked about.
- A person can file complaints, regardless of whether they're incarcerated. They still can receive the same services, but the CCRB representative would meet them where they are.
- Youth can also file a complaint with the assistance of a parent or guardian.

When a complaint is received and confirmed to be within CCRB's jurisdiction, the following steps are taken:

- Interview the complainant
- Locate and interview witnesses
- Interview the officers involved (Police Officers must cooperate with the investigation and are required to give a sworn statement)
- Gather evidence (including video evidence, documents, and records)
- Present findings to a 3-member panel from the 15-member board
- This panel will review all evidence and make a final recommendation for disciplinary action or administrative prosecution
- The prosecutors are not civil or criminal. A person can also take civil or criminal action by consulting an attorney.

The Civilian Assistance Unit will speak to the complainant during the investigation and offer them mental health services, food assistance, health insurance options and other social services.

The Policy Department gathers data and develops data-driven solutions to policy challenges that impact the CCRB.

There is a database where you can find any existing member of service at the NYPD, whether they are currently active, retired, quit, or were fired. You can find all of their

information, their history past the year 2000, how many complaints they've had against them, what were the findings? What were the rulings? What was the disciplinary action that was taken?

As an outreach coordinator, Ms. Righi gives presentations to educational institutions, community organizations, organizations that provide services to the homeless, libraries, etc. If anyone would like to schedule one of these presentations, please contact jrose@ccrb.nyc.gov

ELECTED OFFICIALS' REPRESENTATIVES:

ASSEMBLY MEMBER ANDREW HEVESI

Michael Carlier announced the following:

- Assemblyman Hevesi will be sending out a district wide mailer outlining what was secured in this year's state budget.
 - Led the effort to secure \$7 billion to expand childcare eligibility in New York.
 - A family of four can now earn up to \$76,500 and have their childcare covered, where previously the same family could only earn up to \$53,000.
 - o This makes 400,000 more children eligible for childcare, and will save each family an average of \$23,000 per year. Anyone eligible for the subsidy can contact our office
 - \$224 million to strengthen the gun violence prevention efforts of law enforcement
 - o \$41 million for flooding-repair assistance from Hurricane Ida
 - o \$53 million for children's mental health programs
 - o \$20 million for the Asian American and Pacific Islander (AAPI) Equity Fund
 - Will increase public health resources, develop a K-12 AAPI curriculum, and fund AAPI organizations across New York
- Sunday 4/10, we partnered with Council Member Lynn Schulman and the 102nd Precinct & 112th Precinct Crime Prevention Unit to clear graffiti from the Austin St underpass underneath the Jackie Robinson Parkway

- This Saturday 4/9, we partnered with the Girl Scouts of America for a cleanup of Annadale Playground & PS 175
- On 3/27- we partnered with CB 6, Council Member Lynn Schulman, District Leader Mark Morrill, Forest Hills Asian Association, Color of Justice Forest Hills, Forest Hills Green Team, Women's Action Group of Forest Hills for a cleanup of MacDonald Park
- We'll be continuing our parks cleanup series over the season, where students can receive service credit for helping maintain our communities
- 4/23- Cleanup & composting event in Glendale
