## **Public Hearing**

**Tony's Way** - A street co-naming for Antonios Joannis Filakouris as to be located at Murray Street and Northern Boulevard, Flushing. This co-naming was requested by Martha Flores-Vazquez and Antonios' brother Nicolaos Filakouris. **Lawrence Hughes, Committee Chair.** 

**Nicolaos Filakouris** spoke about his brother Antonios who owned a car repair and gas station on this corner for over 50-years. Many times, customers came to his shop to have their cars repaired and Antonios would not charge them if they could not afford to pay.

Martha Flores-Vazquez explained that her car broke down while her children were with her. Since she could not afford to pay, Antonios did not charge for the repairs to her car. Antonios sponsored Three Kings Day and he bought toys for children who would otherwise not get any Christmas presents. He gave his time to the community by being active with his church. Antonios passed away in July 2024.

Lawrence Hughes: The Transportation Committee met and the vote was unanimous to approve.

**Kaitlyn Kilpatrick:** My father was a first responder who passed away due to cancer caused by working at the site of the 9/11 attacks. He also volunteered at local carnivals and helped many neighbors when they needed it. He and his family were very much involved whit their local church and its event.

**Lawrence Hughes:** The Transportation Committee met and the vote was unanimous to approve.

Chairman Chuck Apelian: Made the motion is to table the Vote on the budget.

### **Public Participation**

**Warren Schreiber**: Gave an update on the Charter Revision Proposal. Queens Civic congress has brought a lawsuit against the Charter Revision Commission because they feel this violated the law. This is a land use issue, not an election issue, and an environmental impact statement was not made.

**Eileen McDonald-Kujes**: I am a member of an organization for Public Service Retirees which represents NYC retired employees. We have been fighting to preserve Medicare for retirees. NYC wants to switch to a forprofit health care plan.

**George Stein**: The #7 Train Willets Point Station needs to be improved. He asked to have bike lanes painted from Union Street to Utopia Parkway.

**Maryanne McGovern**: Lives on 23rd Avenue, south of Clearview Golf course. The homes in this area used to be 2-stories and recently people have been adding more stories to their homes which have caused the neighboring homes to have no sunlight and causes flooding whenever it rains.

**George Hadjiconstantinou, Vice President, Strategic Programs Queens Chamber of Commerce:** We are working on starting new BID in College Point.

**Betsy Mak:** Update on the NST. We had 36 complaints from CB 7 Members. We were able to direct the complaints to the appropriate agencies. The only one complaint they refused to take care of is prostitution.

**Frank Quatela**: As an Architect, I appear before many Community Board throughout the City. I want to compliment our Community Board for having the best structure and the best leadership and for always asking the best questions of all Community Boards that I have visited.
