7) 135-01 35th AVENUE - PROJECT ID #P2015Q0168 - Proposed rezoning from M1-1 to R7A/C2-3 to allow the development of an eight (8) story 95 feet tall mixed use residential and commercial building at the premises with 72,442 sq. ft. of floor area, and a FAR of 4.60 (3.8 FAR residential and 0.8 FAR commercial). The proposed development will contain 76 dwelling units (22 of which would be affordable) within 59,883 sq. ft. of residential floor area, 12,609 sq. ft. of commercial retail on the first floor, and 6,720 sq. ft. on the cellar level. Sixty-eight parking spaces will be on the sub-cellar and cellar levels accessible by car elevator.
