### A Message from Our Elected Officials

Mabel Tso from the Office of Congresswoman Ocasio-Cortez provided some updates. This month, a Town Hall meeting was held in Pelham Bay and Congresswoman Ocasio Cortez shared some information on the new legislation package of bills entitled, "A Just Society". Two weeks ago, the office introduced the first piece of Green New Deal legislation, The Green New Deal for Public Housing Act. The legislation includes:

- o Improving the quality of life for public housing residents by upgrading and modernizing the housing stock.
- o Combatting climate change by reducing carbon emissions from all public housing to zero.
- Improving the economic stability of low-income, public housing residents, by ensuring up to 90% of the high-quality jobs created by the modernization project are going to public housing residents.
- o Training in long-term job skills.

In addition, the congresswoman's office recently joined the Quiet Skies Caucus to address noise pollution, environmental and health concerns as it relates to air traffic. The town hall meeting was streamed and can be viewed on Facebook.com/repAOC.

**ITEM #4a:** 141-54 Northern Blvd. – BSA Application No. 72-04-BZ. Pursuant to Sec. (11-411) of NYC Zoning Resolution, the applicant seeks to extend the term of a previously granted variance to authorize the existing use of the premise as an automotive service station (UG 16B) with accessory uses to expire on June 3, 2020. The premise is located within a R6 and R6/C1-2 zoning district. **John Choe, Committee Chair** introduced Elyse Foladare from the office of Eric Palatnik P.C., representative for the applicant, to present the application for board approval.

The premises has been under the Board's jurisdiction since February 9, 1960 and the term was last extended on September 25, 2012. The application does not seek any physical changes at the premises from the previous approval. The application seeks an extension of term of a special permit for a term of 10 years.

#### **Guest Presentation**

ITEM #5: New York Presbyterian Queens Hospital: Baby-Friendly-Representative Sandra Asanjarani, Perinatal Safety Officer/Baby-Friendly Chair.

Sandra Asanjarani discussed the importance and benefits of breastfeeding. She also updated the community on NY Presbyterian Queens Hospital Baby-Friendly designation. NYP Queens Hospital embarked in the prestigious designation Baby-Friendly USA, two years ago. Baby-Friendly is a global program launched in the 1990's due to a lack of safe practices in breastfeeding and formula feeding. NYP Queens Hospital is the second Baby-Friendly hospital in Queens. The goal is to provide mothers with information to safely breastfeed infants until six months of age, formula feed safely, and to promote mother and baby bonding. Benefits include: sensory and cognitive development, a decrease in SIDS-Sudden Infant Death Syndrome, obesity, diarrhea, ear and stomach infections and a quicker recovery in illness. Some benefits to the mother include: a decrease in the rate of breast cancer, ovarian cancer, type II diabetes and cardiovascular disease and a decrease in the rate of postpartum hemorrhage. Most recent, NYPQ hospital offers a free prenatal breastfeeding class which was piloted with **board member Michael Cheng**. Breastfeeding classes are offered in English, Spanish and Chinese. English classes are offered every second and fourth Saturday of the month. Sandra Asanjarani is asking the attendees of tonight's Public Hearing to help spread the importance of proper infant feeding practices. She requested the board to disseminate a Continuity of Care Survey on Breastfeeding to organizations that educate pregnant and postpartum women.

- Q. A Board Member asked, "How do you bring awareness to pediatricians and obstetricians?"
- A. Sandra Asanjarani responded, 3 hour courses are mandatory.

**Gene Kelty** added, the Continuity of Care Survey on Breastfeeding will be included in the Board's mailings in December and will be sent to civic organizations, schools and churches in the Board's district.
