# Announcement from Elected Officials:

Jessica Schabowski from the Mayor's office spoke of their goal to distribute the COVID vaccine to one million residents in January. Just last week 100,000 vaccines were administered. The Mayor toured a vaccine site in CB 7 and advocated expanding vaccinations from Group 1-A and Group 1-B, from essential workers to those 75 years and older. **Marcus Bettinger** from Congresswoman Ocasio-Cortez's office said Congress **1**) Certified the results of the 2020 election, despite the violence and threats to the members of the House while in session. **2**) Successfully removed the requirement tying new spending with spending cuts. Members can now propose Medicare for all and the Green New Deal. **3**) Second stimulus package, including the \$600, now extended to families of mixed immigration status, extension of conviction and eviction moratorium and expanded small business support.

# EXECUTIVE COMMITTEE ELECTIONS FOR 2021

The links for the ballot are locked. Chair Kelty will inform all members present when the ballot is unlocked for voting. Once the link is open you can vote by clicking on your name.

After each candidate's vote is tallied, we will announce the results and winner of the position. If a person cannot vote digitally, we will record a voice vote. If you make a mistake, just tell us so we can let you re-vote. Please call the Board office, if you have a serious issue.

**District Manager Marilyn McAndrews** read Articles #4 of the Community Board #7 By-Laws regarding elections for executive officers before proceeding on the voting process.

- 1. Officers of the Community Board shall be elected for one (I) year by open ballot at the first duly called meeting of the currently serving appointed members of the Board to be held in January of each year.
- 2. Candidates who receive the highest number of votes cast at that meeting for such office shall be deemed elected.
- 3. Nominations for positions as Officers of the Community Board shall be submitted to the District Manager, in writing, not later than thirty (30) days prior to the January meeting. the names of all such nominees so submitted shall appear on the ballot. The ballot shall also include blank spaces to provide for writing names of qualified nominees who may be nominated from the floor at the January meeting.
- 4. At the December meeting of the Board, the Chairperson shall report those qualified nominees received for each office.
- 5. Every member of the Board in attendance in person at the January meeting shall be entitled to cast one (I) vote for each Officer to be elected.
- 6. Nominations for every office may be made from the floor at the January meeting.

**Lei Zhao** – When I was nominated from the floor last January and elected to this position, I didn't anticipate we as a Board and as individuals would have to overcome the incredible challenges posed by the pandemic and events at large.
