## **Public Hearing**

## 1 – Voting on Capital & Expense Budget Submissions for FY 2025

## Frank Macchio read our Budget Requests.

We moved up a priority request for a new police precinct because the 109 Precinct is the largest in NYC. There is a greater need now for a new police precinct. Most of the other items are the same as last year.

**Arlene Fleishman:** The Linden Towers Co-Op did a \$1.5 million refurbishing because of flooding, 138th Street still does not have any storm sewers. This has been on the budget since 1984. **Frank Macchio:** The sewer project will be included in the 2024 budget.

Cody Herrmann: When was the request for a new precinct submitted?

**Chairman Kelty**: We have requested a new precinct since 1984. There was supposed to be a satellite unit in Bay Terrace and then a satellite in Flushing Meadows Corona Park. A special unit was in the park for a short while.

**Joseph Sweeney**: I am Chair of our Public Safety Committee. Most of the crime takes place Downtown, near Main Street. Since crime takes place Downtown, it takes longer for the police to get to Whitestone & College Point. There has been a massive increase in the number of people in Flushing, but the number of police in the precinct has decreased.

**Millicent O'Meally**: I asked for the reconstruction of the comfort station and the Parkhouse at the Flushing Memorial Park as well as the basketball court be placed on a higher priority at the committee meeting and my request has been lowered on the priorities.

Frank Macchio: All the requests were lowered since we raised the priority for the new Police Precinct.

**Chairman Kelty:** I am still trying to get answers from some City agencies. About the Meditation Garden at Kissena Corridor Park, Board Member **Harpreet Wahan** asked for lighting to be installed in the garden. We modified our budget request to include lighting for the exterior as well as the interior of the garden. We also included in our budget a new playground at Bay Terrance at Board member **Matt Silverstein's** request.

**Phil Konigsberg:** Does the Department of Environmental Protection (DEP) request include the sound detectors? **Chairman Kelty:** I don't know, but it does include expanding their noise complaint unit.

**Terence Park:** If the City is cutting budgets, why are we asking for more funding? **Frank Macchio:** If the agencies are requesting funding for a particular reason, the requests from the Community Boards provides support and more weight.

Frank Macchio: The motion is to approve Capital, Expense & Continuous Support budgets, seconded by Arlene Fleishman.
